Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Good Neighbor Employee Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2022 (in liquidation) and December 31, 2021 (ongoing), and the related statements of changes in net assets available for benefits for the period from January 1, 2022 to June 30, 2022 (in liquidation) and the year ended December 31, 2021 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of June 30, 2022 (liquidation basis) and December 31, 2021 (ongoing), and for the period January 1, 2022 to June 30, 2022 and the year ended December 31, 2021, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis-of-Matter – Basis of Accounting

As discussed in Note 1 to the financial statements, the Trustees and Plan administrator approved a resolution to terminate the Plan effective January 7, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the financial statements for the period January 1, 2022 to June 30, 2022. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Description of Plan:

The following description of the Good Neighbor Employee Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

On February 21, 2022, the Trustees and Plan administrator approved a resolution to terminate the Plan effective January 7, 2022. The Plan termination resulted in distributions to participants. All remaining assets of the Plan were distributed by June 30, 2022. Therefore, the Plan has changed its basis of accounting from the ongoing basis used in presenting the financial statements for the year ended December 31, 2021 to the liquidation basis used in presenting the financial statements for the period from January 1, 2022 to June 30, 2022.

During 2021, the Company was acquired, which resulted in the majority of the Company's employees, and the Plan's participants, terminated from the Plan. This resulted in a partial plan termination during 2021. Affected participants became fully vested in accrued benefits at their termination date.

Effective January 1, 2021, the Plan document was amended and restated.

General: The Plan was a defined contribution plan covering all eligible employees of Good Neighbor Holdings, LLC (the "Company"). The Plan included participants of Good Neighbors Homes, Inc., Good Neighbor Outpatient Services, Inc., Good Neighbor Day Treatment Services, Inc., Good Neighbor Intensive In-Home Services, Inc., and Good Neighbor Mental Health Services, Inc. Participants could enter the Plan on the first day of the Plan year quarter following the participant's date of hire. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective July 14, 2021, the Plan's sponsor, Good Neighbor Holdings, LLC entered into a purchase agreement, and was acquired by National Mentor Services, LLC. The transaction closed on August 31, 2021.

Contributions: The Plan provided for participant contributions up to 100% of pre-tax annual compensation, as defined in the Plan. Participants who will be 50 years of age by the end of the Plan year could make additional "catch-up" contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. All eligible employees were automatically enrolled in the Plan at a deferral rate of 2%, unless the employee elected to opt-out of the Plan or elected a different deferral rate. The Employer could make matching contributions equal to a discretionary percentage of a participant's elective deferrals, to be determined by the Company. The Company's matching contribution was 50% of the first 4% of the participant's contribution during the period January 1, 2022 to June 30, 2022 (liquidation basis) and the year ended December 31, 2021 (ongoing). The Company could contribute additional amounts at the option of the Board of Directors. Contributions were subject to certain limitations.

1. Description of Plan, Continued:

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses, and (c) charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Plan Trustees: Certain employees of the Company served as the trustees of the Plan. The trustees were not compensated by the Plan for services rendered.

Investment Options: Participants could direct Principal Life Insurance Company and Principal Trust Company, the custodians, as to the investment of their account balances in accordance with guidelines established by the Plan. Participants could change their investment elections at any time.

Vesting: Participants were immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contributions was based on years of continuous service. A participant was vested in the Company's contributions 20% after one year, 40% after two years, 60% after three years, 80% after four years, and 100% after five years of credited service.

The Plan was considered a partial plan termination during 2021. Thus, participants affected by the partial plan termination were immediately 100% vested in the Company's discretionary contributions, plus actual earnings thereon. Participants became 100% vested in the Company's contributions once management approved a resolution to terminate the Plan.

Notes Receivable from Participants: Participants could borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms could not exceed five years, unless the proceeds are used to acquire a principal residence. The loans were secured by the vested balance in the participant's account and bore interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest were paid ratably through payroll deductions. Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants deemed to be in default by the plan administrator, were reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits: Distribution of the vested portion of a participant's account occurred upon the participant's termination of service, retirement, death, or disability, as defined in the Plan. A participant was entitled to receive a lump-sum payment in an amount equal to the vested value of his or her account, or the participant could elect to receive the amount in installments as described in the Plan.

1. Description of Plan, Continued:

Plan Administration: Overall responsibility for administering the Plan rests with the Company. Participant accounts were administered by Retirement Plan Solutions, Inc., which served as the third-party administrator of the Plan. Principal Life Insurance Company and Principal Trust Company were the custodians of the Plan's assets.

Forfeitures: Forfeited balances of terminated participants' non-vested accounts was used to offset future Company contributions or to pay administrative expenses. Forfeiture additions were \$11,445 for the period from January 1, 2022 to June 30, 2022 (liquidation basis) and \$40,912 for the year ended December 31, 2021 (ongoing). Forfeited balances available were \$11,595 at December 31, 2021 (ongoing). For the period from January 1, 2022 to June 30, 2022 (liquidation basis) and the year ended December 31, 2021 (ongoing), \$22,720 and \$35,768, respectively, were used to pay administrative expenses. Forfeitures applied to reduce employer contributions from forfeited non-vested accounts were \$1,041 in the year ended December 31, 2021 (ongoing).

2. Summary of Significant Accounting Policies:

Basis of Accounting: For the period January 1, 2022 to June 30, 2022, the accompanying financial statements were prepared using the liquidation basis of accounting. For the year ended December 31, 2021, the Plan used the accrual method of accounting. In accordance with the liquidation basis of accounting, the Plan remeasures its assets and other items it expects to sell that it had not previously recognized, liabilities, and the accruals of disposal or other costs or income to reflect the actual or estimated change in carrying value since the previous reporting date. The liquidation basis of accounting was not materially difference from the accrual basis.

Group Annuity Investment Contracts: Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Investment Valuation and Income Recognition: Investments were reported at fair value (except for fully benefit-responsive investment contracts, which were reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits were recorded when paid.

2. Summary of Significant Accounting Policies, Continued:

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Subsequent Events: Management has evaluated subsequent events through March 10, 2023, the date the financial statements were available to be issued, and has determined that there are no subsequent events to be reported in the accompanying financial statements.

3. Fair Value Measurements:

The Financial Accounting Standards Board ("FASB") has issued guidance for measurement and disclosure of fair value and established a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Unit value calculated based on the NAV of the underlying pool of securities or investments. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. The Plan's pooled separate accounts are measured at NAV in accordance with FASB ASU 2015-07.

3. Fair Value Measurements, Continued:

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. **Group Annuity Investment Contracts with Insurance Company:**

The Plan invested in a group annuity contract with Principal Life Insurance Company totaling \$449 for 2021 (ongoing). Principal Life Insurance Company maintained the contributions in a Principal Life Insurance Company's general account. The account was credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not be less than 1.20 percent. The crediting rate is reviewed on a semiannual basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would also limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

5. **Administrative Expenses:**

The Plan's administrative expenses were paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. The Plan paid administrative fees in the amount of \$33,868 for the period January 1, 2022 to June 30, 2022 (liquidation basis), and \$114,520 for the year ended December 31, 2021 (ongoing).

6. **Related Party Transactions:**

The Plan invested in a number of investments sponsored by affiliates of custodians. These were related-party transactions.

The Plan paid certain administrative fees to its service providers, See Note 5. These fees were included in administrative and other expenses on the accompanying statements of changes in net assets available for benefits.

7. **Tax Status:**

The Internal Revenue Service has determined, by letter dated June 30, 2020, that the adopted prototype plan was designed in compliance with the applicable requirements of the Internal Revenue Code.

Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at June 30, 2022 (liquidation basis) and December 31, 2021 (ongoing). The Plan is not currently under audit by any tax jurisdiction.

8. **Financial Information Certified by Qualified Institutions:**

Principal Life Insurance Company and Principal Trust Company, the custodians of the Plan for the period January 1, 2022 to June 30, 2022 (liquidation basis) and the year ended December 31, 2021 (ongoing), have certified that the following information is complete and accurate:
