Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of NetMotion Software, Inc. 401(k), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 16, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period ended May 16, 2022, and the related notes to the financial statements.

NetMotion Software, Inc. 401(k) Plan Notes to Financial Statements

Note 1 – Description of Plan

The following description of the NetMotion Software, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

General – The Plan was a defined contribution and profit sharing plan established by NetMotion Software, Inc. The Plan covered substantially all employees of NetMotion Software, Inc., and was subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). NetMotion Software, Inc. (the Company), was the Plan’s sponsor and served as Plan administrator. The Company was acquired by Absolute Software Corporation effective July 1, 2021 and the Plan merged into the Absolute Software, Inc. 401(k) Plan (Absolute Plan) effective May 16, 2022.

Eligibility – All employees of the Company were eligible to participate in the Plan upon reaching age 18, except for employees covered by a collective bargaining agreement, leased employees, nonresident employees, temporary employees, statutory employees, and interns. However, employees in the temporary, statutory, and intern categories became eligible after they have reached the age of 21 and after completing one year of service in which at least 1,000 hours are worked. Employees had to complete at least 501 hours of service during the Plan year or be employed as of the last day of the Plan year to be eligible to receive any profit sharing contributions.

Contributions

Participant contributions – Each year, participants could contribute between 1-90% of pretax annual compensation, as defined in the Plan. Participants could also elect to make Roth contributions utilizing after-tax contributions. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant.

Employer match and profit sharing contributions – The Company could elect to make discretionary matching and profit sharing contributions to the Plan. During the Plan period ended May 16, 2022, the discretionary match was 50% of employee contributions, up to 6% of eligible compensation deferred to the Plan. Profit sharing contributions were allocated to participants in the same proportion as a participant’s compensation bore to the total of all participants’ compensation. There were no profit sharing contributions for the period ended May 16, 2022.

Contributions were subject to regulatory limitations.

Participant accounts – Each participant’s account was credited with the participant’s contributions and Company matching contributions as well as allocations of the Company’s profit sharing contributions and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account. Participants directed the investment of their contributions into various investment options offered by the Plan.

Vesting – Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts was based on years of continuous service. Participants vested in the Company’s contributions based on the following schedule:

Notes receivable from participants – Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were issued by the Plan and secured by the balance in the participant’s account. All loans had to be repaid within a period of five years, unless the loan was used to purchase a principal residence, in which case, the loan had to be repaid within a reasonable period of time not to exceed ten years. Under the terms of the Plan agreement, Plan loans bore a reasonable rate of interest determined by the Plan administrator. Principal and interest was paid ratably, at a minimum quarterly. As of May 16, 2022, all outstanding loans were transferred to the Absolute Plan.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant could elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service for other reasons, a participant could elect to receive the value of the vested interest in his or her account as a lump-sum distribution. Terminated participants with account balances between \$5,000 and \$1,001 were automatically distributed from the Plan and rolled over into an IRA. Terminated participants with account balances of \$1,000 or less were automatically distributed from the Plan as a cash payment. The Plan also allowed for in-service distributions after a participant reached age 59½ and hardship distributions subject to Plan provisions.

Forfeitures – Forfeitures were the nonvested portion of a participant’s account that were lost upon termination of employment. Forfeitures were retained in the Plan and could be used to reduce future Company contributions and to pay Plan administrative expenses. As of May 16, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$9,289, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

Use of estimates – The preparation of financial statements in accordance with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. The Plan's trustee, Fidelity Management Trust Company, certifies the fair value of all investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net depreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement.

Payment of benefits – Benefits are recorded when paid.

Expenses – General Plan administrative expenses may be paid out of the forfeiture account or paid by the Company. Investment management, distribution, and loan transaction fees are paid by the Plan participants.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through March 14, 2023, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There were no changes in the techniques used at May 16, 2022 or December 31, 2021.

Registered investment companies (mutual funds and money market funds): Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan were deemed to be actively traded. Mutual funds held by the Plan were open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

The valuation methods used by the Plan could produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Tax Status

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC).

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Information Certified by the Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statement of net assets available for benefits as of December 31, 2021.
- Net depreciation in fair value of investments, dividends and interest, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the period ended May 16, 2022.

Note 6 – Party-in-Interest Transactions

Certain Plan investments were shares of registered investment companies and a money market fund managed by Fidelity Investments. Fidelity Management Trust Company was the trustee of the Plan and an affiliate of Fidelity Investments and, therefore, transactions with these entities qualified as exempt party-in-interest transactions.
