Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements

We have performed an audit of the financial statements of R.P. Marzilli Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Responsibilities of Management for the 2022 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about R.P. Marzilli Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2022 Financial Statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 – Description of Plan

The following description of the R.P. Marzilli Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan was a defined contribution plan covering substantially all full-time employees of R.P. Marzilli & Co., Inc. (“the Company”), except excluded employees as defined by the Plan, who have at least reached the age of 21 and have reached 1,000 hours of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees oversees governance of the Plan.

Effective March 8, 2017, the Plan was amended so that terminated participants whose account balance was between \$1,000 and \$5,000 would be rolled over to an IRA established by an IRA provider selected by the Company, unless the participant made a distribution election.

Effective January 1, 2021, participants were eligible upon completion of 12 consecutive months from date of employment which participants must have completed 1,000 hours of service. If 1,000 hours of service were not met within 12 consecutive months of employment, participants were eligible and satisfied the service requirement if credited with a year of service.

On December 17, 2021, substantially all of the assets of the Plan’s sponsor, R.P. Marzilli & Co., Inc. were sold to Mariani Enterprises, LLC. The sale had no immediate effect on the Plan or its assets.

On April 29 2022, the Plan was terminated and all of the assets were distributed to participants.

Notes Receivable from Participants – Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant’s account and bear interest at rates as determined by the plan administrator based on the prevailing interest rates. Principal and interest were paid ratably through payroll deductions. Participants were allowed to have one outstanding note at any given time.

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred. No allowances for credit losses were recorded as of May 31, 2022. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

Employee Contributions – Contributions to the Plan were made by both the Company and participants. Participants could elect to defer up to 100% of their compensation, as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. Participants could also elect to make Roth deferrals. Participants who have attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan.

Employer Contributions – Continued – Effective January 1, 2021, the Company contributed a safe harbor matching contribution equal to 100% of a participant’s salary deferrals that did not exceed 3% of their compensation plus 50% of their salary deferrals between 3% and 5% of their compensation beginning January 1, 2021. The Company, at its discretion, could also make a discretionary contribution to the Plan. The Company made no discretionary contributions for the five months ended May 31, 2022.

Participant Accounts – Each participant’s account was credited with the participant’s contribution and allocations of (a) the Company’s contribution, if any, and, (b) Plan earnings or losses, and (c) charged with an allocation of any administrative expenses paid by the Plan. Allocations were based on eligible compensation. The benefit to which a participant was entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants were immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company’s contribution portion of their account was based on age or years of service. A participant was 100% vested upon attaining age 65, or after four years of credited service in their portion of the basic matching contribution in accordance with the following schedule:

Less than one year	0%
At least one year but less than two years	25%
At least two years but less than three years	50%
At least three years but less than four years	75%
Four years or more	100%

Payment of Benefits – Benefits under the Plan were distributed to participants upon retirement, death, disability, or termination, in a lump-sum amount equal to the value of the participant’s vested interest in his or her account or to receive a number of equal installment payments. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution.

The Plan allowed in-service withdrawals upon attainment of age 59 ½. A participant could also request hardship withdrawals from a participant’s elective deferral account. Participants must have exhausted all other options before financial hardship withdrawals were allowed. Deferral contributions were suspended for a six-month period after receiving a hardship withdrawal.

Forfeited Accounts – Forfeitures of the non-vested portion of withdrawing employees’ accounts were used to reduce future employer matching contributions and pay plan expenses. At May 31, 2022, there were no forfeited non-vested accounts.

Note 2 – Summary of Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America, requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the five months ended May 31, 2022.

Payment of Benefits – Benefits were recorded when paid.

Expenses – Certain expenses of maintaining the Plan were paid by the Company and therefore excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Recently Adopted Accounting Pronouncements – In May 2015, the FASB issued ASU 2015-07, Fair Value Measurement (Topic 820): Disclosures for Investments in Certain Entities that Calculate Net Asset Value per Share (or its equivalent) (ASU-2015-07). ASU 2015-07 removes the requirement to include investments in the fair value hierarchy for which fair value is measured using the net asset value (NAV) per share practical expedient under ASC 820. ASU 2015-07 is effective for fiscal year-ends beginning after December 15, 2016, with early adoption permitted. The amendment should be applied retrospectively to all periods presented. Management has elected to adopt this guidance and the Plan's disclosures in Note 4 are presented accordingly. Other than the changes to disclosures, the adoption of this standard did not have a material effect on the financial statements.

Subsequent Events – Subsequent events were evaluated through February 27, 2023, which is the date the financial statements were available to be issued.

Note 3 – Certified Investments

Reliance Trust Company certified certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at May 31, 2022, and net depreciation in fair value of investments, interest and dividend income, and interest income on participant notes receivable from participants for the five months ended May 31, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

Note 4 – Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability's fair value measurement value, within the fair value hierarchy, is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the quoted NAV of the shares held by the Plan at year-end and actively traded.

Common collective trust fund: Valued at the NAV per unit based on the underlying assets. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair values. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than that reported NAV.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the five months ended May 31, 2022, are reported in net depreciation in fair value of investments.

Note 5 – Related-Party Transactions and Party-In-Interest Transactions

Transactions with Reliance Trust Company, the trustee for the Plan, and ADP Retirement Services (ADP), the recordkeeper for the Plan, qualify as party-in-interest transactions.

ADP provided certain administrative services to the Plan pursuant to a service agreement between the Company and ADP Retirement Services. ADP received revenue from investment funds service providers for services ADP provides to the funds.

Note 5 – Related-Party Transactions and Party-In-Interest Transactions

The Plan made payments of \$5,929 to ADP for administrative expenses not covered by revenue sharing for the five months ended May 31, 2022. The Company pays, directly, any other fees related to the Plan's operations. During the five months ended May 31, 2022, the Company paid plan expenses, which are excluded from these financial statements.

Note 6 – Plan Termination

The Company had the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Plan was terminated on April 29, 2022. On April 29, 2022, participants became 100% vested in their employer contributions. As of April 29, 2022, all of the net assets have been distributed to participants.

Note 7 – Tax Status

The Plan is a prototype plan offered by Reliance Trust Company. The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated July 16, 2014, that the prototype plan and related trust is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefit.
