### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Advicent 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of May 31, 2022 and December 31, 2021, the related statements of changes in net assets available for benefits for the period ended May 31, 2022 and year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### NOTES TO FINANCIAL STATEMENTS

#### ( 1 ) Description of plan

The following description of the Advicent 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

**General** - The Plan was a defined contribution plan sponsored by Advicent Solutions, LP (the "Company") for the benefit of its employees who were age 20 or older. Collective bargaining employees, interns and employees hired for administrative special assignments were excluded from participation in the Plan. Employees were eligible for employer matching contributions upon meeting the eligibility requirements. Employees were eligible for employer nonelective contributions after a year of service in which a 1,000 hours were worked. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was administered by the Company's Advisory Committee ("Committee"), which was a committee made up of members of management of the Company. The Committee had overall responsibility for the operation and administration of the Plan. The Committee, along with the investment advisor, determined the appropriateness of the Plan's investment offerings and monitored investment performance.

**Plan restatement** - Effective July 26, 2021, the Plan was restated in accordance with the IRS Cycle 3 restatement window. The Internal Revenue Service ("IRS") determined that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC") and informed Great-West Trust Company, LLC, the trustee, of such in a letter dated June 30, 2020. The plan administrator adopted the pre-approved plan and believes that the Plan and related trust operated in compliance with the applicable requirements of the IRC.

**Plan merger** - Effective April 1, 2022, the Plan merged into the InvestCloud, Inc. 401(k) Plan (EIN 32-0412640, Plan #001) as discussed in Note 9.

**Contributions** - Each year, participants could contribute up to the maximum IRS allowed amount as pre-tax or Roth contributions, as defined in the Plan. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who made contributions to the Plan, were allowed to make catch-up contributions as defined in the Plan. Participants directed the investment of all contributions into various investment options offered by the Plan. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation. The Company may contribute a discretionary matching contribution to the Plan. For the period ended May 31, 2022 and year ended December 31, 2021, the Company contributed 50% of the first 6% of base compensation that a participant contributed to the Plan. Contributions are subject to certain IRC limitations.

**Participant investment account options** - The Plan offered various mutual funds, common collective trusts, and a guaranteed investment contract as investment options for participants. Each investment option had its own investment strategy, which could be obtained through the prospectus of the respective fund. Participants could change their investment options at any time.

#### ( 1 ) Description of plan (continued)

**Participant accounts** - Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contributions (if any) and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants were immediately vested in their contributions plus actual earnings thereon. Employer contributions were subject to the following vesting schedule:

**Notes receivable from participants** - Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bear interest at rates which were commensurate with local prevailing rates as determined by the plan administrator. Principal and interest were paid ratably through payroll deductions.

**Payment of benefits** - On termination of service due to death, disability or retirement, a participant could receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If the participant's vested benefit in the Plan did not exceed \$5,000, then the participant's benefit was distributed as soon as administratively feasible without the participant's consent. If the participant made no election, then their account balance was automatically rolled to an IRA. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump sum distribution or installments.

**Forfeited accounts** - At May 31, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$26,738, respectively. These accounts could be used to pay reasonable plan expenses or reduce future employer contributions. For the period ended May 31, 2022 and year ended December 31, 2021, employer contributions were reduced by \$31,496 and \$52,365, respectively, from forfeited nonvested accounts. For the period ended May 31, 2022 and year ended December 31, 2021, \$1,040 and \$14, respectively, of plan expenses were paid from forfeited nonvested accounts.

#### ( 2 ) Summary of significant accounting policies

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual method of accounting.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment trustee and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes receivable from participants** - Notes receivable from participants were measured at their unpaid principal balance plus accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses was recorded as of May 31, 2022 and December 31, 2021.

**Payment of benefits** - Benefits were recorded when paid.

**Administrative expenses** - Certain expenses of the Plan were paid by the Company and were not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation (depreciation) of fair value of investments.

#### ( 3 ) **Information prepared and certified by the custodian and trustee**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC, the custodian and trustee of the Plan, has certified that the following data included in the accompanying financial statements are complete and accurate with respect to investments:

- Investments at fair value
- Fully benefit-responsive investment contract at contract value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Interest
- Dividends
- Interest income on notes receivable from participants

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

#### ( 4 ) **Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### ( 4 ) Fair value measurements (continued)

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2022 and December 31, 2021.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that are registered with the Securities and Exchange Commission. These funds were required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

*Common collective trusts:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, was used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) could occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserved the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations would be carried out in an orderly business manner.

As of May 31, 2022, there were no investments held by the Plan as a result of the plan merger as discussed in Notes 1 and 9.

#### ( 5 ) **Fully benefit-responsive investment contract**

The Plan had a fully benefit-responsive guaranteed investment contract with Great-West Life & Annuity Insurance Company ("Great-West"). Great-West maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but could not be less than zero percent. The crediting interest rate was reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

#### ( 6 ) **Related party transactions and party-in-interest transactions**

Certain Plan investments were units of common collective trusts and a guaranteed investment contract managed by Great-West Trust Company, LLC or Great-West. Great-West Trust Company, LLC is the trustee and Great-West is a custodian for the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the custodian of \$22,674 and \$36,633 for the period ended May 31, 2022 and year ended December 31, 2021, respectively, which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

( 7 ) **Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

( 8 ) **Tax status**

The IRS determined that the pre-approved profit sharing plan was designed in accordance with applicable sections of the IRC and informed the trustee of such in a letter dated March 31, 2014. The plan administrator adopted the pre-approved and believes that the Plan operated in compliance with the applicable requirements of the IRC.

Effective July 26, 2021, the Plan was restated in accordance with the IRS Cycle 3 Restatement window. The IRS determined that the pre-approved plan was designed in accordance with applicable sections of the IRC and informed the trustee of such in a letter dated June 30, 2020. The plan administrator adopted the pre-approved plan and believes that the Plan and related trust operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

( 9 ) **Plan merger**

Effective April 1, 2022, the Plan merged into the InvestCloud, Inc. 401(k) Plan (EIN 32-0412640, Plan #001). The effective date of the plan merger was April 1, 2022, however the assets were not transferred out of the Plan until May 2022. As a result of the plan merger, assets of \$10,616,226 were transferred out of the Plan.

( 10 ) **Subsequent events**

The Plan has evaluated subsequent events through March 15, 2023, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
