Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Miramar Eye Specialists Medical Group, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation as of May 19, 2022 and March 31, 2022, and the related statement of changes in net assets in liquidation for the period April 1, 2022 to May 19, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of May 19, 2022 and March 31, 2022, and for the period April 1, 2022 to May 19, 2022, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

As disclosed in Notes 1 and 2 to the financial statements, on February 7, 2022, the Plan's sponsor adopted a resolution to terminate the Plan. The Plan was fully liquidated on May 19, 2022. In accordance with accounting principles generally accepted in the United States of America, the Plan adopted the liquidation basis of accounting as of and for the year ended March 31, 2022. Accordingly, the financial statements as of May 19, 2022 and March 31, 2022 and for the period April 1, 2022 to May 19, 2022 are presented on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

1. Description of the Plan

The following description of the Miramar Eye Specialists Medical Group, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Miramar Eye Specialists Medical Group, Inc. (the Company or Plan Sponsor) who have completed one year or 1,000 hours of service and are age 21 or older. Plan entry dates are semi-yearly. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's 401(k) Plan Administrative Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Plan Termination

Effective November 2, 2021, the Company was acquired by Laser Eye Care of CA (Laser Eye). In connection with the acquisition, the Plan was frozen to new participant contributions effective January 28, 2022. Former employees of the Company who became employees of Laser Eye became eligible to participate in the Nvision Eye Centers 401(k) Plan on January 28, 2022 and were allowed to rollover their investments into the Nvision Eye Centers 401(k) Plan (See Note 2). The following provisions of the Plan were based on the plan document prior to termination and liquidation. Effective May 19, 2022, the Plan was fully liquidated.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company contributes 25% of the first 4% of base compensation that a participant contributes to the Plan. In addition, the Company may contribute a profit sharing amount. During the period ended May 19, 2022, the Company did not make any profit-sharing contributions to the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. No contributions of any kind were made during the period ended May 19, 2022 as the plan was frozen.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contribution, as well as allocations of the Plan's earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Company's contributions plus actual earnings thereon.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest is paid ratably through bi-weekly payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may receive a lump-sum distribution equal to the value of the participant's vested interest in their account. In addition, the Plan allows for hardship distributions if certain criteria are met.

2. Summary of Significant Accounting Policies

Basis of Accounting

Effective February 7, 2022, the Plan Sponsor resolved to terminate the Plan, and the Plan was fully liquidated as of May 19, 2022. In accordance with accounting principles generally accepted in the United States of America (GAAP), the accompanying financial statements of the Plan are presented on the liquidation basis of accounting.

Under the liquidation basis of accounting, assets are stated at their estimated net realizable value and liabilities are stated at their anticipated settlement amounts. Further, under the liquidation basis, estimated costs to dispose of assets and costs expected to be incurred through the end of the liquidation process should be accrued. The following adjustments are reflected in the accompanying March 31, 2022 financial statements relating to the adoption of the liquidation basis:

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation

Under the liquidation basis of accounting, investments reported at net realizable value, which represents the estimated amount of cash or other consideration the Plan expects to be collect in settling or disposing of the investments in carrying out its plan for liquidation.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of May 19, 2022 and March 31, 2022.

Expenses

Under the liquidation basis of accounting, costs expected to be incurred through the end of the liquidation process should be accrued. As of March 31, 2022, the Plan accrued expenses totaling \$13,147 based on the remaining expense incurred during the period.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through March 15, 2023, the date the financial statements were available to be issued.

3. Fair Value and Net Realizable Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Based on the adoption of the liquidation basis of accounting, the estimated fair values of investments held by the Plan at March 31, 2022 were adjusted to present the investments at net realizable value (see Note 2). Following is a description of the valuation methodologies used to determine the fair value of the investments prior to this adjustment.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

4. Administration of Plan Assets

The Plan's assets are administered under a contract with Principal Life Insurance Company and Principal Trust Company, the custodians of the Plan. The custodians invest funds received from contributions, investment sales, interest and dividend income and makes distribution payments to participants.

5. Related-Party and Party in Interest Transactions

Certain of the Plan's investments are managed by the custodians, and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

6. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

Prior to the liquidation of assets in connection with the Plan termination, the Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. As of March 31, 2022, the value of the Plan's investments was reduced by \$447,391 to reflect the decrease in value between April 1, 2022 and May 19, 2022. As of May 19, 2022, all Plan assets were liquidated.

8. Information Certified by Custodians

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for the period ended May 19, and 2022. Accordingly, Principal Life Insurance Company and Principal Trust Company, the custodians of the Plan, have certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of May 19, 2022 and March 31, 2022, and the related investment activity reported in the Statement of Changes in Net Assets in Liquidation for the period April 1, 2022 to May 19, 2022.
