Because of the matter described in the Basis for Disclaimer of Opinion paragraph, however, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion.

Basis for Disclaimer of Opinion

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the Plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information summarized in Note 3, which was certified by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company, the Custodians of the Plan, except for comparing the information with the related information included in the financial statements. We have been informed by the Plan administrator that the Custodians held the Plan's investment assets and executed investment transactions. The Plan administrator has obtained a certification from the Custodians as of December 16, 2019 and for the period from January 1, 2019 through December 16, 2019, that the information provided to the Plan administrator by the Custodians is complete and accurate.

Disclaimer of Opinion

Because of the significance of the matter described in the Basis for Disclaimer of Opinion paragraph, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the 2019 financial statements. Accordingly, we do not express an opinion on the 2019 financial statements referred to in the first paragraph.

Other Matter – 2018 Financial Statement

The financial statement of the Plan as of December 31, 2018 was audited by predecessor auditors. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA), the Plan administrator instructed the predecessor auditors not to perform, and they did not perform, any auditing procedures with respect to the information certified by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company, the Custodians of the Plan. Their report, dated October 10, 2019, indicated that (a) because of the significance of the information that they did not audit, they were unable to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, they did not express an opinion on the financial statement and (b) the form and content of the information included in the financial statement other than that derived from the information certified by the Custodians, were presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Report on Form and Content in Compliance with DOL Rules and Regulations - 2019

The form and content of the information included in the 2019 financial statements, other than that derived from the information certified by the Custodians, have been audited by us in accordance with auditing standards generally accepted in the United States of America and, in our opinion, are presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

1. DESCRIPTION OF THE PLAN

The following description of the Rock Creek Publishing, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan was a defined contribution plan, which was established on January 1, 1998 by Rock Creek Publishing Group, Inc. (the Company). The Plan covered all eligible employees of the Company who had attained 18 years of age and performed at least three months of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator oversaw governance of the Plan, determined the appropriateness of the Plan's investment offerings, and monitored investment performance. The Plan was most recently amended on January 1, 2019 to merge the Plan into the ByteCubed LLC 401(k) Plan (the ByteCubed Plan) (Note 5).

Participant Contributions

Prior to January 1, 2019, participants could contribute up to 100% of their eligible annual compensation, as defined by the Plan, not to exceed the maximum allowable contribution limit under the Internal Revenue Code (the Code). Participants could also contribute post-tax Roth elective contributions. A participant's Roth elective contributions were allocated to a separate account maintained for such contributions. Roth elective contributions were treated as elective contributions for all purposes under the Plan. Participants who attained age 50 before the end of the Plan year could make additional catch-up contributions, subject to limitations imposed by the Code.

Participants were permitted to make rollover contributions to the Plan.

Company Contributions

Prior to January 1, 2019, the Company provided a safe harbor matching contribution to eligible participants on a per-payroll basis. Safe harbor matching contributions were equal to 100% of salary deferrals not to exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation.

Prior to January 1, 2019, the Plan allowed for the Company to make a discretionary contribution to the Plan each year. The amount was determined at the Company's discretion and allocated to Plan participants based on their relative share of total compensation. All employees who were an active participant on December 31 and had 1,000 or more hours of service in the Plan year were eligible to receive the discretionary match.

As all participants were transferred from the Plan to the ByteCubed Plan and became eligible to participate in the ByteCubed Plan effective January 1, 2019 (Note 5), the Company did not make any safe harbor matching or discretionary contributions for the period from January 1, 2019 through December 16, 2019.

Participant Accounts

Each participant's account was participant-directed and credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings and administrative expenses. Allocations were based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the vested portion of the participant's account.

Vesting

Participants were immediately vested in their contributions, Company safe harbor matching contributions, and Company discretionary contributions, plus actual earnings thereon.

Payment of Benefits

Upon termination of service due to death, disability, normal retirement age, or attainment of age 59½, a participant or his or her beneficiary, in the event of death, was entitled to a distribution of their vested account balance. Distributions from the Plan were payable in the form of a lump sum or installment payments equal to the value of the participant's vested interest in his or her account. Upon termination of service, participants with vested account balances of less than \$5,000 would receive a lump-sum distribution without participant consent. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed could be withdrawn for a hardship purpose. In all cases, certain income tax penalties applied to withdrawals or distributions prior to age 59½. Distributions were subject to the applicable provisions of the Plan agreement. As of December 16, 2019 and December 31, 2018, there were no net assets of the Plan allocated to participants who elected to withdraw from the Plan but had not received such distributions as of year-end.

Notes Receivable from Participants

Participants could borrow up to 50% of their vested account balance not to exceed \$50,000. The minimum note amount was \$1,000 and a participant could not hold more than one outstanding note at any given time. The notes were collateralized by the participant's vested account balance. The period of repayment could not exceed five years. All notes bore interest at rates comparable to those offered by financial institutions at the time of note origination, as determined by the Plan Sponsor. Principal and interest was paid ratably through payroll deductions.

Plan Expenses

Expenses incurred in the administration of the Plan were required to be paid by the Custodians with net assets of the Plan unless paid by the Company, at its discretion. A portion of the Plan's direct expenses were paid by the Company during the period from January 1, 2019 through December 16, 2019. Administrative expenses totaling \$749 were paid directly from the Plan for the period from January 1, 2019 through December 16, 2019. Loan and distribution fees were paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosure of contingent assets and liabilities and changes therein at the date of the financial statements and reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provided for investments in assets that, in general, were exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities could occur and materially affect the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

Accounting Standards Codification, *Fair Value Measurement* (ASC 820), defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interests in registered investment companies: Valued at the closing price reported on the active market on which the funds are traded.

Interests in pooled separate accounts: Valued at the net asset value (NAV) as a practical expedient of shares held by the Plan at year-end.

Interests in common collective trust: Valued at the net asset value (NAV) as a practical expedient of shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 16, 2019 and December 31, 2018.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Notes become due immediately upon termination of a participant's employment. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

Payment of Benefits

Benefit payments are recorded when paid.

Reclassifications

Certain amounts presented in the 2018 financial statements have been reclassified to conform to the 2019 presentation.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through February 7, 2023, the date the financial statements were available to be issued, and determined there were no material events that warrant disclosure except as disclosed in Note 7 related to the incomplete Form 5500 filing.

3. INVESTMENTS

All investment information contained in the accompany financial statements (excluding notes receivable from participants), including investments held as of December 16, 2019 and December 31, 2018, and interest and dividend income and net realized and unrealized appreciation in the fair value of investments for the period from January 1, 2019 through December 16, 2019, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Custodians of the Plan.

4. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by affiliates of the Custodians of the Plan. The Plan allowed for participants to take loans against their vested account balances. The Company provided the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualified as party-in-interest transactions, which are exempt from the prohibited transaction rules.

5. PLAN MERGER

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts. While not a Plan termination, as further described below, the Plan did merge into the ByteCubed Plan effective January 1, 2019.

Effective August 29, 2018, the Company was acquired by and became a wholly-owned subsidiary of ByteCubed LLC (ByteCubed). As a part of the acquisition, ByteCubed acquired and maintained the Plan.

5. PLAN MERGER – cont'd.

On January 1, 2019, the Plan merged with the ByteCubed Plan and all participants in the Plan were transferred to and became eligible for the ByteCubed Plan.

In conjunction with this merger, during January 2019, the balances of the notes receivable from participants totaling \$13,907 were transferred to the ByteCubed Plan. Additionally, investments totaling \$5,951,243 were transferred to the ByteCubed Plan. Certain investments of the Plan required a one-year notice prior to transfer of the entire investment offering. Investments totaling \$255,670 were subject to such restrictions and, accordingly, were not transferred until December 16, 2019.

6. INCOME TAX STATUS

The Plan was governed by a prototype plan sponsored by Principal Life Insurance Company. The prototype plan received an opinion letter dated March 31, 2014 from the Internal Revenue Service stating that the Plan and related trust are designed in accordance with the applicable sections of the Code. The Plan had been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been recorded in the accompanying financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan was tax exempt and had no unrelated business income, the provisions of ASC 740 did not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan did not have any amounts accrued relating to interest and penalties as of December 16, 2019 and December 31, 2018. The Plan was subject to routine audits by the IRS and Department of Labor (DOL); however, there are currently no audits in progress for any open periods.

7. OTHER MATTERS

The Form 5500 and associated financial statements for the period from January 1, 2019 through December 16, 2019 were initially due to the DOL by October 15, 2020. While the Company submitted the Form 5500 by this date, they were unable to complete an audit by this date and, accordingly, filed an incomplete Form 5500. By letter dated July 6, 2021, the DOL informed the Company that the Plan's Form 5500 had been rejected as an Accountants' Opinion and the associated audited financial statements and accompanying footnotes had not been attached to the Form 5500 submission. As this instance of noncompliance was not corrected in a timely manner, by letters dated January 5 and March 24, 2022, the DOL assessed a penalty of \$50,000 plus associated accrued interest and administrative costs. Effective July 13, 2022, the Department of Treasury, acting on behalf of the DOL, withheld \$52,014 from a scheduled payment in settlement of this penalty. The expense associated with this penalty was recognized by the Company as opposed to the Plan. Management has consulted with ERISA counsel and is taking appropriate actions to address this instance of noncompliance as soon as feasibly possible. Furthermore, Management has represented that future fines and penalties assessed by the DOL will be borne by the Company as opposed to the Plan or its participants.
