Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Livingston-Wyoming ARC 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 15, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 to February 15, 2022 and for the year ended December 31, 2021, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS FEBRUARY 15, 2022 AND DECEMBER 31, 2021

1. DESCRIPTION OF PLAN

The following description of the Livingston-Wyoming ARC 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the New York State Chapter for Retarded Children, Inc., Livingston-Wyoming Chapter (the Chapter). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Transfer

In July 2020, the Arc New York Board of Governors approved a resolution to create a single retirement plan for all NYSARC Chapters called The Arc New York Affiliated Employers 401(k) Plan (the Affiliated Plan). On October 1, 2021, the Plan Sponsor adopted an amendment to the Plan that merged the Plan into the Affiliated Plan. The plan merger date was February 15, 2022 and all assets of the Plan, totaling \$13,509,270, were transferred to the Affiliated Plan on February 15, 2022, which effectively terminated the plan.

The following is information about the Plan, prior to the merger date.

Eligibility

Employees of the Chapter who had one year of service with at least 1,000 hours and were twenty-one (21) or older were eligible to participate in the plan.

Contributions

Participants could make voluntary contributions subject to certain limitations under the terms of the Plan and the Internal Revenue Code (IRC). The Chapter matched employee contributions up to 5% of the participant's compensation. Participants directed the investment of all contributions into various options offered by the Plan.

Rollover Contributions

The Plan accepted direct rollover contributions from a qualified plan, as defined by the Plan.

Participant Accounts

Each participant's account was credited with the participant's contributions, the Chapter's contributions, an allocation of the Plan earnings/losses on all contributions and an allocation of administrative expenses. Allocations were based on participant earnings/losses or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their voluntary contributions plus actual earnings/losses thereon. Vesting in the Chapter's contributions plus earnings/losses thereon was based on a vesting table, and were 100% vested after completing 5 years of credited service.

1. DESCRIPTION OF PLAN (Continued)

Payment of Benefits

On termination of service due to death, retirement or other reasons, a participant or beneficiary could elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in a qualified joint and survivor annuity.

Hardship Withdrawals

Participants could receive distributions, up to 100% of their vested balance in the form of a hardship withdrawal upon meeting financial hardship requirements outlined in the Plan document.

Forfeitures

Forfeitures of non-vested account balances were used to reduce future Chapter contributions. Employer contributions were reduced by \$10,619 and \$1,401 as a result of forfeited non-vested accounts in 2022 and 2021, respectively. There were no forfeited non-vested balances available to be used to reduce future employer contributions at February 15, 2022 and December 31, 2021.

Plan Administration Costs

The Chapter paid certain administrative costs of the Plan and certain costs were passed through to participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States (GAAP).

Investment Valuation and Income Recognition

The Plan's investments in pooled separate accounts are stated at fair value. The guaranteed investment accounts are stated at the contract value less an early withdrawal charge and market adjustment, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation or depreciation in fair value of investments consists of both realized and unrealized gains or losses on those investments.

Risks and Uncertainties

The Plan's investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amount reported in the accompanying financial statements.

Fair Value of Financial Instruments

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly, are considered level 2 measurements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value of Financial Instruments (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with GAAP requires the management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. INVESTMENTS

Certified Investment Information

Principal Life Insurance Company (Principal), the custodian of the Plan, has certified as to the completeness and accuracy of information included in the financial statements and supplemental schedule as of February 15, 2022, and for the period from January 1, 2022 to February 15, 2022 and as of and for the year ended December 31, 2021 as follows:

Contract value was calculated as accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. Fair value is considered contract value adjusted to take into account the current rates of interest available in the market place as defined in the contract, utilizing a combination of the current interest rates based on remaining investment term at the reporting date as well as the interest rate on account.

Investment in Entities that Calculate Net Asset Value – Pooled Separate Accounts

The Plan invested in pooled separate accounts that calculate net asset value (NAV) on a daily basis. Units are issued and redeemed as of the end of each day at the daily NAV. The Plan's pooled separate accounts are invested in various types of investments. The investment strategies of these accounts are to invest in global and domestic equity and fixed income investments with the goal of producing favorable long-term returns primarily through appreciation of assets, dividends, and interest. There are no withdrawal restrictions on any of the pooled separate accounts, except for the U.S. Property Separate Account which allows for one transfer in a 30-day period. There are no unfunded commitments relating to these investments.

With the exception of the Principal U.S. Property Separate Account, investments are valued at fair value using the NAV per share practical expedient, which is based on quoted market prices of the underlying investments using a market approach. The underlying assets of the Principal U.S. Property Separate Account are valued at fair value using the NAV per share practical expedient, utilizing discounted cash flow valuation models that utilize real estate market data inputs such as transaction prices, market rents, vacancy absorption, market cap rates and discount rates. In addition, each property is appraised annually by an independent appraiser.

3. INVESTMENTS (Continued)

Fair Value Measurements (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. PLAN TERMINATION

The Organization had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan participants became 100% vested in their accounts.

5. TAX STATUS

The Plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan and related trust were, at that time, designed in accordance with applicable requirements of the Code. Although the Plan has been amended since receiving that determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of February 15, 2022 and December 31, 2021 and for the period from January 1, 2022 to February 15, 2022 and for the year ended December 31, 2021.

7. PARTY-IN-INTEREST TRANSACTIONS

Investments included guaranteed interest accounts and pooled separate accounts managed by Principal, who was the custodian as defined by the Plan, and the Chapter is the sponsor. As such, transactions between Principal, the Chapter, and the Plan qualify as party-in-interest transactions.

8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through February 27, 2023, which is the date the financial statements were available to be issued.
