## Independent Auditor's Report

To the Plan Administrator and Participants  
of the Mel Rapton Honda Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Mel Rapton Honda Profit Sharing Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of June 15, 2022 (Liquidation basis) and December 31, 2021 (Liquidation basis), and the related statement of changes in net assets available for benefits for the period January 1, 2022 to June 15, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 15, 2022 and December 31, 2021, and for the period January 1, 2022 to June 15, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment

information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly,



in all material respects, in accordance with accounting principles generally accepted in the United States of America. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter – Plan Termination**

As further discussed in Note 1, Mel Raption, Inc. dba Mel Raption Honda decided to terminate the Plan effective December 31, 2021 and all plan assets were distributed prior to June 15, 2022 in accordance with ERISA. Our opinion is not modified with respect to this matter.

### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Mel Raption Honda Profit Sharing Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan that was established on June 30, 1969 by Mel Raption, Inc. dba Mel Raption Honda ("the Company" or "Plan Administrator") covering all eligible employees of the Company as defined in the Plan agreement. Certain classes of employees as defined in the Plan agreement are excluded from plan participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Company was acquired by Group 1 Automotive, Inc. on October 19, 2021 and decided to terminate the Plan effective December 31, 2021. All plan assets were distributed prior to June 15, 2022 in accordance with the provisions of ERISA.

A Plan Committee ("the Committee") manages the operation and administration of the Plan, including the appropriateness of the Plan's investment offerings and investment performance. The Company has contracted with Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal") to act as custodian and record-keeper to process and maintain the records of participant data. Benefits Resources, Inc., a third-party administrator ("TPA"), provides certain plan services. Certain company personnel serve as plan trustees.

Effective January 1, 2022, the Plan was amended and restated for certain legislative and regulatory changes. Participants should refer to plan documents for any changes made to the Plan.

**Contributions** - In connection with the Plan termination, no participant contributions were made for the period January 1, 2022 to June 15, 2022. Prior to December 31, 2021, participants could contribute an amount of eligible pre-tax annual compensation as defined in the Plan agreement, not to exceed the maximum statutory amount. The Plan allowed for automatic enrollment for eligible employees as defined in plan documents with a deferral rate of 3% which was increased by 1% each year until it reached a maximum of 6% of eligible compensation, unless the employee elected differently. Participants who are age 50 or older could elect to make catch-up contributions to the Plan, not to exceed the maximum statutory amount. Participants could also contribute amounts representing distributions from other qualified eligible plans.

The Plan allows for an employer discretionary matching contribution and/or an employer discretionary profit sharing contribution subject to certain eligibility requirements; none were made for the period January 1, 2022 to June 15, 2022.

**Participant Accounts** - Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution (if any), an allocation of the discretionary profit sharing contribution (if any), plan earnings and losses, and plan expenses as applicable to the Plan. Allocations of the discretionary profit sharing contribution are based on years of service and participant compensation. Allocations of plan earnings and losses are based on individual participant investment choices. All contributions/investments are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - In connection with the termination of the Plan, all participants became 100% vested in their accounts.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with prevailing rates as determined by the Plan Administrator. There were no outstanding notes receivable from participant as of June 15, 2022. Outstanding notes receivable from participants as of December 31, 2021 carry interest rates which range from 5.25% to 7.00%. Principal and interest are paid ratably through payroll deductions. The notes must be repaid within a five-year period, unless it is used for the purchase of a principal residence in which case the maximum repayment period may be longer. The Plan Administrator establishes the specific terms and conditions of such notes.

**Payment of Benefits** - Upon the satisfaction of certain distributable events, participants or their beneficiaries may elect to receive their vested account balance and are paid in accordance with plan provisions.

**Forfeited Accounts** - Forfeited non-vested accounts can be used to pay plan expenses.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting. In connection with the Plan termination on December 31, 2021 and in accordance with accounting principles generally accepted in the United

States of America, the Plan's basis of accounting in presenting the 2022 and 2021 financial statements are in the liquidation basis.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value except for fully benefit-responsive investments which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by Principal. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 15, 2022 and December 31, 2021. Delinquent participant notes are recorded as distributions on the basis of the terms of the Plan agreement.

**Excess Contributions Payable** - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability. As of June 15, 2022 and December 31, 2021, there were no material excess contributions payable.

**Plan Expenses** - In 2022, some plan fees were paid by the Company and these amounts are excluded from the Plan's financial statements. Investment/fund fees, certain participant transaction fees, commissions, and third-party administrative fees are paid by the Plan and charged to participant accounts as applicable. Certain plan administration fees are paid through the forfeiture account.

**Payment of Benefits** - Benefits are recorded when paid.

**Subsequent Events** - The Plan has evaluated subsequent events through March 13, 2023, the date the financial statements were available to be issued.

### NOTE 3 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 4 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements, including investments held at June 15, 2022 and December 31, 2021, interest and net depreciation in fair value of investments for the period January 1, 2022 to June 15, 2022 was obtained by management and agreed to or derived from information certified as complete and accurate by Principal. Notes receivable from participants and the related interest income are not certified.

### NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs other than quoted prices include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 15, 2022 and December 31, 2021.

**Separate Accounts:** Units held in the separate accounts are valued at fair value based on the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The net asset value ("NAV") of the separate account is calculated based on a compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase, and redemption activity in the fund. The NAV is used as a practical expedient to estimate fair value for the funds. This practical expedient would not be used if it is determined to be probable that the funds will sell the investments for an amount different from the reported NAV. For the separate accounts there are no unfunded commitments, the units can be redeemed daily, and there is no redemption notice period.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021. There were no plan assets as of June 15, 2022.

### **NOTE 6 - FIXED INCOME FUND**

The Principal Fixed Income Guaranteed Option Fund is valued at contract value as reported by Principal. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investments. The Principal Fixed Income Guaranteed Option Fund is considered fully benefit-responsive. As of December 31, 2021, contract value equals fair value.

An employer-level liquidation or employer initiated transfer of the Plan's interest in the Fund could be subject to either a 12-month irrevocable advance notice or a 5% surrender charge, whichever the employer chooses. In connection with the Plan termination, no surrender charges were paid by the Plan.

### **NOTE 7 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Plan investments are held by Principal. Any purchases and sales of these investments are performed in the open market at fair value or contract value. Various plan related fees are paid by the Plan to Principal, to an investment broker and to a third-party administrator. The Plan has other service providers. All these transactions while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

### **NOTE 8 - TAX STATUS**

The Plan adopted a non-standardized pre-approved plan, which received an opinion letter dated June 30, 2020 from the IRS. The Plan has been amended since, however, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
