## **INDEPENDENT AUDITORS' REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Briggs & Veselka Co. 401(k) Retirement Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) [“ERISA Section 103(a)(3)(C) audit”]. The financial statements comprise the statements of net assets available for benefits (in liquidation) as of August 30, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits (in liquidation) for the period January 1, 2022 through August 30, 2022, and the related notes to the financial statements (“Financial Statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of August 30, 2022 and December 31, 2021, and for the period January 1, 2022 through August 30, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion on the Financial Statements**

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the Financial Statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the Financial Statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ## **Emphasis of Matter – Plan Termination and Basis of Accounting**

As discussed in Note 10 to the financial statements, effective December 30, 2021, the Plan was terminated. As a result, the Plan has presented the accompanying financial statements under the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the Financial Statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors’ Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

### **NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Briggs & Veselka Co. 401(k) Retirement Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan was a qualified defined contribution plan covering employees of Briggs & Veselka Co., LLP, B&V Capital Advisors, LLC, and B&V Pathway Forensics, LLC (collectively, "the Company"). The Plan covered all full-time employees who had reached 20 years of age, subject to entry dates on the first day of each month. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective December 30, 2021, the Plan was terminated (see Note 10).

#### **Contributions**

Participants could contribute up to 90% of compensation, up to the maximum dollar amount allowable by the Internal Revenue Service, as defined in the Plan. Participants could also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered investment choices through Empower Annuity Insurance Company of America and Empower Trust Company, LLC (formerly known as Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC), the custodians of the Plan's investments, which included a common collective trust fund, mutual funds through various registered investment companies, a group annuity contract, and participant-directed brokerage accounts. The Plan allowed for discretionary employer matching and profit-sharing contributions for all eligible employees who had at least 6 months of service and were employed on the last day of the Plan year. The Company made no discretionary matching or profit-sharing contributions for the period January 1, 2022 through August 30, 2022.

#### **Participant Accounts**

Each participant's account was credited with the participant's contributions, qualified rollover contributions, and allocations of the Company's contributions (if any), and Plan earnings, and charged with an allocation of administrative expenses. Allocations were based upon participant earnings or account balances, as defined by the Plan. Forfeited balances of terminated participants' nonvested accounts were used to pay Plan expenses or reduce amounts otherwise required to be contributed to the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

#### **Notes Receivable from Participants**

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan terms ranged from 1 to 5 years, or the administrator could permit a longer repayment term for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bore interest ranging from 5.25% to 7.50%. Principal and interest were paid ratably through regular payroll deductions.

#### **Vesting**

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in discretionary matching or profit-sharing contributions allocated to individual participants, plus actual earnings thereon, were based upon years of continual service as defined in the Plan. A participant was 100% vested after six years of service. Due to the plan termination effective December 30, 2021, all participants became 100% vested in all contributions (Note 10).

#### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may have elected to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, hardship withdrawals and in-service distributions at age 59 ½ were permitted if certain criteria were met.

#### **Forfeited Accounts**

At December 31, 2021, unallocated plan assets resulting from forfeited nonvested accounts totaled \$48,439. There were no forfeited accounts at August 30, 2022. Forfeited accounts were permitted to be used to reduce administrative expenses and discretionary employer contributions.

### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

Given the Plan's termination (Note 10), the financial statements of the Plan have been prepared under the liquidation basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles in the United States required the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may have differed from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments were stated at fair value, which was deemed to approximate the amount that the Plan expected for settlement in carrying out its plan for liquidation. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds were deducted from income earned on a daily basis and not separately stated. Consequently, management fees and operating expenses were reflected as a reduction of any investment return on such investments.

**Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest, which was deemed to approximate the amount that the Plan expected for settlement in carrying out its plan for liquidation. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for loan losses had been recorded as of August 30, 2022 and December 31, 2021. If a participant ceased to make loan repayments and the plan administrator deemed the note receivable to be in default, the participant loan balance was reduced; and a benefit payment was recorded.

**Payment of Benefits**

Benefits were recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan were paid directly by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration and processing of benefit payments were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net depreciation of fair value of investments. The Plan made direct payments for administration fees of \$73,166 for the period January 1, 2022 through August 30, 2022.

**Subsequent Events**

Management has evaluated subsequent events through February 20, 2023, the date on which the financial statements were available to be issued. There were no subsequent events requiring recognition or disclosure in these financial statements.

The custodians also certified the completeness and accuracy of \$2,940,847 of net depreciation in the fair value of investments, \$13,416 of dividends and interest, and \$4,262 of interest income on notes receivables from participants, related the aforementioned assets for the period January 1, 2022 through August 30, 2022.

### **NOTE 4 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures* (“FASB ASC 820”), provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include the following:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observed for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at August 30, 2022 and December 31, 2021.

Following is a description of the valuation methodologies used for assets measured at fair value. As discussed in Note 10, the Plan did not have any assets at August 30, 2022.

*Common/collective trusts:* Units are valued using the net asset value (“NAV”) practical expedient of the common/collective trust (“CCT”) as reported by the CCT manager, Empower Trust Company, LLC. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The CCT invests entirely in the MetLife Group Annuity Contract, which consists of separately managed investment portfolios in fixed income securities, and also enters into wrapper contracts, which are issued by third parties and are designed to allow the fund to maintain a constant NAV.

**NOTE 4 – FAIR VALUE MEASUREMENTS (continued)**

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Participant-directed brokerage accounts:* Accounts primarily consist of mutual funds, common stocks, corporate debt instruments, exchange-traded funds, certificates of deposit, and government agency securities that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain of the Plan’s investments were managed by Empower Retirement, LLC, which is affiliated with Empower Annuity Insurance Company of America and Empower Trust Company, LLC (formerly known as Great-West Trust & Annuity Insurance Company and Great-West Trust Company, LLC), the custodians of the Plan; and therefore, these transactions qualified as party-in-interest transactions under ERISA. Fees paid by the Plan for investment management services were included as a reduction of any return earned on each investment.

As described in Note 2, the Company may have paid certain administrative expenses relating to Plan operations to various service providers. In addition, employees of the Company provided administrative services to the Plan for which no fees are charged. These transactions were party-in-interest transactions under ERISA.

Notes receivable from participants also qualified as party-in-interest transactions under ERISA.

**NOTE 6 – TAX STATUS**

On June 30, 2020, the Internal Revenue Service stated that the preapproved individual volume submitted plan adopted by the Plan, as then designed, qualified under Section 401(a) of the Internal Revenue Code (“IRC”). Although, the Plan had not received a determination letter specific to the Plan itself; the plan administrator and the Plan’s tax counsel believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believed that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America required plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. No assets or liabilities relative to uncertain tax positions were recorded as of August 30, 2022 and December 31, 2021. The Plan was subject to routine audits by taxing jurisdictions; however, as of August 30, 2022, there were no audits for any tax periods in progress.

### **NOTE 7 – RISKS AND UNCERTANTIES**

The Plan invested in various investment securities. Investment securities were exposed to a range of risks such as interest rate risk, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits (in liquidation).

### **NOTE 8 – PLAN AMENDMENT AND RESTATEMENT**

Effective August 1, 2021, the Plan was amended and restated under a Cycle 3 Restatement to bring the Plan into compliance with legislative and regulatory changes set forth in IRS Notice 2017-37. Significant provisions of the amended plan document are consistent with those of the current plan document. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

### **NOTE 9 – PROHIBITED TRANSACTIONS**

During the 2021 plan year, the plan sponsor failed to deposit certain participant contributions within the required timeframe as stipulated by the U.S. Department of Labor ("DOL"). The DOL considers late deposits to be prohibited transactions as disclosed in the accompanying supplementary information. Employee contributions have been remitted to the Plan. The lost earnings are in the process of being corrected.

### **NOTE 10 – PLAN TERMINATION**

Effective December 30, 2021, the Plan was formally amended and terminated. The participants became 100% vested in their accounts upon termination. Final distributions to participants were completed prior to August 30, 2022.
