Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Allied Wire & Cable, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation available for benefits as of June 16, 2022 and December 31, 2021, and the related statement of changes in net assets in liquidation available for benefits for the period January 1, 2022 to June 16, 2022, and the related notes to the financial statements.

Notes to Financial Statements

June 16, 2022 and December 31, 2021

(1) Description of Plan

The following description of the Allied Wire & Cable, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established for the benefit of the employees of Allied Wire & Cable, Inc. (the Company). The Plan was intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The board of directors was responsible for oversight of the Plan. Management determined the appropriateness of the Plan's investment offerings, monitored investment performance and reported to the board of directors.

Plan Termination

On November 1, 2021, the Company completed a merger with Genuine Cable Group, LLC (GCG). Per the terms of the merger agreement, the Company's Board of Directors adopted a resolution effective October 31, 2021 to terminate the Plan (the Plan Termination), making liquidation of the Plan imminent. In January 2022, the Company formally began the liquidation process with the Plan's trustee.

Effective with the Plan's termination, the Plan no longer accepted participant employee deferrals and all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of the status or years of vested service. The Plan's termination also ceased employer contributions into the Plan and ceased new participant notes receivable from the Plan.

In connection with the Plan Termination the remaining assets of the Plan were liquidated effective June 16, 2022 and \$162,791 of participant notes receivable were transferred to the Genuine Cable Group 401(k) Plan.

Eligibility

Prior to the Plan Termination, upon completion of one hour of service, all employees of the Company, except leased employees, students, summer interns, and seasonal employees, were eligible to participate in the Plan on the first day of the calendar month coincident with or following satisfaction of the eligibility requirements as defined by the plan document. Employees were eligible for the Company matching contribution once they had completed one year of service, as defined in the Plan. The employees must have completed one year of service to be eligible for participation in the profit sharing and safe harbor contributions and were able to enter into the Plan on the first day of the first and seventh months of the calendar year following eligibility.

(1) Description of Plan, Continued

Participant Accounts

Each participant's account was credited with their contributions, the Company matching, profit sharing and safe harbor contributions, and allocations of the plan earnings. Participant accounts may have been charged with an allocation of certain administrative expenses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Prior to the Plan Termination, participants were immediately vested in their contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in the Company's profit sharing and matching contributions was based on years of continuous service. A participant became fully vested upon the completion of six years of credited service, with Company contributions first being vested after two years of credited service. A credited year of service was defined by the Plan as any calendar year in which an employee completed a minimum of one thousand hours of compensated service with the Company. All participants with balances at the time of the Plan Termination immediately became fully vested in their balances from all sources.

Notes Receivable from Participants

Prior to the Plan Termination, participants were able to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans were secured by the balance in the participants' accounts and bore interest at rates that range from 4.25% to 6.5%, which were commensurate with local prevailing rates as determined by the plan administrator. Principal and interest were paid ratably through biweekly payroll deductions. Loans ranged from one to five years, unless the loan was acquired for the purchase of the participant's primary residence.

Payment of Benefits

Prior to the Plan Termination, upon termination of service due to death, disability or retirement, a participant may have elected to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account or an alternative form of payment, as defined in the Plan. For termination of service due to other reasons, a participant may have received the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

There were no forfeited nonvested accounts at June 16, 2022. Forfeited nonvested accounts totaled \$16,095 as of December 31, 2021. During the period January 1, 2022 to June 16, 2022, the Plan used forfeited nonvested amounts of \$15,477 to offset administrative expenses of the Plan.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared on the liquidation basis of accounting.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determined the Plan's valuation policies utilizing information provided by the investment advisers, trustee and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Plan fees and expenses were paid by the Company or charged against the assets of the Plan. Fees paid by the Company were excluded from these financial statements. Fees related to certain participant transactions and for the administration of notes receivable from participants were charged directly to the participants' accounts and were included in administrative expenses. Investment related expenses were included in net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through February 24, 2023, the date the financial statements were available to be issued.

(3) Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at June 16, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest income on notes receivable from participants, and dividends and interest income for the period January 1, 2022 through June 16, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, as agent for Ascensus Trust Company, a qualified institution.

(4) Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

Registered investment companies: Valued at the daily closing price as reported by the registered investment companies. Registered investment companies held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common collective trust: Value at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

There were no significant transfers among investment levels during the period January 1, 2022 to June 16, 2022 and the year ended December 31, 2021.

(5) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments were shares of registered investment companies managed by The Vanguard Group, Inc. (Vanguard). The Plan entered into a recordkeeping and administrative service agreement with Vanguard effective August 1, 2013. Therefore, these transactions qualified as party-in-interest transactions which were exempt from prohibited transaction rules.

The terms of the recordkeeping and administrative services agreement with Vanguard allowed Vanguard to contract those services from another service provider for the Plan. Vanguard entered into an agreement with Ascensus, Inc. coincident with entering into the recordkeeping and services agreement.

Ascensus, Inc. provided administrative services to the Plan. Ascensus Trust Company, an affiliate of Ascensus, Inc., was also the trustee as defined by the Plan and, therefore, these transactions qualified as party-in-interest transactions, which were exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services were included in net depreciation in fair value of the investment. The plan sponsor paid directly any other fees related to the Plan's operations.

(6) Tax Status

The Plan adopted a non-standard form of a prototype plan sponsored by CCH Incorporated, DBA ftwilliam.com (CCH). The prototype plan received a letter from the IRS dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter had been relied upon by this Plan. The plan administrator believed that the Plan was designed and was operated and terminated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
