## **INDEPENDENT AUDITOR'S REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Carbon Five, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of August 27, 2022 and December 31, 2021 (in liquidation), and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to August 27, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Carbon Five, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 27, 2022 and December 31, 2021, and for the period from January 1, 2022 to August 27, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

## **Emphasis of Matter—Basis of Accounting**

As discussed in Note 1 to the financial statements, the Board of Directors of Carbon Five, Inc. 401(k) Plan approved the termination of the Plan on February 8, 2022. The Plan was frozen as of February 28, 2022. As a result, the Plan reports its basis of accounting under the liquidation basis. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Carbon Five, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE 1: DESCRIPTION OF PLAN**

The following description of the Carbon Five, Inc. 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was established on January 1, 2001 by Carbon Five, Inc. ("the Company") covering all eligible employees of the Company as defined in the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On February 8, 2022, the Board of Directors of Carbon Five, Inc. adopted a resolution to terminate the Plan, effective February 28, 2022. As of August 27, 2022, all assets of the Plan have been fully distributed.

Eligibility

All employees of the Company upon completing six months of service were eligible to contribute salary deferrals to the Plan, as well as receive Company Safe-Harbor matching contributions, and other discretionary Company contributions.

Participant Contributions

Participants were able to contribute, through pre-tax deferral of compensation, an amount up to the maximum allowed by the IRS. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants were able to contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants were also able to make after-tax Roth contributions to the Plan.

Employer Contributions

The Company could contribute a discretionary Safe-Harbor matching contribution each year. For the period from January 1, 2022 to February 28, 2022 (date the Plan was frozen), the Company contributed a Safe-Harbor matching contribution of 3.0% of a participant's eligible salary. The Company could also make discretionary profit sharing contributions. For the period from January 1, 2022 to February 28, 2022 (date the Plan was frozen), there were no profit sharing contributions.

Participant Accounts

Each participant's account was credited with the participant's contributions and an allocation of (a) the Company's contribution, (b) Plan earnings, and (c) charged with an allocation of benefit payments and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Account Options

Participants directed the investment of their contributions into various investment options offered by the Plan. Each participant had the option of directing contributions into any of the investment account options selected by the Company and could change the allocation to the extent permitted by the individual agreements.

Vesting

Participants were immediately vested in their voluntary contributions and contributions representing rollovers from other qualified plans, plus earnings thereon. Participants were also always 100% vested in any Company Safe-Harbor matching contributions and other Company discretionary contributions.

**NOTE 1: DESCRIPTION OF PLAN (CONTINUED)**

Notes Receivable from Participants

Participants could borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest. A participant could have one outstanding loan at any given time. Note terms for newly disbursed loans ranged from one to five years or up to thirty years if used to purchase the primary residence of the participant. The notes were secured by the balance in the participant's account and bore interest at a rate of Prime plus 2.0%. Principal and interest was paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement or any other reason, a participant was entitled to receive a distribution equal to the value of the participant's vested interest in his or her account as a lump-sum distribution of the account balance. If a terminated participant had an account balance of less than \$5,000 and did not request the account balance be rolled into another qualifying plan, the Plan would automatically have their account balance rolled into an Individual Retirement Account established for the benefit of the participant. Terminated participants with account balances greater than \$5,000 could elect to leave their account in the Plan or roll their account balance into another qualified plan. Participants could also receive in-service distributions on account of hardship or after reaching normal retirement age (age 59 1/2). As of August 27, 2022 and December 31, 2021 there were no benefits payable to participants that have elected to withdraw from the Plan but have not yet been paid.

Administrative Expenses

The Plan's expenses were paid either by the Plan or the Plan Sponsor, as provided by the Plan document. Expenses that were paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Forfeitures

Participants are always 100% vested in all employer contributions. The Plan does not have any forfeitures.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

Effective February 28, 2022, the Board of Directors of the Company voted to terminate the Plan. As a result, the Plan's financial statements as of August 27, 2022 and December 31, 2021, and for the period from January 1, 2022 to August 27, 2022 have been prepared on the liquidation basis, in accordance with U.S. GAAP. This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimate net realized cash value and liabilities are stated at their anticipated settlement amounts. The estimated net realizable cash value for investments as of August 27, 2022 and December 31, 2021 would be fair value.

**NOTE 2: SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

Investment Valuation and Income Recognition

The Plan's investments, except for investments fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. See Note 4 for discussion of fair value measurements and a description of the method(s) and significant assumptions used to determine the fair value of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on ex-dividend dates. Net appreciation (depreciation) includes Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the plan document.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through March 7, 2023, the date on which the financial statements were available to be issued.

**NOTE 3: INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has an investment in a fully benefit-responsive Group Annuity contract with Principal Life Insurance Company (Principal: Issuer). Under the terms of the contract, the contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The value of the investment as of August 27, 2022 and December 31, 2021 is presented below:

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. In the event that the Plan Sponsor terminates the contract and requests an immediate payout, the contract payout would be subject to a 5% termination fee. The plan administrator does not believe that the occurrence of any other such contract value events, which would limit the Plan's ability to transact at contract value with participants, is probable. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The crediting interest rate of the contract is based on a formula agreed upon with the issuer, as defined in the contract agreement, but cannot be less than zero. Such interest rates are reviewed and reset on semi-annual basis. The key factors that influence future interest crediting rates could include the following: the level of market interest rates; the amount and timing of participant contributions, transfers and withdrawals into/out of the contracts; and the duration of the underlying investments backing the contract.

**NOTE 4: FAIR VALUE MEASUREMENTS**

*FASB Accounting Standards Codification 820, Fair Value Measurements and Disclosures*, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described below:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 27, 2022 and December 31, 2021.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded, resulting in a Level 1 valuation.

*Pooled separate account (PSA):* Valued at Unit Value per share that is based on the net asset values of the underlying investments after the deduction of applicable investment management, fund administration, and financial accounting charges. The Unit Value is not a publicly-quoted price in an active market. The pooled separate accounts are comprised of a wide variety of underlying investments such as domestic and international equities, bonds, real estate, and mutual funds.

*Collective trusts:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5: UNAUDITED INFORMATION - CERTIFIED INVESTMENTS**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Substantially all information pertaining to the Plan's investments and notes receivable from participants included in the August 27, 2022 and December 31, 2021 financial statements, including the associated investment income and interest income from notes receivable from participants, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal Life Insurance Company, and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. This information has not been audited by independent accountants.

**NOTE 6: TAX STATUS**

On March 31, 2014, the Internal Revenue Service issued a favorable determination letter on the documents adopted by the Plan, noting that the plan qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan's administrator believes that the Plan's design and operations continue to comply with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 7: TRANSACTIONS WITH PARTIES-IN-INTEREST**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns fifty percent or more of such an employer. Substantially all administrative expenses of the Plan are paid by the Plan Sponsor. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. The Plan holds collective trust investments and an insurance contract investment issued by affiliates of the trustee. Transactions with these investments reflect parties-in-interest transactions. Notes receivable from participants are also party-in-interest transactions.

**NOTE 8: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
