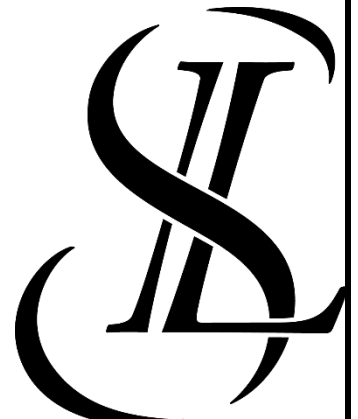

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Horne Bros. Construction, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of May 31, 2022 (in liquidation) and December 31, 2021 (in liquidation), and the related statement of changes in net assets available for benefits for the period ended May 31, 2022 (in liquidation), and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of May 31, 2022 and December 31, 2021, and for the period ended May 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the certified investment information in the accompanying financial statements agrees to or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Description of Plan

The following description of the Horne Bros. Construction, Inc. (the “Company” or “Employer”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

In May 2021, Pine Gate Renewables completed the acquisition of Horne Bros. Construction, Inc., which resulted in the newly formed entity Blue Ridge Power. During April 2022, the Plan was terminated and merged into the Pine Gate Renewables 401(k) Plan resulting in transfers of approximately \$10,992,000. Also see Notes 2 and 6.

General

The Plan is a defined contribution plan available to eligible employees of the Company. To be eligible to participate in the Plan, an employee must have attained the age of 18 and completed one year of service with more than 1,000 hours. Employees may begin participation as of January 1 or July 1 of the year in which they meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Eligible employees are automatically enrolled to defer 3% of pre-tax compensation unless an alternative election is made or participation is declined. Participants may otherwise elect to contribute a percentage of their pre-tax or after-tax annual compensation, as defined in the Plan, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Company makes a safe harbor matching contribution equal to 100% of the first 3% of each participant’s compensation plus 50% of the next 2% contributed to the Plan. The Company may also make a discretionary profit sharing contribution to be determined annually by the Board of Directors. There was no discretionary profit sharing contribution for 2022. Participants must complete 1,000 hours of service and be employed on the last day of the year in order to receive Company profit-sharing contributions.

Upon enrollment in the Plan, a participant may direct participant and Company contributions in any of the investment options offered through the Plan. Participants may change their deferral percentages and investment options at any time.

Participant Accounts

Each participant’s account is credited with the participant’s and the Company’s contributions and an allocation of the Plan’s net earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions and the Company's safe harbor matching contributions, plus any income or loss thereon. Vesting in the Company's discretionary profit sharing contributions, plus any income or loss thereon, is based on years of continuous service according to the following schedule:

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, a participant may elect to receive a lump-sum payment or installment payments. In-service distributions may be made to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

Forfeitures

Forfeitures from non-vested participant accounts may be used to offset plan expenses or future Company contributions. There were no forfeitures utilized during 2022.

Notes Receivable from Participants

Plan participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Loan terms generally range from one to five years. The loans are collateralized by the balance in the participants' accounts and bear interest at the prime rate plus 2%, as of the loan origination date. Participants may have up to two outstanding loans at any time. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Distribution and loan fees are paid from affected participant accounts. Other fees, including trustee, recordkeeping, and asset fees, may be paid by the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on a liquidation basis, in accordance with accounting principles generally accepted in the United States of America ("GAAP"). This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts. As a result of the Plan merger effective April 2022, the Plan's financial statements as of May 31, 2022 and December 31, 2021, and for the period ended May 31, 2022, have been prepared on the liquidation basis and in accordance with GAAP.

2. Summary of Significant Accounting Policies (Concluded)

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of May 31, 2022 and December 31, 2021. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated events occurring subsequent to the date of the financial statements through March 16, 2023, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at May 31, 2022 and December 31, 2021, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period ended May 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Alerus Financial, N.A. ("Alerus").

4. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

5. Income Tax Status

The Plan has adopted a non-standardized plan document utilized by Spectrum Employee Benefits ("Spectrum"). The IRS has determined and informed Spectrum by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. Plan Termination

In April 2022, the Plan was terminated and merged into the Pine Gate Renewables 401(k) Plan. As a result, participant accounts became fully vested and nonforfeitable and were rolled over to the Pine Renewables 401(k) Plan.

7. Party-in-Interest Transactions

Administrative fees paid by the Plan to Alerus for administrative services amounted to \$10,999 for 2022. Alerus is the trustee and recordkeeper of the Plan. As such, these transactions qualify as party-in-interest.

8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820") which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

Basis of Fair Value Measurements

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used in 2022 or 2021.

Mutual funds and money market funds: Valued at net asset value ("NAV") of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
