Management has obtained a certification from a qualified institution as of April 18, 2022 and for the period from January 1, 2022 to April 18, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the 2022 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the 2022 financial statements or to the 2022 financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

As permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the predecessor auditors not to perform, and they did not perform, any auditing procedures with respect to the information certified by a qualified institution. Their report, dated October 13, 2022, indicated that (a) the amounts and disclosures in the 2021 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with GAAP and (b) the information in the 2021 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### (1) Description of plan

The following description of the Tapstone Energy 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan was a defined contribution plan which was adopted on January 1, 2014 to provide retirement benefits for employees of Tapstone Energy, LLC and Subsidiaries (collectively, the "Company"). Effective April 17, 2020, the Plan became part of the controlled group of an affiliated company, the Tapstone Management Company, LLC. The Plan covered substantially all employees, excluding union and leased employees, nonresident aliens, and residents of Puerto Rico, ("participants") of the Company and the Tapstone Management Company, LLC (collectively, the "Employer"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In December 2021, the Employer was acquired by Diversified Energy Company, PLC (formerly, the Diversified Gas & Oil Corporation). On April 18, 2022, the Plan was merged into the Diversified Gas & Oil Corporation Employee Savings Plan ("DGOC Plan"), and all participant account balances were transferred into the DGOC Plan.

#### (b) Contributions

Prior to January 1, 2022, participants could voluntarily make qualified retirement contributions to the Plan which were deductible by the participants for federal income tax purposes under Section 401(k) of the IRC. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. Participant contributions were permitted up to 75% of compensation subject to certain IRC limitations.

The Plan had an automatic enrollment provision in which participants were automatically enrolled on the first of the month following one month of service and began contributing 6% of their eligible compensation unless the participant elected otherwise.

The Employer could make a discretionary matching contribution to the Plan. Effective October 1, 2020, the Employer would determine each year the percentage for the discretionary matching contribution, which was equal to a uniform percentage of the participant's salary deferrals. No discretionary Employer matching contributions were made in 2022.

The Plan also provided that the Employer could contribute a discretionary profit sharing contribution each year in an amount authorized by the Employer; however, the Employer made no profit sharing contribution in 2022.

(c) Participant accounts

Each participant's account was credited or charged with the participant's contributions and allocations of Employer contributions, investment earnings (losses) of the investment options selected by the participant, and an allocation of administrative expenses. Allocations were based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

(d) Vesting

Participants were immediately vested in their elective salary deferral plus actual earnings (losses) thereon. Vesting in the Employer's matching and discretionary profit sharing contributions was based on four years of continuous credited service. Effective October 1, 2019, a participant was 100 percent vested in Employer matching contributions.

Participants could also become 100% vested upon full or partial termination of the Plan, or in one of the following ways, if incurred while employed: (1) death or (2) disability. Participants became 100% vested in all accounts upon the merger of the Plan as described in Note 1(a).

(e) Notes receivable from participants

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable from participants were secured by the balance in the participant's account and bore interest at a rate equal to the prime rate plus one percent, which was commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest were paid ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, permanent disability, or retirement, a participant could elect to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant was entitled to receive only the vested interest in his or her account as a lump-sum distribution.

(g) Forfeited accounts

Forfeitures were created when participants terminated employment prior to becoming fully vested in the Employer discretionary matching and profit sharing contributions portion of their accounts. Such forfeitures were used to reduce the Employer's contributions to the Plan or to pay plan expenses. Forfeited nonvested accounts of \$2,210 were transferred into the DGOC Plan as of April 18, 2022. On December 31, 2021, forfeited nonvested accounts totaled \$11.

(h) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(i) Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Employer and are excluded from these financial statements. Fees related to the processing of distributions and certain other specific transactions were included in administrative expenses and were charged directly to the participant's account. Investment related expenses were included in net depreciation in fair value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan were prepared under the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("GAAP").

(b) Investment valuation and income recognition

Investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determined the Plan's valuation policies utilizing information provided by the Newport Trust Company ("Newport"). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Net depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the plan document.

(d) Payment of benefits

Benefits were recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

The Employer has evaluated events and transactions that occurred between April 18, 2022 and March 20, 2023, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments and notes receivable from participants reported and disclosed in the accompanying financial statements, including the fair value of investments and notes receivable from participants held at April 18, 2022 and December 31, 2021, and net depreciation in fair value of investments, dividend income and interest on notes receivable from participants for the period from January 1, 2022 through April 18, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Newport.

(4) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at April 18, 2022 and December 31, 2021.

- (i) *Mutual funds*: Valued based on the funds' reported closing net asset values ("NAV") of shares held by the Plan as of the last business day of the plan year. The mutual funds are deemed to be actively traded.
- (ii) *Common/collective trust fund*: Valued at NAV of units of the common/collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan held mutual funds totaling \$18,426,854, which were classified as Level 1 investments in the fair value hierarchy as of December 31, 2021. No mutual funds were held as of April 18, 2022.

The following table summarizes investments for which the fair value is measured using NAV as a practical expedient as of April 18, 2022 and December 31, 2021, respectively. There were no participant redemption restrictions for these investments.

(5) Income tax status

The Employer adopted a pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved profit sharing plan was designed in accordance with the applicable sections of the IRC. The Plan itself had not received a determination letter from the IRS stating that the Plan was qualified under Section 401(a) of the IRC. However, the plan administrator believed that the adopted plan, as amended, was designed and operated in compliance with the applicable requirements of the IRC and was therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator had analyzed the tax positions taken by the Plan, and had concluded that as of April 18, 2022 and December 31, 2021, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Untimely remittance of participant contributions

The Employer was required by Department of Labor regulation to remit participant contributions as soon as practicable, but by no later than the fifteenth business day following the end of the month in which the amounts were withheld from wages. For certain participant contributions withheld in 2021, the funds were not remitted timely. Imputed lost earnings applicable to these participant contributions were calculated and contributed to the Plan under the Voluntary Fiduciary Correction Program in 2022.

(7) Related party and party-in-interest transactions

As described in Note 1, the Plan paid expenses to various service providers and held notes receivable from participants which also qualified as party-in-interest transactions.
