We have audited the financial statements of the Lancer Financial Group, Inc. 401(k) Profit Sharing Plan an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103 (a)(3)(C) for the period ended March 14, 2022, and we will issue our report thereon dated January 24, 2023. As permitted by ERISA Section 103 (a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan by Vanguard, the trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a) (3) (C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Our audit of the financial statements does not relieve you or management of your responsibilities.

Planned Scope, Timing of the Audit, Significant Risks, and Other

We performed the audit according to the planned scope and timing previously communicated to you in our meeting about planning matters on January 19, 2023, and we have communicated to you the significant risks of material misstatement identified as part of our audit planning.

An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements; therefore, our audit involved judgment about the number of transactions to be examined and the areas to be tested.

Our audit includes obtaining an understanding of the Plan and its environment, including internal control, sufficient to assess the risks of material misstatement of the financial statements and to design the nature, timing, and extent of further audit procedures. Material misstatements may result from (1) errors, (2) fraudulent financial reporting, (3) misappropriation of assets, or (4) violations of laws or governmental regulations, including prohibited transactions with parties in interest or other violations of ERISA rules and regulations, that are attributable to the Plan or to acts by management or employees acting on behalf of the Plan. We generally communicate our significant findings at the conclusion of the audit. However, some matters could be communicated sooner, particularly if significant difficulties are encountered during the audit where assistance is needed to overcome the difficulties or if the difficulties may lead to a modified opinion. We have also communicated any internal control related matters that are required to be communicated under professional standards.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during the period ended March 14, 2022. We noted no transactions entered into by the Plan during the period for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

The financial statement disclosures are neutral, consistent, and clear.

As discussed in Note 9 to the financial statements, the Plan was terminated on March 14, 2022 and all assets were transferred to a new Plan. The employees of the Lancer Financial Group became eligible to participate in the new plan effective January 1, 2022.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no misstatements noted during the audit process.

Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested and received certain representations from the Administrative Committee and management that are included in the management representation letter dated January 24, 2023.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

This information is intended solely for the use of the Administrative Committee and management of the Plan and is not intended to be, and should not be, used by anyone other than these specified parties.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

MARCH 14, 2022 AND DECEMBER 31, 2021

NOTE 1. DESCRIPTION OF PLAN

The following is a brief description of the Lancer Financial Group, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan established to encourage savings by employees of Lancer Financial Group, Inc. (the Company). The Plan covers all employees who have attained the age of 18 and are not covered under a collective bargaining agreement. Employees need not perform a minimum amount of service to become eligible to begin making elective deferrals. Employees become eligible to receive employer matching contributions and profit sharing contributions after performing 1,000 hours of service. All eligible employees are automatically enrolled on the plan commencing on the employee's hire date unless they elect to opt out of the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Administrative Committee of the Plan is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Administrative Committee of the Plan.

Contributions

Participants may elect to contribute an amount equal to a percentage of their annual compensation not to exceed the limits imposed by Section 402(g) of the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch up contributions. The Company will match, dollar for dollar, the first 3% of the employee's contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an autoenrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Participants may change the percentage of contribution or the designation of the proportions in which subsequent contributions under the Plan will be invested at any time.

On January 1, 2022, the Plan was frozen to new participants and ceased deferrals to the Plan after December 31, 2022.

NOTE 1. DESCRIPTION OF PLAN (continued)

Participants Accounts

Participant accounts are credited with participant contributions and an allocation of employer contributions and plan earnings. Participants are responsible for directing the contributions into various investment options offered by the Plan. The accounts are charged with any distributions made to the participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant accounts are always fully vested in their contributions and the Company's Safe Harbor matching contributions, plus actual earnings thereon and shall not be subject to forfeiture for any reason. A participant will be a qualified participant entitled to share in the profit sharing contributions any Plan year the participant is an employee of the Company on the last day of that Plan year except in the case of the participant's death, termination due to disability or termination due to normal retirement age. Vesting in the profit sharing contributions fully vests in year six.

Investment Options

The Plan provides for a number of investment options maintained by Vanguard. A self-directed brokerage option is also available to allow participants to select investment options not specifically offered by the Plan. Amounts are contributed to each fund in the proportion designated by each employee, in multiples of 5%. Plan participants cannot defer more than the Internal Revenue Code 402 (g) limit (\$19,500 and \$26,000 for participants 50 or over in 2021).

Investment income and net realized and unrealized appreciation (depreciation), as determined by the Plan's trustees, are allocated to participants based on the individual participant's equity in each investment fund.

Participants Loans

Participants may obtain a loan from the Plan upon request of Vanguard, the Plan's trustee. The loan amount available will be determined by the Plan's trustee up to a maximum, including all outstanding loans, of the lesser of \$50,000 or 50% of the participant's vested interest in the Plan as of the date the loan is granted. The loans are secured by the balance in the participant's account and bear interest at the prevailing prime rate plus 2%. Principal and interest is paid ratably through semi-monthly payroll deductions. All loans must be repaid within five years except for loans for the purchase of a primary residence, which have a maximum repayment period of ten years.

Benefits

On termination of service, death, disability, or retirement, if the vested account balance exceeds \$5,000, a participant may receive distribution in the form of a lump-sum amount equal to the vested account balance or through several installment payment options. For vested account balances less than \$5,000, all distributions are through lump-sum payment.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The financial statements are prepared using the accrual basis of accounting.

Plan Trustee - The Plan is maintained under a trust agreement with the Vanguard Fiduciary Trust Company (Vanguard), which has custody of the assets of the Plan and makes payments to participants at the direction of the Plan sponsor.

Investments and Income Recognition- Investments are carried at fair value which generally represents the net asset value of the mutual funds as of the last business day of the year as provided by the investment company.

Purchases and sales are recorded on the trade date basis. Interest and dividends are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Loans to Participants - Participant notes are measured at their principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Forfeitures - When certain terminations of participants in the Plan occur, the Company profit sharing contributions portion of the participant's account represents a forfeiture. This account will be used to reduce future Company contributions. At December 31, 2021, forfeited nonvested accounts totaled \$7,089.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Administrative Expenses - Plan administrative expenses are primarily comprised of investment management advisory fees and recordkeeping fees. These expenses are paid directly by the Plan.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2022 and 2021. Accordingly, Vanguard Fiduciary Trust Company, the Trustee of the Plan for the periods ended March 14, 2022 and December 31, 2021, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of March 14, 2022 and December 31, 2021.

NOTE 4. PRIORITIES UPON TERMINATION

On March 14, 2022, the Plan was terminated and all existing account balances were transferred to existing account balances into the successor Plan, Core Specialty Insurance Holdings, Inc, 401(k) Plan. The Plan administrator was not required to notify the Pension Benefit Guaranty Corporation (PBGC) that the Plan had terminated. The PBGC does not insure defined contribution plans, under which contributions are made by on or behalf of employees into individual employee accounts with no promise as to the amount of payouts. Defined contribution plans include 401(k) plans, profit-sharing plans, money purchase plans, and employee stock ownership plans (ESOPs).

NOTE 5. TAX STATUS

The Plan obtained its latest determination letter on May 28, 2014 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 401(a) of the Internal Revenue Code, and was, therefore, exempt from federal income taxes under Section 501(a). The Plan's administrator and the Plan's counsel believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

NOTE 6. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 6. FAIR VALUE MEASUREMENTS (continued)

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

For the periods ended March 14, 2022 and December 31, 2021, there were no transfers in or out of levels 1, 2, or 3.

The Plan's investments are participant directed. Participants can initiate transactions in and out of their accounts at any time without prior notice.

NOTE 7. RELATED PARTIES

Certain Plan investments are shares of mutual funds managed by Vanguard Fiduciary Trust Company, the Trustee, as defined by the Plan. These transactions qualify as party-in-interest transactions and have been denoted as such on the supplemental schedule of assets held at end of year.

Certain administrative duties are provided by the employer, Lancer Financial Group, Inc. for which no fees have been charged to this Plan. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.

NOTE 8. RISK AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 9. PLAN TERMINATION

Effective December 31, 2021, Lancer Financial Group, Inc. adopted a resolution to terminate the Plan with the intention to transfer existing account balances into the successor plan. The employees of Lancer Financial Group, Inc. became eligible to participate in the new plan effective January 1, 2022. The new plan is a result of the merger between the Lancer Financial Group, Inc. and Core Specialty Insurance Holdings, Inc. On March 14, 2022, the Lancer Financial Group, Inc. 401(k) Profit Sharing Plan was terminated and all existing account balances were transferred to existing account balance into the successor Plan, Core Specialty Holdings, Inc. 401(k) Plan.

NOTE 10. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through January 24, 2023, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards
