### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Echo360, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which financial statements comprise the statements of net assets available for benefits as of July 1, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through July 1, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of Plan

Echo360, Inc. established the Echo360, Inc. 401(k) Plan (the Plan) effective March 14, 2008. The Plan included Echo360, Inc. and affiliated companies Echo Government Solutions, LLC (formerly known as Echo Secure, LLC) and Echo Continuing Education, LLC (formerly known as Astute Technology, LLC) (collectively, the Company). The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan was a defined-contribution plan covering substantially all employees of the Company who had attained the age of 21. Effective April 19, 2021, the Plan was restated to comply with legislative and regulatory changes. There were no eligibility service requirements for participant deferral elections or discretionary matching contributions. To be eligible for nonelective discretionary contributions, participants must have worked at least 501 hours and been employed at the end of the plan year. New participants entered the Plan the first day of the month following the month of hire. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On December 22, 2021, Turning Technologies, LLC, a premium provider of learning engagement platforms and EdTech solutions, acquired Echo360, Inc., a global video-based learning platform. As a result, the Plan was merged with the Turning Technologies, LLC 401(k) Profit Sharing Plan, effective July 1, 2022. Accordingly, on that date assets totaling \$7,290,975 became assets of the Turning Technologies, LLC 401(k) Profit Sharing Plan.

#### *Trustee and administration of the Plan*

The trustee and recordkeeper of the Plan was Fidelity Management Trust Company (Fidelity or trustee). The administrator of the Plan was the Company. The trustee held all assets of the Plan in accordance with the service provider contract with the Company. The Company's Board of Directors was responsible for the oversight of the Plan. Management determined the appropriateness of the Plan's investment offerings, monitors investment performance, and reported to the Company's Board of Directors.

#### *Contributions*

Each year, eligible participants could contribute up to 60% of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. Salary reduction election could be changed as of the beginning of each payroll period. Participants could also enter into a special salary reduction agreement to make additional deferral contributions in an amount up to 100% of their compensation for bonuses. Participants could designate a portion or all of their deferrals as Roth Deferral Contributions. Eligible employees were automatically be enrolled in the Plan with a salary deferral of 6% unless they affirmatively elected not to participate in the Plan. Deferral as part of automatic enrollment increased annually by 1% up to a maximum of 12% of eligible compensation. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Catch-up contributions were not eligible for discretionary matching contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (Rollover contributions).

Participants directed the investment of their contributions into various investment options offered by the Plan. The Company could make discretionary matching contributions and nonelective discretionary contributions for all eligible participants. During the period from January 1, 2022 through July 1, 2022, there were no discretionary employer matching contributions or nonelective discretionary employer contributions made to the Plan.

### ***Participant accounts***

Each participant's account was credited with the participant's contributions and the Company's discretionary matching contributions, as well as allocations of the Company's nonelective discretionary contributions and plan earnings. Participant accounts were charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

### ***Vesting***

Participants were vested immediately in their elective deferral contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and nonelective discretionary contributions portion of their accounts was based on years of continuous service as follows:

<i>Years of Service</i>	Percent Vested
Less than three years	0%
Three years or more	100%

In the event of death, permanent disability, or retirement, a participant's employer contribution account became fully vested.

### ***Notes receivable from participants***

Participants could borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period, and a minimum of \$1,000. The loans were secured by the balance in the participant's account and bore interest rates which were commensurate with local prevailing rates, as determined by the Plan Administrator. Loans were repaid within a five-year period, except for the purchase of a principal residence in which case loans could be repaid within ten years. Principal and interest were paid ratably through payroll deductions. Only one loan was allowed to be outstanding at any given time.

### ***Payment of benefits***

On termination of service due to death, disability or retirement, a participant, or a participant's beneficiary in the case of death, could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a period of time. For termination of service due to other reasons, a participant received the value of the vested interest in his or her account as a lump-sum distribution or a rollover to another qualified plan. Participants with account balances less than \$5,000 automatically received a lump-sum

distribution. Participants were eligible for in-service distributions of any portion of their vested account balance after attaining the age of 59½. Before 59½, withdrawals could be made from a participant's deferral contribution only in the event of demonstrated financial hardship, as provided in the plan document.

### ***Forfeited accounts***

Forfeitures of the non-vested portion of withdrawing participants' accounts were retained in the Plan and used first to pay administrative expenses and any remaining amounts were used to reduce future Company discretionary matching contributions and nonelective discretionary contributions. There were no balances within forfeiture accounts as of July 1, 2022 or December 31, 2021. During the period from January 1, 2022 through July 1, 2022, no forfeitures were used to pay administrative expenses or to reduce discretionary matching contributions.

## **2. Summary of Significant Accounting Policies**

### ***Basis of accounting***

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment valuation and income recognition***

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determined the Plan's valuation policies utilizing information provided by the investment advisors and the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation included the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### ***Notes receivable from participants***

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. If a participant ceased to make loan repayments and the Plan Administrator deemed the participant loan to be in default, then the participant loan balance was reduced and a benefit payment was recorded.

### *Payment of benefits*

Benefits were recorded when paid.

### *Administrative expenses*

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net depreciation in fair value of investments.

### **3. Certified Investment Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified that the following investment information included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of July 1, 2022 and December 31, 2021.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period from January 1, 2022 through July 1, 2022.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level, within the fair value hierarchy, is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at July 1, 2022 and December 31, 2021.

### ***Mutual Funds and Money Market Account***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

The preceding method described above may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value at December 31, 2021. There were no assets at fair value at July 1, 2022 as a result of the Plan's merger into the Turning Technologies, LLC 401(k) Profit Sharing Plan.

### 5. Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments were shares of mutual funds and a money market account managed by Fidelity. Fidelity was the trustee, as defined by the Plan, and therefore, these transactions qualified as party-in-interest transactions. Fees incurred by the Plan for the investment management services were included in net depreciation in fair value investments. The Company paid, directly, any other fees related to the Plan's operations. Notes receivable from participants also constituted exempt party-in-interest transactions under ERISA.

### 7. Tax Status

The Company, as the Plan's sponsor, adopted a non-standardized prototype plan which received an IRS opinion letter dated June 30, 2020, which states that the restated prototype plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator timely adopted the stated prototype plan. The Plan Administrator believed that the Plan is designed, and was operated, in compliance with the applicable requirements of the IRC and, therefore, believed that the Plan was qualified and was tax exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator analyzed the tax positions taken by the Plan, and has concluded that as of July 1, 2022 and December 31, 2021, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the accompanying financial statements. The Plan was subject to routine audits by taxing jurisdictions, however, there were currently no audits for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

### 9. Subsequent events

The Plan has evaluated subsequent events through March 27, 2023 the date the financial statements were available to be issued.
