We have performed an audit of the financial statements of Sunrise Windows 401(k) & Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 14, 2022, December 31, 2021, and the related statements of changes in net assets available for benefits for the period ended January 14, 2022 and year ended December 31, 2021, and the related notes to the financial statements (collectively, 2022 and 2021 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 and 2021 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the period ended January 14, 2022 and as of and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2022 and 2021 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2022 and 2021 Financial Statements section:

Emphasis of Matter – Plan Merger

As discussed in Note 5 to the financial statements, the Board of Directors of Sunrise Windows Ltd., the Plan's sponsor, voted on October 18, 2021, to merge the Plan into the MI Windows and Doors 401(k) Plan effective January 14, 2022. All plan assets were transferred to MI Windows and Doors 401(k) Plan in January 2022. Our opinion has not been modified with respect to these matters.

Responsibilities of Management for the 2022 and 2021 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2022 and 2021 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 and 2021 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. In our report dated September 27, 2021, we indicated that (a) because of the significance of the information that we did not audit, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, we did not express an opinion on the 2020 financial statements, and (b) the form and content of the information included in the 2020 financial statements other than that derived from the certified information were presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Plan Description

The following description of the Sunrise Windows 401(k) & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Sunrise Windows Ltd. (the Company) who are 20½ years of age and have completed six months of service. Effective May 11, 2018, employees are automatically enrolled, with a deferral rate of 3%, on the first day of the quarter following their eligibility requirements being met. All employees who have completed 500 hours of service during the year are also eligible for the discretionary profit sharing contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 14, 2022, the Plan was amended to merge the Plan into MI Windows and Doors 401(k) Plan, which is disclosed in detail in Note 5 to the financial statements. Plan Sponsor management communicated the Plan termination to participants in 2021.

Contributions: Each year, individual participants may elect to contribute a percentage of their gross wages, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes safe harbor matching contributions, whereby the Company contributes 100% of the participant deferrals and catch-up contributions up to 3% plus 50% of the next 2% of deferrals. Effective May 15, 2020, the Company suspended the safe harbor matching contribution. The safe harbor matching contribution was re-instated on January 1, 2021. Additional amounts may be contributed at the option of the Company. The Company did not make a discretionary profit sharing contribution to the Plan for the period ended January 14, 2022 or the year ended December 31, 2021. Employer contributions are invested in a manner consistent with participant contributions. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, if any, and (b) Plan earnings and charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions and the Company's safe harbor contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service as defined by the Plan. A participant is 100% vested after five years of credited service.

Forfeitures: Under the Plan, forfeitures are used to either reduce administrative expenses or to reduce future Company contributions. At January 14, 2022, December 31, 2021 and 2020, forfeiture account balances of approximately \$77,513, \$77,513 and \$43,100, respectively, were available.

Payment of benefits: Upon termination of service for any reason, attainment of age 59½, death or retirement, a participant will receive a lump sum amount equal to the value of his or her account. Benefits are recorded when paid.

Administration of Plan assets: Certain administrative functions are performed by officers or employees at the Company. No such officer or employee receives compensation from the Plan.

Note 1. Plan Description (Continued)

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Participants may borrow from their fund accounts a minimum of \$900 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are collateralized by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the custodian. Rates at January 14, 2022 and December 31, 2021 ranged from 4.25% to 6.50%. Principal and interest are paid ratably through payroll deductions.

Coronavirus Aid, Relief, and Economic Security Act (CARES Act): The Plan has implemented certain requirements allowed by the CARES Act and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which allows certain eligible individuals to receive coronavirus-related relief to suspend required minimum distributions and also includes a delay of the commencement date for required minimum distributions. The features within these acts were implemented during the year ended December 31, 2020, as required by the Internal Revenue Service (IRS). Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment contracts: Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attributable for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. There are no fully benefit responsive contracts held by Plan at January 24, 2022, December 31, 2021 or 2020.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest and dividend income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note 2. Significant Accounting Policies (Continued)

Fair value measurements: Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. That hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 14, 2022, December 31, 2021 and 2020.

Shares of pooled separate accounts: Valued using net asset value (NAV), as a practical expedient, of shares held by the insurance company in their pooled accounts at year-end.

Guaranteed investment contract: Valued a fair value by discounting the related cash flows based on the current yield of similar instruments with comparable duration considering the credit worthiness of the issuer. This category includes investments primarily in diversified fixed income mutual funds and separately managed bond accounts run by investment subsidiaries of Voya Financial, and in book value stabilizing agreements offered by high quality financial institutions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Recent accounting pronouncement adopted: In August 2018, the Financial Accounting Standards Board issued Accounting Standards Update 2018-13, *Fair Value Measurement (Topic 820): Disclosure Framework—Changes to the Disclosure Requirements for Fair Value Measurement*. The ASU modifies the disclosure requirements for fair value measurements by removing, modifying, or adding certain disclosures.

Subsequent events: The Plan Sponsor has evaluated subsequent events for potential recognition and/or disclosure through January 18, 2023, the date the financial statements were available to be issued.

Note 3. Information Certified by Voya Retirement Insurance and Annuity Company (Voya)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Voya, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedules.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. During the year ended December 31, 2020, participants transferred (on a net basis) approximately \$452,000 into the Voya Fixed Account, a level three investment. For the year ended December 31, 2021, there were no transfers in or out of level three. For the period ended January 14, 2022, there was \$85,092 transferred out of the Voya Fixed Account as part of the transfer of investments into the MI Windows and Doors 401(k) Plan.

Note 5. Plan Merger

In October 2021, the Plan Sponsor elected to merge the Plan with the MI Windows and Doors 401(k) Plan effective January 14, 2022.

Legal title and responsibility of net assets of \$10,887,152 were transferred to the MI Windows and Doors 401(k) Plan, which includes notes receivable of \$204,536 from participants. Investments in the amount of \$10,605,103 were transferred to the MI Windows and Doors 401(k) Plan on January 14, 2022, while remaining investments in the amount of \$77,513 and notes receivable of \$204,536 were transferred on January 24, 2022. As a result, the statement of net assets as of January 14, 2022, reflects an amount due to the MI Windows and Doors 401(k) Plan and the statement of changes in net assets available for benefits for the period ending January 14, 2022, reflects a transfer to the MI Windows and Doors 401(k) Plan.

Note 6. Related Party Transactions

Certain Plan investments are managed by the custodian. The custodian performs services for the Plan, and, therefore, these transactions qualify as party-in-interest. Fees paid to the custodian by the Plan for the period and year ended January 14, 2022 and December 31, 2021 were approximately \$50 and \$7,000, respectively.

Note 7. Income Tax Status

The Plan is an adopter of a prototype plan. As such, no individual determination letter is available. The Internal Revenue Service has determined that the prototype plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan's administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for the years before 2018.
