INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
Acusis 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Acusis 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of November 18, 2022 (in liquidation) and December 31, 2021 (ongoing), the related statements of changes in assets available for benefits for the period from January 1, 2022 to November 18, 2022 (in liquidation) and the year ended December 31, 2021 (ongoing) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of November 18, 2022 and for the period from January 1, 2022 to November 18, 2022 and as of and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP); and

- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

As discussed in Note 1 to the financial statements, a decision to terminate the Plan was made effective March 16, 2022, and all of the Plan's assets were distributed by November 18, 2022. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the financial statements for the year ended December 31, 2021 to the liquidation basis used in presenting the financial statements for the period from January 1, 2022 to November 18, 2022. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

General - The Plan was a defined contribution plan originally established effective February 1, 2001 and amended and restated as recently as January 1, 2017. The Plan covered virtually all employees of Acusis LLC (the "Company") who had attained the age of 18. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In connection with the sale of the Company's operating assets, the Company elected to terminate the Plan effective March 16, 2022. No contributions were made after the termination date, and final distributions were completed by November 18, 2022. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the financial statements for the year ended December 31, 2021 to the liquidation basis used in presenting the financial statements for the period from January 1, 2022 to November 18, 2022. No differences exist between the liquidation basis of accounting and the ongoing basis of accounting as all investments are reported at fair value under both methods. Accordingly, the liquidation basis is presented from January 1, 2022 rather than March 16, 2022.

Use of Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of changes in net assets during the reporting periods. Actual results could differ from those estimates.

Contributions - Participants were able to contribute a portion of their compensation each year to the Plan, subject to annual limits prescribed by the Internal Revenue Code. Employee contributions were recorded in the period during which the Company made payroll deductions from the Plan participants' earnings. For the period from January 1, 2022 to November 18, 2022 and the year ended December 31, 2021, the employer matching contribution percentage under safe harbor provisions was 100% of the first 3% and 50% of the next 2% of each employee's compensation deferred. Matching contributions were typically calculated at the end of each year and paid in the subsequent year, though the matching contributions for the period from January 1, 2022 to November 18, 2022 were made in July 2022. Additional discretionary employer contributions were permitted. There were no discretionary employer contributions for the period from January 1, 2022 to November 18, 2022 or for the year ended December 31, 2021.

Investment Valuation and Income Recognition - Investments were carried at their fair value based on published quotations or, in the absence of readily ascertainable market values, at such values as the custodian determined. The Plan presented net appreciation or depreciation in the fair value of its investments, which consisted of realized gains or losses and the unrealized appreciation (depreciation) of these investments, in the statements of changes in assets available for benefits. Gains and losses on securities sold or redeemed were determined on the basis of specific identification. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

Participant Accounts - Each participant's account was credited with the participant's contribution, an allocation of the Company's contribution and Plan earnings. Earnings were allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund.

Payment of Benefits - Benefits were reflected when they had been approved for payment and were paid by the Plan. Upon termination of service, a participant was able to elect to receive either a lump-sum amount equal to the value of his or her accounts less applicable tax withholding amounts or a direct, tax-free rollover. All distributions were subject to the provisions of the Plan agreement.

Investment Options - Participants were able to direct their contributions and any related earnings into various investment options. Participants were able to change their investment options at any time.

Vesting - Participants were immediately vested in their voluntary contributions and employer contributions.

Fair Value Measurements - Accounting principles generally accepted in the United States of America establish a framework for measuring fair value of financial assets. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the guidance are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs are not quoted prices in active markets, but they are observable either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan's money market and mutual fund balances were valued using level 1 inputs at December 31, 2021.

Administrative Expenses - The Company paid substantially all administrative expenses as permitted by the Plan document.

Subsequent Events - Management has evaluated subsequent events through March 5, 2023, the date which the financial statements were available to be issued.

2. INCOME TAX STATUS

The Plan operated under a standardized adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust. The Internal Revenue Service stated in a letter dated March 31, 2014 that the prototype plan was designed in accordance with the applicable regulations of the Internal Revenue Code (IRC). The Plan was amended since the date of the opinion letter. However, the plan administrator believes that the Plan was designed and was operated in compliance with the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management believes that there is no liability related to uncertain tax positions at November 18, 2022 or December 31, 2021. The Plan is no longer subject to tax examinations for tax years before 2019.

3. CERTIFIED FINANCIAL INFORMATION

The custodian has certified that the following data included in the accompanying financial statements is complete and accurate.

- Investments, as shown in the statements of assets available for benefits as of November 18, 2022 (in liquidation) and December 31, 2021 (ongoing).
- Investment income (loss), as shown in the statements of changes in assets available for benefits for the period from January 1, 2022 to November 18, 2022 (in liquidation) and the year ended December 31, 2021 (ongoing).

4. RELATED PARTIES AND PARTIES-IN-INTEREST

Ascensus, LLC (Ascensus) served as custodian and recordkeeper of the Plan and also provided access to certain funds as investment options through an affiliated company, The Vanguard Group, Inc. (Vanguard). Both Ascensus and Vanguard were considered parties-in-interest.

Certain administrative functions of the Plan were performed by employees of the Company. Neither the Company nor its employees received compensation from the Plan.
