## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Westmed Medical Group Profit Sharing Plan

### Scope and Nature of ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Westmed Medical Group Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). - the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**1. DESCRIPTION OF PLAN**

The following description of Westmed Medical Group Profit Sharing Plan (the "Plan") provides only general information. For a more complete description of the Plan's provisions, refer to the agreement governing the Plan ("Plan Document").

General

The Plan was established on January 1, 2019, and was a defined contribution plan covering eligible employees of WESTMED Medical Group, P.C. (effective December 26, 2021, and thereafter, became known as Westchester Medical Group, PLLC due to corporate restructuring and merger with another entity, see below for additional discussion) and The Rye Ambulatory Surgery Center, LLC (collectively, the "Company" or "Plan Sponsor") and supplements the benefits of eligible employees who participated in the Westmed Medical Group Retirement Savings Plan ("RSP"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan.

Plan Merger

In December 2021, the Plan Sponsor merged with another company which has its own retirement plan (the "Successor Plan"). In February 2022, the Plan administrator resolved to terminate and merge the Plan into the Successor Plan. Therefore, the final payroll period for eligible participant compensation used to determine employer contributions occurred in February 2022. In June 2022, substantially all participant accounts that were held by the Plan were either distributed to certain eligible participants based on the nature of the source of contributions to their accounts or transferred to the Successor Plan on their behalf, with the remaining transfers occurring in August 2022.

Eligibility

The Plan covered eligible employees of the Company who attained 21 years of age and have completed 1,000 hours of service within one Plan year. The Plan excluded employees who were covered by a collective bargaining agreement, certain nonresident aliens and leased employees. The effective dates of participation were January 1 or July 1, subsequent to the participant meeting the eligibility requirements.

Contributions

Under the provisions of the Plan Document, participants were allowed to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

In order to maintain safe harbor status, the Plan Sponsor intends to make an annual safe harbor non-elective contribution ("Safe Harbor Contribution") equal to 3% of compensation for each eligible participant. Participants were not required to be employed on the last day of the Plan year to be eligible for the Safe Harbor Contribution. Any eligible employee who was entitled to a Safe Harbor Contribution under the RSP, which was made to this Plan, was deemed eligible to participate in this Plan with respect to such Safe Harbor Contribution. For the period from January 1, 2022 to August 31, 2022, Safe Harbor Contributions amounted to \$256,832.

Contributions (Continued)

In addition, the Plan Sponsor, at its sole discretion, was allowed to make profit-sharing contributions to eligible participants of the Plan. If the Plan Sponsor elected to make a discretionary contribution, such contribution was to be allocated to eligible participant accounts based on the pro-rata share of each participant's compensation to the total compensation for each sub-class of participants, as defined in the Plan Document. Participants were required to be employed on the last day of the Plan year to be eligible for such profit-sharing contributions. For the period from January 1, 2022 to August 31, 2022, discretionary profit-sharing contributions amounted to \$55,888.

Participant Accounts

Individual accounts were maintained for each Plan participant. Each participant's account was credited with any participant rollover contributions and an allocation of the Plan Sponsor's contributions and investment earnings, profits and losses, and was charged with withdrawals and an allocation of administrative expenses. Allocations of investment earnings, profits and losses were based on the ratio of each participant's account balance to the total of all participant account balances. The benefit to which a participant was entitled is the benefit that can be provided from the vested accounts.

Vesting

Participants were immediately fully vested in their accounts for rollover contributions, discretionary profit-sharing contributions and Safe Harbor Contributions.

Notes Receivable from Participants

Participants were allowed to borrow from the vested interest in their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, except as discussed in Note 2 related to the Coronavirus Aid, Relief, and Economic Security Act (the "CARES Act"). The funds required to satisfy a borrowing request are withdrawn on a pro-rata basis from various investment funds in the participant's account. The borrowings generally were to be fully repaid within five years, except when the proceeds were used for the purchase of the participant's principal residence.

The loans were secured by the vested balance in the participant's account and bore interest at the prime rate plus 1%. Interest rates were set at inception of the loan and fixed for the duration. At August 31, 2022, there were no loans outstanding. At December 31, 2021, the interest rate on outstanding loans was 4.25%, maturing on various dates through October 2024. Principal and interest were repaid ratably through payroll deductions. Principal and interest repayments were credited directly to the borrower's respective account and were generally repaid via payroll deductions. During the period from January 1, 2022 to August 31, 2022, the remaining loans outstanding of \$20,314 were transferred into the Successor Plan, which are included in "Net transfers to other plan" in the accompanying statement of changes in net assets available for benefits.

Participant Distributions

On termination of service, a participant (or designated beneficiary) was allowed to elect to (a) receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, (b) roll over the value of the participant's vested interest in his or her account into another qualified plan, (c) receive annual or monthly installment payments over a specified period or in specified amounts, or (d) receive a partial distribution of his or her total account balance. Active participants were eligible to receive in-service or hardship withdrawals or withdrawals allowed under the Internal Revenue Code ("IRC") for participants that reach age 59½.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accompanying financial statements were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and changes in net assets available for benefits during the year. Accordingly, actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year such adjustments are determined.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan Document.

In 2020, the Plan adopted certain provisions of the CARES Act; however, the Plan was amended in 2021 for the adoption of these provisions. The CARES Act provisions that were adopted pertained to notes receivable by participants, including the following:

- (a) Participants that met eligible CARES Act criteria were allowed to borrow up to the lesser of \$100,000 or 10% of their vested balance for 180 days, beginning March 27, 2020.
- (b) Participants were allowed to defer loan repayments that would otherwise be due between March 27, 2020 and December 31, 2020. Loan repayments resumed starting January 1, 2021.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on an accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation included the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair Value Measurement

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Under this standard, fair value is defined as the exit price, or the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and, inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Payment of Benefits

The Plan adopted the following CARES Act provisions pertaining to benefit payments to participants:

- (a) Participants that met eligible CARES Act criteria were allowed to take penalty-free withdrawals of up to \$100,000 from January 1, 2020 through December 31, 2020.
- (b) Participants had the ability to repay the amount withdrawn within three years, though repayment was not required.
- (c) A CARES Act distribution was not to be considered a hardship distribution; therefore a participant did not have to first obtain a loan or other available distributions under the Plan before requesting a distribution.

Benefits were recorded when paid to Plan participants.

Administrative Expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and were excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions were charged directly to the participant's account and included in administrative expenses. Investment-related expenses are included in "Net depreciation in fair value of investments."

Subsequent Events

In accordance with FASB ASC 855, *Subsequent Events*, the Plan has evaluated subsequent events through March 6, 2023, the date on which these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

**3. RISKS AND UNCERTAINTIES**

The Plan provided for various investment options in combinations of mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits and statement of changes in net assets available for benefits.

**4. FAIR VALUE MEASUREMENTS**

There were no assets held by the Plan as of August 31, 2022.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. FAIR VALUE MEASUREMENTS (CONTINUED)**

*Cash equivalents:* Cash equivalents are primarily investments in money market funds and highly liquid U.S. government securities. The cash funds are valued at the per unit amounts reported daily by such funds, which approximate fair value. U.S. government treasury and agency securities are valued based upon the closing price reported in the active market in which the security is traded.

*Common collective trust funds:* Valued at the NAV of the units of a collective trust. The NAV as provided by the custodian of the fund is based upon the fair value of the underlying assets held by the fund. Participant transactions (purchases and sales) may occur daily. If the Plan were to make a full accumulated book value withdrawal from the fund, a written request must be made 12 months prior to the designated valuation date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. INFORMATION CERTIFIED BY THE PLAN CUSTODIAN**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of information regarding the Plan as of August 31, 2022 and December 31, 2021, and for the period from January 1, 2022 to August 31, 2022, which was prepared by or derived from information prepared by the custodian and furnished to the Plan administrator. The Plan administrator has obtained a certification from the custodian that such information is complete and accurate.

**7. TAX STATUS**

The Plan used a prototype plan document which had received an opinion letter from the Internal Revenue Service ("IRS") dated March 31, 2014, stating that the prototype document satisfied the applicable provisions of the IRC. Although the Plan was amended from the original prototype document, the Plan Sponsor believed that the Plan is designed and was being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualified under Section 401(a) of the IRC and was exempt from federal income taxes under Section 501(a) of the IRC. Accordingly, no provision for income taxes was included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of August 31, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**8. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain administrative functions were performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Additionally, certain administrative expenses were paid directly by the Plan Sponsor.

Certain Plan investment options included funds managed by the custodian. Accordingly, these transactions qualified as party-in-interest transactions. Notes receivable from participants were also party-in-interest transactions.
