INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audit of the financial statements of the WhiteHat Security, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of October 5, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period ended October 3, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of October 5, 2022 and December 31, 2021, and for the period ended October 5, 2022, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters we identified during the audit.

WhiteHat Security, Inc. 401(k) Plan Notes to Financial Statements

1. Description of Plan

The WhiteHat Security, Inc. 401(k) Plan (the Plan) was established by NTT Security AppSec Solutions Inc. (formerly known as WhiteHat Security, Inc.) (the Company), effective August 31, 2005, to provide participants with a method to fund their retirement on a tax-deferred basis. The Plan has since been amended and restated, most recently as of May 6, 2022. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

In July 2021, the Company amended and restated the Company's Certificate of Incorporation and changed the name of the Company to NTT Application Security, Inc.

In June 2022, the Company entered into an acquisition agreement whereby Synopsys, Inc. acquired 100% ownership of the Company. Participants became eligible to contribute to the acquiring Company's employee benefit plan on June 23, 2022, and contributions to the Plan ceased. Effective October 3, 2022, the Plan was merged with the acquiring company's employee benefit plan, at which time all Plan assets were transferred. Plan operations concluded on October 5, 2022, at which date the Plan ceased to exist.

General:

The Plan was a defined contribution plan with a 401(k) salary deferral arrangement qualified under appropriate provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company was the Plan sponsor and Plan administrator. The Plan was administered by Company employees and a Plan Committee. Fidelity Management Trust Company (Fidelity) served as the Plan's trustee and record keeper. Fidelity held, invested and reinvested trust assets in the interest and at the direction of participants and their beneficiaries. The Company had engaged MMA Securities, LLC (MMA) as an investment advisor. MMA assisted the Plan Committee in selecting investment options offered under the Plan and monitoring investment performance.

Eligible Participants:

Company employees, as defined by the plan agreement, age 18 or older could become participants immediately following their date of hire.

1. Description of Plan (continued)

Contributions:

Participants were permitted to make contributions to the Plan through pre-tax salary reduction up to 100% of annual compensation, as defined, subject to certain limitations under the Code. Participants who had reached the age of 50 could elect to withhold additional catch-up contributions under the Code. Participants were also able to contribute after-tax contributions and amounts representing distributions from other qualified defined benefit or contribution plans (rollovers), subject to Code regulations.

The Company could make discretionary matching and non-elective contributions at the discretion of the Company's Board of Directors. The Company did not make any matching contributions during the period from January 1, 2022 through October 5, 2022.

The Plan provided for automatic enrollment on the date a participant became eligible for the Plan. The automatic election for eligible participants was 4% of their compensation, unless the participant requested a different amount to be contributed or formally declined participation. Participants were permitted to adjust their deferral rate or discontinue their contributions at any time.

Contributions were subject to certain limitations under the Code.

Participant Accounts:

Each participant's account was credited with the participant's contributions and an allocation of Company contributions, if any, plus earnings (less any losses) thereon. Allocations were based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account balance.

Participants could elect to invest their accounts in a variety of participant-directed investment fund options offered by the Plan that were designed to provide the participants with a wide range of investment options. A participant could authorize transfers among investment options at any time.

Vesting:

Participants were immediately vested in their salary deferral, after-tax and rollover contributions, and Company matching contributions, if any, plus actual earnings (less any losses) thereon. Vesting in Company non-elective contributions, plus allocated earnings (less any losses) thereon, was based on continuous years of service. A participant became 20% vested in Company non-elective contributions after two years of service and was fully vested after six years, or upon retirement, disability, Plan termination or death.

1. Description of Plan (continued)

Notes Receivable from Participants:

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes were reclassified as distributions based upon the terms of the Plan document.

Participants could borrow up to one-half of their account balance, not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which longer terms could be granted. The notes were evidenced by a written note, secured by the vested balance in the participant's account and bore interest at a rate that was commensurate with local prevailing rates, as determined by the Plan administrator, under the Plan's note policy. Repayment of principal and interest was generally made through payroll deductions.

Liability for Corrective Distributions:

The liability for corrective distributions represents contributions made by certain participants that must be refunded in order for the Plan to be in compliance with applicable non-discrimination tests. The December 31, 2021 liability of \$8,911 was refunded in 2022.

Payment of Benefits:

Upon termination of service, participants could elect to leave their account balance in the Plan or receive benefits. Benefits were paid either in a lump-sum cash distribution equal to the value of the participant's vested account balance or in regular cash installment payments over a period requested by the participant, subject to certain stipulations as defined by the Plan agreement. Accounts between \$1,000 and \$5,000 could be automatically distributed to individual retirement accounts on behalf of the participants without participant approval. Accounts below \$1,000 could be automatically distributed directly to participants without participant approval.

Benefits were recorded when paid.

Administrative Expenses:

Several of the investment fund options were subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees were charged directly against the fund's investment performance and, thus, were not separately disclosed in the financial statements. Certain account maintenance, Plan advisory, distribution, note, and other transaction fees were charged to the Plan and allocated to participant accounts. All other expenses to administer the Plan were paid by the Company and were not reflected in the Plan's financial statements.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan prepared its financial statements using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investments:

The Plan's mutual funds were valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted prices in active markets.

The Plan's investment in the Putnam Stable Value Fund (the Fund), a common/collective trust, was valued at contract value. The Plan invested in fully benefit-responsive investment contracts through the Fund. Contract value was the relevant measurement for the portion of plan assets available for benefits attributable to fully benefit-responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan agreement.

Fair Value Measurement:

The Plan used a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritized within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focused on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those investments.

The three-level hierarchy for fair value measurement was defined as follows:

Level I: Inputs to the valuation methodology were quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level II: Inputs to the valuation methodology included quoted prices for similar assets and liabilities in active markets, and inputs that were observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level III: Inputs to the valuation methodology, which were significant to the fair value measurement, were unobservable.

Fair Value Measurement: (continued)

An investment's categorization within the fair value hierarchy was based on the lowest level of input that was significant to the fair value measurement.

The Plan's mutual funds were classified as Level I within the fair value hierarchy through their disposition. The Fund, valued at contract value, was excluded from the three-tier hierarchy under GAAP.

Income Recognition:

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual method of accounting. Dividends were recorded on the ex-dividend date. Net depreciation included gains and losses on the Plan's investments bought, sold or held during the period.

4. Tax Status

The Company adopted a volume submitter plan offered by Fidelity, which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating the form of the plan submitted for review qualified under provisions of the Code. The Plan was amended since receiving the letter. However, the Company believed the Plan was being operated in compliance with the applicable requirements of the Code and related state statutes and was, therefore, qualified through October 5, 2022 and the trust, which formed a part of the Plan, was exempt from federal and state income taxes.

GAAP required Plan management to evaluate income tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator analyzed the income tax positions taken by the Plan, and has concluded, at October 5, 2022, there were no uncertain income tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan will continue to be subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for the years prior to 2019.

5. Party-In-Interest Transactions

The Plan's investments included securities managed by Fidelity. As Fidelity was the Plan's trustee, purchases and sales of these investments qualified as party-in-interest transactions. Notes receivable transactions with participants also qualified as party-in-interest transactions. These transactions were exempt from the prohibited transaction rules under ERISA.
