

As described in Note 2, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. There were no material adjustments to the 2022 financial statements as a result of the change under the liquidation basis of accounting. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. There were no significant estimates in the financial statements.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements were:

- The disclosure addressing non-exempt prohibited transactions as it relates to untimely remittances of participant withholdings in Note 9 to the financial statements.
- The disclosure addressing the Plan's termination in Note 7 to the financial statements.

The financial statement disclosures are neutral, consistent, and clear.

A significant risk is an identified and assessed risk of material misstatement that, in the auditor's professional judgment, requires special audit consideration. Within our audit, we focused on the following areas.

- Management override of controls
- Improper revenue recognition
- Plan Termination

##### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

##### *Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in performing and completing our audit.

### *Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no misstatements detected as a result of audit procedures that were more than trivial.

There were no known uncorrected misstatements that were more than trivial.

### *Reportable Findings*

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified the following reportable findings:

### *Disagreements with Management*

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

### *Management Representations*

We have requested certain representations from management that are included in the management representation letter dated as of the date of the audit report.

### *Management Consultations with Other Independent Accountants*

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

### *Other Audit Findings or Issues*

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

#### *Emphasis of Matter*

Our report will include the following emphasis of matter paragraph:

As described in Note 7 to the financial statements, the Board of Directors of Galesburg Hospital Corporation, the Plan's sponsor, approved a plan of liquidation as of February 28, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

#### *Other Matters*

Our responsibility for the ERISA-required supplementary schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplementary schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplementary schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Appendix II

### Communication of Internal Control Matters Identified During the Audit

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Galesburg Hospital Corporation 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of and for the year ended August 31, 2022, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing our opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Nationwide Trust Company, FSB and Nationwide Life Insurance Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified a certain deficiency in internal control that we consider to be significant deficiency.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. A reportable finding is an indication of deficiencies in internal control identified during the audit that have not been communicated to management by other parties and that, in the auditor's professional judgment, are of sufficient importance to merit management's attention. We did not identify any deficiencies in internal control that we consider to be material weaknesses.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. A reportable finding is an indication of deficiencies in internal control identified during the audit that have not been communicated to management by other parties and that, in the auditor's professional judgment, are of sufficient importance to merit management's attention. We consider the following deficiency in the Plan's internal control to be a significant deficiency and reportable finding:

#### **Contributions Made Late**

Department of Labor regulations require employers to remit participant withholdings (employee contributions) to the Plan as soon as they can be reasonably segregated from the employer's general assets. During 2022, we noted delinquent contributions totaling \$19,996. Therefore, the plan is considered to have engaged in a prohibited use of plan assets. In order to correct the failure, we recommend the plan sponsor fund potential lost earnings to the affected participant accounts. This matter should also be corrected through one of the Internal Revenue Service programs.

## Appendix III Matters for Management's Consideration

In planning and performing our audit of the financial statements of the Plan as of and for the year ended August 31, 2022, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

However, during our audit we became aware of matters for management's consideration that are opportunities for correcting noncompliance, strengthening internal controls, and improving operating efficiency. This letter does not affect our report dated March 29, 2023, on the financial statements of the Plan. Our comments and recommendations regarding these matters are:

### **Review of Service Organization Control Report (SOC)**

Plan management has access to the Service Organization Control (SOC) Report provided by the Plan's third-party service provider, but management did not review the SOC report. The SOC report provides a description of the third-party service provider's system for processing retirement plan transactions. In the SOC report, an auditor will have provided an opinion on the suitability of the design and operating effectiveness of controls to achieve the related control objectives stated in the description. In addition, the SOC report will include the user controls that the third-party service provider relies on the plan sponsor to implement. Due to significant reliance on the Plan's third-party service provider to process and record plan transactions, it is important that plan management obtain, review, and retain the SOC report on an annual basis to ensure that internal controls are operating effectively and there are no areas of concern regarding compliance and financial reporting. In addition, Plan management should ensure that the user controls identified are in place.

### **Monitoring of Third-Party Service Providers**

Lack of annual plan review. The Department of Labor continues to emphasize to plan sponsors, the importance of monitoring all services providers hired to perform any duties of plan administration. As part of your fiduciary responsibilities, you are required to periodically monitor the TPA to ensure it is properly performing the agreed-upon procedures. This monitoring should include, but is not limited to, reading and reviewing any reports provided, reviewing the TPA's performance periodically, checking actual fees charged and following up on participant complaints.

### **Fidelity Bond Coverage**

The Plan Sponsor could not provide any documentation of ERISA coverage. Through review of the 5500 and conversation with administrator, it seems that there was information showing this coverage at some point, but the Plan Sponsor could not provide when requested. We recommend the plan sponsor obtain documentation of ERISA fidelity bond coverage and provide this documentation to us when available.

### **Incorrect Deferral Percentage Used**

In our testing we found two participants who had changed their deferral percentage in Nationwide, but it was never updated in the payroll software. Documentation supporting all enrollments and election changes should be maintained as evidence of the appropriate authorization. Maintaining proper documentation regarding participant data can safeguard the Plan and the Plan Sponsor. Transactions construed as a breach of fiduciary duty could result in penalties against the Plan Sponsor and/or be considered prohibited transactions.

### **Employee Census is Incorrect**

Employee deferrals do not agree from the plan sponsor provided census to the gross compensation reported from the payroll system. As a result, we were unable to determine completeness of our testing population. We would recommend that plan sponsor review these to ensure agreement before providing this information.

**Incorrect Deferral Type Contributed**

During one pay in the current year we found that funds were contributed to the plan under in the incorrect type of deferrals. There were multiple participants whose Pre-tax and Roth contribution types were entered incorrectly. We recommend procedures be implemented to ensure proper characterization of employee contributions.

**Participant Opt-Out**

During our audit we noted that once newly eligible employees are given the enrollment info to begin contributions to the plan, there is no follow-up by the plan sponsor of eligible employees who did not enroll. We recommend that the plan sponsor add an additional item to the enrollment form for eligible employees who are not interested in participating to indicate doing so on the form. We further recommend then that the plan sponsor follow up with eligible employees until all forms are returned.

**Lack of Payroll Review**

During our internal control walk through we found that there wasn't a second individual reviewing the payroll after it was completed. Per the plan sponsor there were no available employees within plan administration to review the payroll. We would recommend having a second individual review payroll before finalizing to ensure everything is correct and accounted for.
