## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits of the 2022 and 2021 Financial Statements

We have performed the audits of the financial statements of Bind Benefits 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 15, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 to July 15, 2022 and for the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's 2022 and 2021 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 14, 2022 and December 31, 2021 and for the period from January 1, 2022 to July 14, 2022 and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the 2022 and 2021 Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the 2022 and 2021 Financial Statements section:

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ## **Emphasis of Matter**

As discussed in Note 1 to the financial statements, effective July 15, 2022, the Plan was merged into the UnitedHealth Group 401(k) Savings Plan. Our opinion was not modified with respect to this matter.

## **Responsibilities of Management for the 2022 and 2021 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audits of the 2022 and 2021 Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits of the 2022 and 2021 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

We were engaged to audit the 2020 financial statements of the Plan. As permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed us not to perform and we did not perform any auditing procedures with respect to the information certified by a qualified institution. In our report dated October 8, 2021, we indicated that (a) because of the significance of the information that we did not audit, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, we did not express an opinion on the 2020 financial statements, and (b) the form and content of the information included in the 2020 financial statements other than that derived from the certified information were presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### **NOTE 1 - Description of the Plan**

---

The following description of the Bind Benefits 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### *General*

The Plan was a defined contribution plan sponsored by Bind Benefits, Inc. (“the Company”) and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Employees who were age eighteen (18) or older were eligible to make elective deferrals and receive employer discretionary matching and profit sharing contributions under the Plan.

Effective July 20, 2021, the Company delegated its rights and responsibilities as plan administrator, except with respect to plan investments, to the UnitedHealth Group Employee Benefits Plans Administrative Committee (“Plan Administrator”). The Company delegated its rights and responsibilities for investment authority and oversight of the Plan’s assets to the UnitedHealth Group Employee Benefits Plans Investment Committee (“Investment Committee”). The Investment Committee determined the appropriateness of the Plan’s investment offerings and monitored investment performance.

Effective December 7, 2021, the Plan was restated on a non-standardized pre-approved plan document.

Effective December 13, 2021, the Plan was frozen to new participation and all future contributions.

Effective July 14, 2022, the investments were liquidated and converted to cash. Effective July 15, 2022, the Plan was merged into the UnitedHealth Group 401(k) Savings Plan and all assets were transferred as of that date.

##### *CARES Act*

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) was signed into law. The provisions of the CARES Act affecting employer-sponsored retirement plans were optional. During 2020, the Plan opted into the following provision of the CARES Act:

- Coronavirus-related distributions – Qualified individuals, as defined in the CARES Act, were permitted to take a coronavirus-related distribution of up to the lesser of \$100,000 or 100% of their vested account from the Plan, without incurring a 10% early withdrawal penalty. Eligible distributions were permitted to be taken until December 30, 2020. Distributions could be repaid to an eligible retirement plan within three years or a participant could elect to include these distributions in taxable income on a pro rata basis over three years.

##### *Contributions*

Prior to the Plan being frozen, participants could contribute an amount up to the maximum dollar amount permissible under the Internal Revenue Code (“the Code”). The Plan allowed participants to contribute up to 100% of their eligible pay. Elective deferrals included pre-tax deferrals, Roth deferrals, and rollover contributions. Participants who had attained age 50 before the end of the plan year could make additional catch-up contributions, subject to limitations imposed by the Code.

Prior to the Plan being frozen, the Company could make discretionary matching contributions. The Company could also make a discretionary profit sharing contribution that was distributed among eligible participants pro rata based upon each participants' eligible compensation compared to all eligible participants' compensation. Participants were eligible for discretionary profit sharing contributions if they were age 18 or older and were employed on the last day of the plan year. There were no discretionary matching or profit sharing contributions for the period from January 1, 2022 to July 15, 2022, or for the year ended December 31, 2021.

#### *Participant Accounts*

Each participant's account was credited with the participant's deferral contributions, rollover contributions, the Company's discretionary matching and profit sharing contributions, if any, and Plan earnings (net of administrative expenses). Allocations were based on the participant's eligible compensation or account balances, as defined in the Plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

#### *Investments Classification*

All investments were participant directed. The Plan was intended to comply with ERISA section 404(c). Participants had the right to individually select the percentage of their accounts to be invested among different classifications of investments made available to them.

#### *Vesting*

Participants were immediately vested in their salary deferral contributions and rollover contributions, and earnings thereon. Employer discretionary matching and profit sharing contributions, if any, vested in accordance with the provisions of the Plan as follows:

<u>Years of Service</u>	<u>Vesting</u>
Less than 1 year	0%
1 or more	25%
2 or more	50%
3 or more	75%
4 or more	100%

Notwithstanding the vesting schedule above, employer discretionary matching and profit sharing contributions, if any, would become fully vested (100%) upon the occurrence of any of the following events while the participant was employed by the Company: death, attainment of normal retirement age (age 65), disability, partial plan termination with respect to the participant, complete termination of the Plan or complete discontinuance of employer contributions, as defined in the Plan document.

Participants became 100% vested in all contributions when the Plan was frozen.

#### *Forfeited Accounts*

Forfeited nonvested accounts totaled \$0 as of July 15, 2022, and December 31, 2021 and 2020. Forfeitures could be used to reduce future employer contributions or to pay certain administrative expenses. For the period from January 1, 2022 to July 15, 2022, and for the year ended December 31, 2021, no forfeitures were used to reduce employer contributions or pay administrative expenses for the Plan.

##### *Payment of Benefits*

Benefits could be paid to the participant or beneficiary upon death, disability, retirement, or termination of employment as defined in the Plan document. The total vested portion of a participant's account balance could be distributed in the form of a lump-sum or partial payment. However, if a participant's account balance was valued at or less than \$1,000, it was distributed as soon as administratively practicable, without an application for distribution, in cash as a direct distribution to the participant, unless the participant requested that the amount be rolled over into another individual retirement account or retirement plan. With Plan Administrator approval, participants could withdraw all or part of their employee contributions in the event of financial hardship.

There were no amounts owed to participants who had elected to withdraw from the Plan, but had not been paid as of July 15, 2022, or December 31, 2021 and 2020.

#### **NOTE 2 - Summary of Significant Accounting Policies**

---

##### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments include the gains and losses on investments bought and sold as well as held during the year.

##### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Subsequent Events*

The Plan has evaluated subsequent events through March 24, 2023, the date the financial statements were approved and available to be issued.

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2022, 2021, and 2020. Accordingly, Ascensus, LLC, as agent for Ascensus Trust Company ("the Trustee"), has certified to the completeness and accuracy of all investments reflected on the accompanying Statements of Net Assets Available for Benefits as of July 15, 2022, and December 31, 2021 and 2020, and the supplemental, Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2021, and the related investment activity reported in the Statements of Changes in Net Assets Available for Benefits for the period from January 1, 2022 to July 15, 2022, and for the year ended December 31, 2021.

#### **NOTE 4 - Fair Value of Financial Instruments**

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Unadjusted quoted prices for identical assets in active markets that the Plan can access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs for the asset.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 and 2020.

*Mutual funds:* Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the net asset value ("NAV") of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay the withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following tables set forth by level within the fair value hierarchy a summary of the Plan's investments measured at fair value on a recurring basis at December 31, 2021 and 2020, respectively. The Plan held no investments as of July 15, 2022.

Certain of the Plan's investments are managed by The Vanguard Group, Inc. ("the Recordkeeper") and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation (depreciation) in fair value of investments.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

#### **NOTE 7 - Tax Status**

---

Effective December 7, 2021, the Plan uses a non-standardized pre-approved plan document sponsored by Ascensus, LLC. The pre-approved plan sponsor received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states the Plan document satisfies the applicable provisions of the Code. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and being operated in compliance with the applicable requirements of the Code, and therefore believe the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

---

#### **NOTE 8 - Risks and Uncertainties**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2021 and 2020, the Plan had investments of \$6,773,922 and \$2,444,215, respectively, concentrated in five and three investments that each accounted for more than 10% of plan investments.
