## INDEPENDENT AUDITORS' REPORT

To the Participants and Administrator of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of LifeCare, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of February 14, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 to February 14, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of February 14, 2022 and December 31, 2021, and for the period January 1, 2022 to February 14, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### **1. Description of the Plan**

The LifeCare, Inc. 401(k) Plan (the “Plan”), as amended, is a defined contribution plan that was established November 1, 1995, and covers all eligible employees, as defined by the Plan, of LifeCare, Inc. (the “Company” or “Employer”).

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan Agreement or Summary Plan Description, not included herein, for more complete information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### ***General***

On December 31, 2020, Empower Retirement completed their acquisition of Massachusetts Mutual Life Insurance Company’s retirement plan business. Great-West Life & Annuity Insurance Company (“GWLA”) and Great-West Trust Company, LLC (“GWTC”) (collectively “Great-West”) are the custodians of the Plan, which replaced Massachusetts Mutual Life Insurance Company as a result of the acquisition effective January 1, 2021.

In 2022, Plan management approved the merger of the Plan into the IAC/InterActiveCorp Retirement Savings Plan. All Plan assets were merged into the IAC/InterActiveCorp Retirement Savings Plan with an effective date of January 1, 2022. The actual merger and transfer of assets occurred on February 14, 2022. Following the merger, no assets remain in the Plan.

#### ***Eligibility***

There is no minimum length of service required to participate in the Plan, and employees are eligible to begin participation on designated monthly enrollment dates provided that they have reached 21 years of age. Employees are eligible to receive Employer discretionary matching contributions after one year of service.

Excluded employees include collectively bargained employees, nonresident aliens with no U.S. source income or leased employees.

#### ***Contributions***

Plan participants may contribute a portion of their eligible compensation to their employee deferral accounts, on a tax deferred basis. Participant contributions may not exceed the federal statutory limit as specified by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

#### ***Contributions (continued)***

The Employer may make matching contributions in addition to the safe harbor matching contribution elected. The safe harbor matching contribution is made to the account of each eligible participant in an amount equal to the sum of 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% but do not exceed 5% of the participant's compensation. The Employer may make matching contributions equal to a discretionary percentage, to be determined by the Employer, of the participants' elective deferrals. During the period January 1, 2022 to February 14, 2022 (herein referred to as "2022"), the Employer did not make any safe harbor matching contribution to the Plan.

#### ***Participant Accounts***

A participant's account is credited with the participant's contribution and allocations of (a) Employer contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately vested in their contributions, safe harbor contributions, and actual earnings thereon. Vesting in the Employer discretionary matching contribution is as follows:

#### ***Forfeited Accounts***

Forfeited accounts are amounts forfeited by employees with a non-vested portion in their account that have terminated their employment and who have withdrawn from the Plan. Forfeited contributions will be used first to reduce expenses related to the administration of the Plan and then to reduce any Employer contributions. At February 14, 2022 and December 31, 2021, forfeited non-vested amounts totaled \$0 and \$3,509. During 2022, the forfeitures were allocated to participant accounts, no forfeitures were used to reduce Employer contributions and no forfeitures were used to reduce Plan expenses.

#### ***Payment of Benefits and Withdrawals***

The Plan is designed to provide benefits at the time of retirement. However, if employment with the Company is terminated because of death, disability, or any other reason, a request for distribution of a participant's vested account balance is also allowed. If a participant dies while classified as an active member of the Plan, the participant's beneficiary or beneficiaries are entitled to receive 100% of the participant's account balance. Should a participant become totally and permanently disabled while employed by the Company, the full value of the participant's account balance may be distributed upon request.

Upon termination of employment, the vested amount of the participant's account will be distributed to the participant in a lump-sum cash payment if the participant's vested account balance is less than \$5,000. If the account balance is greater than \$5,000, the participant's written consent will be required for any distribution including the election of a rollover distribution to another qualified plan. Otherwise, the plan administrator will direct the custodian to begin distribution no later than April 1 of the calendar year after the participant attains the age of 70½, or, if the participant is an active employee, 72. Upon reaching age 59½, pursuant to the Internal Revenue Code ("IRC"), participants may elect distributions from their accounts without any tax penalty.

Subject to certain limitations prescribed by the Plan and the IRC, participants may elect hardship withdrawals. In accordance with the IRC, a 10% premature distribution penalty tax may also be imposed on such withdrawals from a participant's account.

#### ***Expenses***

Administrative fees incurred in connection with loans and participant activity charges are borne by the individual and deducted from their respective Plan assets. Plan administration fees are borne by the Company. Investment related expenses are included in the net asset value of the respective investment vehicle and, consequently, those expenses are not separately reflected but are a component of net depreciation in value of investments.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loans bear interest at the prime rate in effect at the date of execution plus 1% and are secured by the participant's account. The loans plus interest are repaid through payroll deduction in equal payments over the term of the loan (up to five years or up to fifteen years for the purchase of a principal residence). A participant may have no more than one outstanding loan from the Plan at any time. Upon termination of service, the principal and accrued interest shall be immediately due and payable.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2021, all investments that were measured at fair value, were valued using level 1 inputs.

#### ***Investment Valuation and Income Recognition***

All of the Plan's investments are valued at fair value, except for the insurance company general account which is recorded at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. All mutual funds of the Plan are deemed to be actively traded. The insurance company general account is valued at contract value, which represents contributions plus credited interest less participant withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Accounting of Uncertainty of Income Taxes***

The Plan recognizes the effect of income tax positions only if those positions are more likely than not to be sustained. Management has determined that the Plan had no uncertain tax positions that would require financial statement recognition and/or disclosure. The Plan is subject to routine examinations by taxing jurisdictions, however, there are currently no examinations for any periods in progress.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is December 12, 2022.

### **3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements including investments and notes receivable from participants held at February 14, 2022 and December 31, 2021, and net depreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the period ended February 14, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Great-West and Reliance Trust Company, qualified institutions.

### **4. MassMutual Capital Preservation**

The MassMutual Capital Preservation investment option was a market value separate account investment option with a general investment account guarantee that provided a stated rate of return and insulated participants' accounts from daily fluctuations in the market. Under the terms of the Capital Preservation group annuity contract, participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their balance at contract value. Great-West reserved the right to impose or not impose the deferral period based on circumstances at the time of notice of termination. Based on current practices, participant withdrawals are permitted during the deferral period provided there is continuity of Plan operations, including but not limited to Great-West's continuing role as the Plan's record-keeper.

Certain events may limit the ability of the Plan to currently transact at contract value and may result in a deferral of the payment at contract value for up to twelve months. Such events include but may not be limited to the following: (1) removal of a group of participants from Plan coverage as a result of temporary absence, change in position or other occurrence qualifying as a temporary break in service under the Plan; (2) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the Employer; (3) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Employer's business; (4) removal from the Plan of one or more groups or classifications of participants; (5) partial or complete termination of the Plan; or (6) Plan disqualification.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Since the MassMutual Capital Preservation investment option was fully benefit-responsive, it was stated at contract value on the statements of net assets available for benefits. Contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the MassMutual Capital Preservation investment option.

Credit risk is the risk that an issuer or other counterparty to an investment will not fulfill its obligations. The credit risk of the custodian, Great-West, was evaluated by nationally recognized statistical rating agencies as of December 31, 2021 as follows: A.M. Best Company, Inc. (A+), Moody's Investors Service (Aa3), Standard and Poor's (AA), and Fitch Ratings (AA).

### 5. Party-in-Interest Transactions

Certain Plan investments are managed by Great-West, the custodian of the Plan, and therefore, these investment holdings qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

The Plan had an agreement with MassMutual whereby MassMutual would pay the Plan's investment advisor, UBS Financial Services Inc., on behalf of the Plan. The payments came from MassMutual and are not a plan asset. Each month, MassMutual calculated the eligible credits by multiplying the value of the Plan's assets as of the last business day of the month by 1/12<sup>th</sup> of the annual reimbursement credit percentage, which is 0.25%. During 2022, the eligible credits used to be paid to UBS Financial Services Inc. on behalf of the Plan totaled \$0.

### **6. Tax Status**

The Plan was formed using a prototype plan designed by the custodian. The IRS has determined and informed the custodian by letter dated March 31, 2014 that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

### **7. Prohibited Transactions**

During 2021, the Company failed to remit to the Plan certain participants' contributions and loans totaling \$4,112 within the period prescribed by the DOL's Rules and regulations due to administrative errors. In 2022, the Company remitted \$4,112 of 2021 late contributions and lost earnings to the IAC/InterActiveCorp Retirement Savings Plan.
