### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements*

We have performed an audit of the financial statements of the Contessa Health 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 21, 2022 and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to September 21, 2022, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of September 21, 2022 and for the period from January 1, 2022 to September 21, 2022 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, we do not express an opinion, a conclusion, or provide any form of assurance on the 2021 financial statement.

### (1) Description of plan

The following description of the Contessa Health 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document, copies of which were available from the Plan administrator, for a more complete description of the Plan's provisions.

#### (a) General

The Plan was a defined-contribution plan which was established on January 1, 2018 to provide retirement benefits for employees of Contessa Health Management, LLC (the "Plan Sponsor"). The Plan covered substantially all employees who were age twenty-one or older and had one month of service ("participants"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan's assets were maintained by Voya Insurance and Annuity Company ("Voya") and records for the Plan were maintained by Access Retirement Services, LLC ("Access Retirement") as the record-keeper.

Effective September 21, 2022, the Plan was merged into the Amedisys Holdings, LLC 401(k) Plan ("Amedisys Plan"). All investments from participants were transferred from the Plan into the Amedisys Plan on September 21, 2022. The net assets were recognized in the participant's accounts of the Amedisys Plan as previously carried in his or her accounts of the Plan. Effective May 1, 2022, participants became eligible to contribute to the Amedisys Plan and contributions to the Plan were suspended.

#### (b) Eligibility and Contributions

Employees were eligible for salary deferrals and employer match contributions upon one month of service and attainment of age 21. Entry into the Plan occurred on the first day of the month coinciding with or next following, the satisfaction of the eligibility requirements. Participants could contribute eligible wages, as defined in the Plan document, to the Plan through a salary deduction arrangement. Contributions were subject to certain Internal Revenue Code ("IRC") limitations. Participants directed the investment of their contributions into various investment options offered by the Plan. Participant contributions were permitted up to 100% of compensation subject to certain IRC limitations, and participants could choose to suspend elections at any time. Participants who were age 50 by the end of the Plan year may have been eligible to make additional catch-up contributions to the Plan.

The Plan allowed for discretionary matching contributions, as determined annually by the Plan Sponsor. During 2022, the Plan Sponsor matched 50% of each participant's elective deferrals on the first 4% of allocated earnings, with an annual cap of 2%. Plan Sponsor contributions may not have exceeded the maximum amount allowable for federal income tax purposes.

(c) Participant accounts

Participants directed the investment of contributions into various investment options offered by the Plan. Each participant's account was credited with rollovers, their contributions, the Company's contributions, earnings or losses on investments in their account, and was charged with the allocated portion of the administrative expenses and certain transaction fees. Allocations were based on relative participant account balances. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account.

(d) Vesting

Participants were immediately vested in their elective salary deferral plus actual earnings (losses) thereon. Vesting in the Company's discretionary contributions was based on years of continuous service. Participants were fully vested after 4 years of qualifying service. Participants were fully vested in employer contributions at September 21, 2022.

(e) Payment of benefits

A participant's account was distributed based upon the participant's election under the Plan document upon retirement, death, disability or termination of employment. Retirement was defined under the Plan document as age 65. In-service withdrawals were permitted upon the attainment of age 59½. Hardship distributions were permitted and were made from the vested portion of a participant's account, as defined in the Plan document.

(f) Forfeited accounts

Forfeitures were created when participants terminated employment prior to becoming fully vested in the Company discretionary matching contribution portion of their accounts. Such forfeitures were permitted to be used to reduce the Plan Sponsor's contributions or pay Plan expenses. As of September 21, 2022, there were no forfeited accounts transferred to the Amedisys Plan. Forfeitures totaling \$512 were utilized to offset Plan Sponsor contributions. At September 21, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0.

(g) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(h) Administrative expenses

Plan administration fees and transaction-based fees related to the processing of distributions were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

The Plan's financial statements were prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates.

(b) Investment valuation and income recognition

Investments were stated at fair value or contract value as reported by Voya. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determined the Plan's valuation policies utilizing information provided by the investment advisers and Voya. See Notes 4 and 5.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Net depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits were recorded when paid.

(d) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") required management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### (3) Certified information

Certain information reported and disclosed in the accompanying financial statements, including the fair value of investments as of September 21, 2022, net depreciation in fair value of investments, and interest and dividends for the period from January 1, 2022 to September 21, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya.

### (4) Fair value measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 and Level 3 are not applicable to the Plan.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

- (i) *Mutual funds*: Valued at the net asset value of shares held by the Plan at year end in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Investment contract with insurance company

The Plan was party to a benefit-responsive investment contract with an insurance company, Voya. The insurance company maintained the Plan's contributions in a pooled account which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The contract was included in the financial statements at contract value, which approximated fair value, as reported to the Plan by Voya. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer. There was no stated minimum or maximum rate. Such interest rates were reviewed on a semi-annual basis for resetting.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan which approximates fair value. Contract value, as was reported to the Plan by Voya, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants were ordinarily able to direct the withdrawal or transfer of all or a portion of their investment at contract value.

The terms of the contract required all permitted participant initiated transactions to occur at contract value. Since the contract was the obligation of Voya, the Plan Sponsor believed the occurrence of an event that limited the ability of the investment to transact at contract value was not probable. The contract allowed participants reasonable access to their assets. The contract had no restrictions on the use of Plan assets and there were no valuation reserves recorded to adjust contract amounts.

(6) Income tax status

On June 30, 2020, the Internal Revenue Service ("IRS") stated that the pre-approved profit sharing plan adopted by the Plan, as then designed, qualified under Section 401 (a) of the IRC. The Plan had not received a determination letter specific to the Plan itself. The pre-approved plan document was amended since receiving the opinion letter, and the Plan administrator believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or assets) if the Plan has taken an uncertain position that more-likely-than-not would not have been sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 21, 2022 and December 31, 2021, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements.

(7) Related party and party-in-interest transactions

As described in Note 1, the Plan paid expenses to various service providers, which qualify as party-in-interest transactions under ERISA.

(8) Risks and uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
