Note 1. Description of Plan

General

The following brief description of the vCORE Technology Partners 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

The Plan was established on January 1, 2011. The Plan is a defined contribution plan covering all eligible employees of vCORE Technology Partners LLC (the "Employer" and "Administrator"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In February 2022, the Plan Sponsor was acquired by AHEAD, Inc. As of June 7, 2022, the Plan merged into the AHEAD, Inc. 401(k) Plan.

Contributions

Each year, participants could contribute a portion of their compensation to the Plan, subject to limitations prescribed by the Internal Revenue Service. There were two types of deferrals: pretax contributions and after-tax Roth contributions. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan.

The Company could make discretionary matching and profit-sharing contributions to the Plan. For the period ended June 7, 2022, the Company matched 100% of the first 3% of a participant's compensation. The Company did not make profit-sharing contributions to the Plan in 2022. All contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Investment Account Options

Each participant had the option of directing their contributions into any of the various investment options offered by the Plan and could change the allocation daily.

Participant Accounts

Each participant's account was credited with the participant's contributions and the Company's discretionary matching and profit-sharing contributions, and Plan earnings. Participant accounts were charged with an allocation of administrative expenses, as applicable. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Vesting

Participants were immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and profit-sharing contributions, plus actual earnings thereon, was based on years of credited service. A participant vested 25% after one year of service and vested an additional 25% each year, until fully vested after four years of service. If a participant reached retirement age (65), died, or became totally disabled, the participant became fully vested in the Plan, irrespective of years of service.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms were up to five years. The loans were secured by the balance in the participant's account and bore interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest was paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a defined period of time or elect to roll his or her investment into another qualified plan or account. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

At June 7, 2022 and at December 31, 2021, forfeited non-vested accounts totaled approximately \$0 and \$23,200, respectively. Forfeited non-vested accounts were used to pay administrative expenses and or used to reduce future employer contributions. During the period ended June 7, 2022, there were approximately \$13,600 of forfeitures used to reduce employer contributions.

Note 2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis.

Use of Estimates

The preparation of financial statements in conformity with United States generally accepted accounting principles (U.S. GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets and the reported amounts of additions to and deductions from net assets. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by Principal Life Insurance Company and Delaware Charter and Trust Company d/b/a Principal Trust Company (collectively, "Principal"). See *Note 4* for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when incurred. If a participant ceased to make loan repayments and the Plan Administrator deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded based on the terms of the plan document.

Payments of Benefits

Benefits were recorded when paid.

Administrative Expenses

The Plan permitted administrative expenses to be paid from the Plan's assets and to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. Expenses relating to specific participant transactions (i.e., distribution requests) could be charged directly against the appropriate participant's account. Investment related expenses were included in net appreciation/depreciation in fair value of investments.

Note 3. Certification of Investments

The Plan administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, has certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of June 7, 2022 and December 31, 2021.
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period from January 1, 2002 through June 7, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during 2022 and 2021. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

The methods described may have produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

Mutual Funds and Pooled Separate Accounts

Investments in mutual funds and pooled separate accounts were based on quoted market prices for the identical security in an active market.

Note 5. Party-In-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments were managed by Principal. These investments and transactions in these investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6. Income Tax Status

The Plan operated under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Principal Life Insurance Company. This prototype plan document has been filed with the appropriate agency. The Plan had not obtained or requested a determination letter. However, the Plan Administrator believed that the Plan was designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Note 7. Subsequent Events

The Plan Administrator has evaluated subsequent events through March 30, 2023, the date the financial statements were available to be issued.
