Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of M. Campbell & Company, Inc., Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of September 30, 2022 (liquidation basis) and December 31, 2021 (ongoing), and the related statement of changes in net assets available for benefit (liquidation basis) for the nine months (liquidation basis) and year then ended (ongoing basis), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of M. Campbell & Company, Inc., Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the nine months and year ended September 30, 2022 and December 31, 2021, respectively, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of M. Campbell & Company, Inc., Profit Sharing Plan, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 6 to the financial statements, the governing body of the Plan approved a plan liquidation, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NOTE 1 – DESCRIPTION OF THE PLAN:

The following description of the M. Campbell & Company, Inc., Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan's agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan, originally effective November 1, 1991. The Plan has been amended throughout the years to comply with tax legislation with the most recent amendment being effective January 1, 2020. The Plan excludes nonresident aliens and employees covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and all subsequent statutory revisions thereto.

Eligibility – Employees who have attained the age of 18 and have completed one year of service (1,000 hours) are eligible to participate for salary deferral, matching contribution, and profit-sharing purposes. Plan entry occurs on the first day of each calendar month during the Plan year or on the day immediately following the completion of the eligibility requirements.

Contributions – The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

M. Campbell & Company, Inc. (the Company), may, at its discretion, elect to make a qualified matching contribution to the Plan for those who participate in salary deferrals. The Company may also decide to make a discretionary employer contribution to eligible employees. The Company's matching contribution as a percentage of eligible participant contributions was 0.00% for the nine months ended September 30, 2022, and 24.68% for the year ended December 31, 2021. The Company did not make a discretionary employer contribution (profit sharing) for 2022 or 2021.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts – Each participant's account is credited with the participant's contribution, the Company's matching and employer contribution, and an allocation of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 – DESCRIPTION OF THE PLAN (continued):

Vesting – Participants are immediately vested in their salary deferral contributions, rollover contributions, plus actual earnings thereon. Vesting in the Company matching and employer contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service. An employee earns a year of service for vesting purposes upon completing 1,000 actual working hours during the Plan year. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability or upon plan termination.

Notes receivable from participants – Participants may borrow up to the lesser of \$50,000 or one-half the vested balance in their account subject to approval. The minimum loan amount is \$1,000. The \$50,000 maximum loan amount is reduced by the participant's highest outstanding loan balance in the previous twelve months over the existing loan balance, if any, on the date a new loan is made. In determining the availability of a Plan loan, the participant may only have two loans outstanding at any time. Loans bear an interest rate based on prime rate plus 1% and are secured by the account balance of the participant. Repayments are generally made over a period not to exceed five years; however, loans used to acquire a principal residence may be repaid over a reasonable period up to ten years. Principal and interest are paid ratably through payroll deductions.

Benefit payments – Upon termination of service, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution. The availability of a distribution will depend on the amount of the participant's vested balance. The Plan allows for in-service distributions if a participant reaches age 59½ or normal retirement age, incurs a hardship subject to Plan provisions, or is in certain qualified active military duty. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the participant may elect to receive the vested balance in cash or be rolled into an individual retirement account in the participant's name.

Forfeited accounts – At the Company's discretion, forfeited non-vested account funds may be used to reduce administrative expenses or allocated as additional employer contributions or reduction of future Company contributions. Forfeiture funds of \$0 and \$4,765 were used to reduce employer contributions for the nine months and year ended September 30, 2022 and December 31, 2021, respectively. Forfeiture funds of \$1,299 and \$0 were used to reduce administrative expenses for the nine months and year ended September 30, 2022 and December 31, 2021, respectively. The remaining forfeited account balances were \$0 and \$933 as of September 30, 2022 and December 31, 2021, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Investment valuation and income recognition – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of September 30, 2022 or December 31, 2021. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Excess contributions payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. Corrective distributions for excess contributions for 2021 were distributed to the applicable participants by March 15, 2022. There were no corrective distributions for the nine months ended September 30, 2022. All applicable forms were filed with the IRS.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE:

Information contained in the financial statements and supplemental schedule that was certified to be complete and accurate by the trustee, Capital Bank and Trust Company, is as follows:

- Investment amounts included in the statements of net assets available for benefits (liquidation basis) as of September 30, 2022 and December 31, 2021.
- Net appreciation in the fair value of investments, interest, and dividend amounts included in the statement of changes in net assets available for benefits (liquidation basis) for the nine months and year ended September 30, 2022 and December 31, 2021, respectively.

NOTE 4 – FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"> • quoted prices for similar assets or liabilities in active markets; • quoted prices for identical or similar assets or liabilities in inactive markets; • inputs other than quoted prices that are observable for the asset or liability; • inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 4 – FAIR VALUE MEASUREMENTS (continued):

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2022 or December 31, 2021:

Mutual funds (Level 1): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market accounts (Level 1): Interest bearing accounts valued at fair market cash value.

NOTE 5 – RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

In early 2020, an outbreak of the novel strain of coronavirus (COVID-19) emerged globally. As a result, there have been mandates from federal, state, and local authorities resulting in an overall decline in economic activity. The ultimate impact of COVID-19 on the financial performance of the Plan’s investments is not reasonably estimable at this time.

NOTE 6 – PLAN TERMINATION:

The Company has approved the termination of the Plan on September 30, 2022. Subsequent to December 31, 2021, no loan payments or new loans were allowed into or out of the Plan. In accordance with accounting principles generally accepted in the United States of America, the Plan is reporting on the liquidation basis. The Plan expects to pay all liabilities and then distribute all participant accounts by September 30, 2022.

NOTE 7 – PLAN TAX STATUS:

The Plan was developed through a volume submitter template. The IRS has determined and informed the submitter by a letter dated March 31, 2014, that the Plan's template and the related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of September 30, 2022 and December 31, 2021, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Certain plan investments are managed by Capital Group's American Funds, a division of Capital Bank and Trust Company. Capital Bank and Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation or depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. As discussed in Note 2, fees paid directly by the Company related to the Plan's operations are not included in these financial statements.

For the nine months and year ended September 30, 2022 and December 31, 2021, respectively, fees paid by the Plan were \$33,186 and \$31,619, respectively, to Capital Bank and Trust Company's subsidiary, American Funds, for investment services.
