It is necessary that I state that all the tax filing have been performed by a third party in the last decade or so. This third-party firm that was hired to complete all the necessary forms and documentation for a successful and completed tax forms failed.

Due to the lack of my expertise in this field, the third party's work was unsupervised. Therefore, the 5500-SF Form was absent nor submitted in a timely fashion. No one has notified me from the trust fund company either, that the trust fund forms were the client's responsibility and not the company's that manages the funds.

Unfortunately, over the last year there has been many other conflicts with the third-party accounting firm and many issues lead to an unresolved situation. Therefore, I no longer associate with, and all contact has been lost with that third party accounting firm. Due to the circumstances I, myself was just ill informed regarding which party is responsible for the filing of this form.

Hopefully this letter will be taken into consideration for a penalty waiver.
