Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mandarin Holdings LP 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 13, 2022 (in liquidation), and December 31, 2021, the related statement of changes in net assets available for benefits for the period from January 1, 2022 through October 13, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 13, 2022, and December 31, 2021, and for the period from January 1, 2022 through October 13, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Termination and Liquidation

As discussed in Note 1 to the financial statements, the Plan's sponsor voted on March 7, 2022, to terminate the Plan effective March 10, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control–related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of Mandarin Holdings LP 401(k) Plan (the Plan) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan was a salary deferral 401(k) defined contribution savings plan established on January 1, 2019, to provide retirement income and other benefits to eligible employees of Mandarin Holdings LP (the Employer, the Plan's sponsor, or the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Employees were eligible to participate in the Plan after attaining age 21 and completing one year of service. A year of eligible service was a 12-month period in which an employee had completed 1,000 or more hours of service. An employee will become a participant in the Plan on the first day of the month coinciding with or following satisfaction of the Plan's eligibility requirements.

The Plan's Trustees and Plan Administrator were responsible for oversight of the Plan. The Plan's Investment Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance, and reported to the Trustees.

Plan termination: On March 7, 2022, the Plan's sponsor voted to terminate the Plan, effective March 10, 2022. No new participants were eligible to participate in the Plan after this date. All participants became fully vested in their benefits upon termination of the Plan.

Contributions: Participants could make voluntary contributions up to the maximum amount permitted by law. The deferral percentage elected could be changed by the participant at any time. The Plan allowed participants to allocate contributions between pretax and Roth deferrals. The Plan also allowed participants age 50 and older to make catch-up contributions.

Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Each year, the Employer could make a discretionary matching contribution. Effective during the last pay period in 2021, the Employer contributed 25% of the first 4% of compensation that a participant contributed to the Plan. The Plan also allowed for discretionary employer contributions. All contributions to the Plan ceased as of March 10, 2022. There were no discretionary employer contributions in 2021 or 2022. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Vesting: As a result of the decision to terminate the Plan during 2022, all participants became fully vested in their account balance. Prior to the Plan termination, participants were immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Employer contributions portion of their accounts plus earnings thereon was based on years of continuous service. A participant was 100% vested after three years of credited service, upon death or permanent disability during the term of employment, upon Plan termination, or upon retirement.

Participant accounts: Each participant's account was credited with the participant's contributions; employer contributions, if any; allocations of Plan investment earnings; and charged with an allocation of administrative expenses that were paid from the Plan and Plan investment losses. Allocations were based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Note 1. Description of the Plan (Continued)

Payment of benefits: Prior to the Plan termination, the participants were able to receive the value of the vested interest in their account in the form of a lump-sum distribution or installments upon termination of service, death, permanent disability or retirement (age 65). If the participant's account balance was between \$1,000 and \$5,000 and the participant did not consent to a distribution of their vested account balance, the participants vested benefit automatically was rolled over to an individual retirement account selected by the Plan Administrator. If the participant's account balance was less than \$1,000, the Plan Administrator authorized the lump-sum benefit payment without the participant's consent. Participants were able to receive in-service distributions upon attaining age 59½ and also hardship distributions, subject to Plan provisions.

Notes receivable from participants: Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants were only permitted to have two outstanding loans at one time. Note terms were up to five years, or longer if used for the purchase of a principal residence. The notes were secured by the vested balance in the participant's account and had interest at the prime rate plus 2%. There were no outstanding notes receivable as of October 13, 2022, or December 31, 2022.

Forfeited accounts: Prior to the Plan termination, upon termination of service, any nonvested portion of the participant's account balance would be forfeited. Forfeited nonvested accounts would be used to pay Plan expenses or fund future Employer contributions. There were no forfeitures for the period from January 1, 2022 through October 13, 2022.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: Due to the decision to terminate the Plan during 2022, management determined that liquidation of the Plan is imminent, and the financial statements for 2022 have been prepared using the liquidation basis of accounting. The 2021 financial statements were prepared as a going concern on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: There are no investments remaining at October 13, 2022. All investments on the 2021 Statement of Net Assets Available for Benefits are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a settlement-date basis. Interest income and dividends are recorded on the liquidation basis. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Note 2. Summary of Significant Accounting Policies (Continued)

Notes receivable from participants: Notes receivable from participants were measured at their unpaid principal balances plus any accrued interest. Interest is recorded on the liquidation basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses had been recorded as of October 13, 2022.

Administrative expenses: Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included as an offset to net appreciation in fair value of investments.

Benefit payments: Benefit payments were recorded when paid. Distributions pursuant to the Plan termination were paid at the participants' election by (a) lump-sum cash distribution, (b) periodic cash distribution, or (c) rollover distribution to an eligible retirement plan. Distributions of the participant accounts were made in either a lump-sum payment, periodic payments, or through a rollover during the period from January 1, 2022 through October 13, 2022.

Risks and uncertainties: The Plan provided for investment in a variety of investment securities. In general, investments were exposed to various risks, such as interest rate, credit and overall market volatility risk.

Subsequent events: In preparing the financial statements, management has evaluated subsequent events through April 4, 2023, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by the Plan Custodian

The following is a summary of the Plan's asset information as of October 13, 2022, and December 31, 2021, included throughout the Plan's financial statements that was prepared or derived from information provided by Voya Retirement Insurance and Annuity Company, the custodian, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that the information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements related to the following assets:

Note 4. Fair Value Measurements

Accounting standards establish the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Input to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2021.

Pooled separate accounts: Pooled separate accounts were valued at the net asset value (NAV) of shares held by the Plan at year-end, which is based on quoted prices for similar assets traded in active markets. The NAV, as provided by the custodian, was used as the practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

In accordance with Financial Accounting Standards Board Accounting Standards Codification Subtopic 820-10, the pooled separate accounts held by the Plan are not classified in the fair value hierarchy table that prioritizes the inputs to valuation techniques used to measure fair value because they are measured at NAV per share as a practical expedient.

Note 5. Guaranteed Investment Contract

The Plan had a guaranteed investment contract, the Voya Fixed Account, with Voya Retirement Insurance and Annuity Company (Voya). Voya maintained the contributions governed by this contract in a general account that was managed by Voya. The guaranteed investment contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value as of December 31, 2021. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by Voya, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Voya may impose restrictions on the ability to move Plan assets into or out of this investment option or among investment options in general under the contract. Under the guaranteed investment contract, Voya was contractually obligated to repay the Plan the principal and a specified interest rate. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on an annual basis for resetting and was 1% at the date of liquidation. There were no withdrawal charges assessed upon liquidation of the fund and termination of the contract.

Note 6. Tax Status

The Plan has adopted a volume submitter plan sponsored by TSC Inc. The volume submitter plan provider has received an advisory letter from the Internal Revenue Service as to the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. The Plan has been amended since the volume submitter plan received the advisory letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party Transactions and Party-in-Interest Transactions

The investments were managed by Voya Retirement Insurance and Annuity Company, the custodian as defined by the Plan, and the Plan and Employer pay certain ongoing administrative expenses associated with the Plan to Voya; therefore, these transactions qualify as party-in-interest transactions.
