Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Harrington Corporation 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 16, 2022 (in liquidation) and December 31, 2021 (ongoing), and the related statement of changes in net assets in liquidation available for benefits for the period ended August 16, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Harrington Corporation 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 16, 2022 and December 31, 2021 and for the period ended August 16, 2022, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by qualified institutions agree to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Harrington Corporation 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 1, the governing body of The Harrington Corporation 401(k) Profit Sharing Plan approved a plan of liquidation on January 8, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of The Harrington Corporation 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS
August 16, 2022

Note 1. Plan Description

The following description of The Harrington Corporation 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was a defined contribution plan covering substantially all employees of The Harrington Corporation (the “Company”). The Plan provided for dual eligibility with respect to participant deferrals and employer matching contributions and had implemented an auto enrollment feature. Eligible employees were automatically enrolled and deferrals of 6% of eligible compensation commenced at the next quarterly entry date. These automatic deferrals were set to increase by 1% each year, to a maximum of 10%. Employees could sign a waiver to decline participation in the Plan or participants could select an alternative deferral amount.

The Harrington Corporation entered into a stock purchase agreement on January 8, 2022 where the shares of the Company were sold. As a result of the sale, the Company elected to terminate the Plan effective April 6, 2022. See Note 6 for additional information regarding Plan termination.

Contributions

Prior to April 6, 2022, participants could contribute from 1% up to the maximum allowable under *Internal Revenue Code (IRC)*, as defined in the Plan. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company could contribute to the Plan in the form of matching or additional discretionary contributions at the option of the Board of Directors. For the period ended August 16, 2022 and year ended December 31, 2021, the Company matched 100% of participant deferrals, up to a maximum of 5% of eligible compensation. Participants directed the investment of contributions into various investment options offered by the Plan. Contributions were subject to certain limitations.

Effective April 6, 2022, the Plan was terminated and no additional contributions were made.

Participant accounts

Prior to Plan termination, each participant’s account was credited with the participant’s contribution and allocations of the Company’s matching and any additional discretionary contributions, plan earnings, and charged with an allocation of administrative expenses. Forfeited non-vested accounts could be used to pay administrative expenses or reduce employer contributions.

Note 1. Plan Description (Continued)

Vesting

Prior to Plan termination, participants were immediately vested in their contributions plus earnings thereon. Vesting in the Company's matching and additional discretionary contribution portions of their accounts plus earnings thereon was based on years of continuous service. A participant was 100% vested in Company matching and additional discretionary contributions after six years of credited service. Due to Plan termination, all participants were 100% vested effective April 6, 2022.

Notes from participants

Prior to Plan termination, participants could borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms ranged from one to five years. Notes were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined by the Loan Administrator. Principal and interest were paid ratably through payroll deductions.

Payment of benefits

Prior to Plan termination, upon termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive a lump-sum distribution or installment payments equal to the value of the participant's vested interest in his or her account.

Plan termination distributions were made as single lump-sums, as defined.

Administrative costs

Plan administrative expenses were paid by the Company or the Plan on a discretionary basis.

Forfeitures

Forfeited non-vested accounts could be used to pay administrative expenses or reduce employer contributions, and any remaining forfeitures allocated, as defined. At December 31, 2021, forfeited non-vested accounts totaled \$4. During the period ended August 16, 2022, forfeited non-vested accounts totaling \$2,720 were used to reduce employer contributions, as defined by the Plan.

Note 2. Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting used to determine the amounts at which investments are stated, from ongoing Plan basis to the liquidation basis for periods after December 31, 2021. See Note 6 for discussion of Plan termination.

Note 2. Significant Accounting Policies (Continued)

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of investments and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Payment of benefits

Benefit payments are recorded when paid.

Subsequent events

Subsequent events have been evaluated through April 10, 2023, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The Plan's investments at December 31, 2021, are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 3. Fair Value Measurements (Continued)

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Level 1 Fair Value Measurements

The fair values of pooled separate accounts, stable value fund, and collective investment trusts are based on quoted net asset values of the shares held by the Plan at December 31, 2021.

Note 4. Investment Contracts

At December 31, 2021 and during the period ended August 16, 2022 prior to Plan termination, the Plan had investment contracts with Principal Trust Company (Principal). Principal maintained the contributions in collective investment funds and pooled separate accounts.

The objective of the collective investment funds was to provide total return consisting of long-term growth of capital and current income, consistent with the investment strategy of an investor who expects to retire on the specified target date. The percentage of contributions allocated to the collective investment funds was determined by the participants.

The Plan also had investments in the Principal Global Investors Trust Company Principal Stable Value Fund. Included in this fund were certain guaranteed investment contracts and synthetic investment contracts. These contracts were considered to be benefit-responsive and were presented at fair value. The average yields for this fund were as follows:

The objective of the Principal Stable Value Fund was to provide diversification of investments consistent with a stable fixed-income methodology and the careful and prudent assumption of investment risk providing for preservation of capital, stability and predictability of returns, liquidity to pay plan benefits and high credit quality. The percentage of contributions allocated to the stable value fund was determined by the participants.

Note 5. Related Party Transactions

Prior to Plan termination, officers or employees of the Company performed certain administrative functions. These employees were also Plan participants. No such officer or employee received compensation from the Plan.

Plan participants directed their investments in funds issued and managed by the Plan Custodian. Investments in funds issued by the Custodian were considered related party transactions. Fees paid to the Plan Custodian by the Plan for investment management and administrative services were \$47,215 for the period ended August 16, 2022.

Note 6. Plan Termination

In January 2022, Plan management elected to terminate the Plan effective April 6, 2022. Effective April 6, 2022 (Plan freeze date), the Company determined no new participants should enter the Plan and there would be no further contributions. As of August 16, 2022, the Plan's Custodian distributed all assets of the Plan to participants and beneficiaries.

Note 7. Tax Status

The Plan was adopted under a prototype plan arrangement with Principal Life Insurance Company. Principal Life Insurance Company received a letter from the Internal Revenue Service dated June 30, 2020, stating that its master prototype plan is designed in accordance with applicable sections of the *IRC*. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of August 16, 2022 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
