As a result, the Plan has changed its basis of accounting from the ongoing basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Plan Description

The following description of The Bill Gatton Family of Dealerships Profit Sharing/401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all employees of Customer 1 One, Inc., Bill Gatton Imports, Inc., G.W. Automotive, Inc., and C. Gatton, Inc., (herein collectively referred to as the "Company") who had attained age 21 and completed one year of service. Excluded classes of employees included independent contractors. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective March 2021, Ascensus Trust Company became the Trustee, Ascensus, LLC became the recordkeeper, and Resources Investment Advisors, LLC became the investment advisor as part of the transition from BB&T as trustee/recordkeeper and ProNvest, Inc. as the investment advisor.

The Plan was restated on May 1, 2021. There were no significant changes to Plan provisions.

As of June 24, 2022, all of the Plan's assets had been distributed. See Note 8 for additional information regarding Plan termination.

Contributions

Each year participants could contribute up to 100% of annual compensation as defined in the Plan, up to the maximum allowed by the *Internal Revenue Code (IRC)*. Participants who had attained age 50 before the Plan year-end were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Company could make a discretionary matching contribution equal to a uniform percentage or dollar amount of elective deferrals. Additional amounts could be contributed at the option of the Company's Board of Directors. Contributions were subject to certain limitations.

Effective December 31, 2021, the Plan was frozen and no contributions were made in 2022 except for one corrective employer contribution.

Participant accounts

Each participant's account was credited with the participant's contributions, the Company's discretionary contributions, if any, and an allocation of Plan earnings, and was charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus earnings thereon was based on years of continuous service. A participant was 100% vested after three years of credited service. Participants became 100% vested if actively employed on or after their normal retirement age, upon death, or total and permanent disability prior to retirement. Due to Plan termination, all participants were 100% vested.

Payment of benefits

Benefits are recorded when paid.

Hardship withdrawals

Hardship withdrawals are permitted pursuant to IRS regulations.

Administrative costs

Plan fees and administrative expenses are paid by the Plan.

Forfeited accounts

At June 24, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$1,624, respectively. These accounts were allocated to remaining active participants or used to reduce contributions.

Note 2. Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting used to determine the amounts at which investments are stated, from the ongoing Plan basis to the liquidation basis for periods after December 31, 2021. See Note 8 for discussion of Plan termination.

Note 2. Significant Accounting Policies (Continued)

Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 3. Certified Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The plan administrator instructed the Plan's independent auditors not to perform any procedures with respect to the following information that Ascensus as agent of Ascensus Trust Company, trustee, has certified to the completeness and accuracy of: investments reflected on the accompanying Statements of Net Assets Available for Benefits as of June 24, 2022 (in liquidation) and December 31, 2021 (ongoing) and the related investment activity reflected in the Statement of Changes in Net Assets in Liquidation Available for Benefits for the period January 1, 2022 to June 24, 2022.

Note 4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Authoritative guidance issued by the Financial Accounting Standards Board established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Level 1 fair value measurements

The fair value of the mutual funds are based on quoted net asset values of the shares held by the Plan at year-end.

Level 2 fair value measurements

The fair value of the common collective trust is based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e. interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The collective trust invests in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While the underlying asset values are quoted prices, the net asset value (NAV) of a unit in these funds is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

Note 5. Investment Contract

The Morley Stable Value Fund (the “Fund”) commenced operations in January 1993, and is an investment fund offered by the Union Bond & Trust Company. Effective March 1, 2016, Union Bond & Trust Company changed its name to Principal Global Investors Trust Company. The trustee is an Oregon Trust organization providing fiduciary services, primarily administration of collective trust funds. The Trust is designed for retirement trusts exempt from federal income tax under Section 501(a) of the Internal Revenue Code of 1986, as amended. The Fund is governed by the Trust Agreement for The Morley Stable Value Fund (“Trust Agreement”) as amended May 1, 2012.

The objective of the Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit-responsive payments. The Fund seeks to achieve this objective by investing primarily in a variety of high quality stable value investment contracts (the performance of which may be predicated on underlying fixed income securities), as well as cash and cash equivalents. It is intended that the Fund’s stable value investment contracts will maintain a minimum weighted average credit quality rating of A or better. The underlying fixed income securities must be rated investment grade and meet issuer diversification guidelines. The duration of the Fund’s investments will not exceed 4 years. The Fund is typically appropriate for investors who desire low volatility, stable principal value, and returns commensurate with a capital preservation objective for a component of their retirement savings. The Fund is designed for long-term retirement investing.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the Fund, plus earnings, less administrative expenses and less participant transactions at contract value.

Note 6. Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Ascensus was the trustee and recordkeeper for the period ended June 24, 2022, and therefore, these transactions qualify as party-in-interest transactions. Fees to Ascensus totaled \$30,182 for trustee and recordkeeping services. Settlor fees related to the Plan are paid by the plan sponsor when incurred.

Note 7. Tax Status

The prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service states the Plan, as then designed, was in compliance with applicable requirements of the *Internal Revenue Code (IRC)*. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC* and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 24, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 8. Plan Termination

In January 2022 the governing body approved a plan of liquidation and determined that no new participants shall enter the Plan subsequent to December 31, 2021. There were no contributions to the Plan for time worked subsequent to December 31, 2021. All participants are 100% vested. As of June 24, 2022, all of the Plan's assets have been distributed to participants and beneficiaries.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
