### **Note 1. Plan Description**

The Coldwater Machine Company, LLC 401(k) Plan (the "Plan") is a defined contribution plan sponsored by Lincoln Electric Automation, Inc. (the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, (ERISA). The provisions of the Plan are included in the official Plan document which legally governs the operations of the Plan and is available for more detailed information. Effective January 1, 2020, the Plan was amended to freeze eligibility and contributions for all employees.

#### Participant Accounts

Each participant's account is credited with Plan earnings and is charged with an allocation of expenses. Allocations of the Plan earnings and expenses are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Effective March 1, 2021, all participants became fully vested in their accounts.

#### Forfeitures and Unallocated Funds

Participants who terminate employment prior to becoming fully vested must forfeit a portion of their Employer contributions. These forfeitures are used to pay Plan expenses. At June 15, 2022 and December 31, 2021, forfeitures totaling approximately \$0 and \$21,000, were available to pay Plan expenses. During 2022, no forfeitures were used to pay Plan expenses and forfeitures of approximately \$21,000 were reallocated to participants.

Additionally, the Plan has unallocated funds of approximately \$0 and \$134,000 at June 15, 2022 and December 31, 2021, respectively, available to pay Plan expenses. During 2022, the unallocated funds were reallocated to participants.

#### Notes Receivable from Participants

The Plan allows participants to borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of employee contributions and rollovers. Loans are typically for terms up to 5 years, but may be for a longer period if the purpose of the loan is for a principal residence. The loans are secured by the balance in the participant's account and bear a reasonable fixed rate of interest of prime plus two percent (determined at origination). The balance of a loan becomes due upon termination of employment of the participant.

#### Benefit Payments

Benefit payments are payable as a single lump-sum payment or in installments. The full value of a participant's account is payable upon retirement, death or disability. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum payment.

### **Note 2. Significant Accounting Policies**

#### Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's custodian determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 15, 2022 or December 31, 2021. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced to zero and a benefit payment is recorded.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### Payment of Benefits

Payment of benefits to participants are recorded when paid.

### **Note 2. Significant Accounting Policies (Continued)**

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

#### Subsequent Events

The Plan administrator has evaluated events and transactions for possible recognition or disclosure through April 12, 2023, the date the financial statements were available to be issued.

### **Note 3. Information Certified by the Plan's Custodian**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the custodian, Great-West Trust Company, LLC, and was not subjected to any auditing procedures performed by the independent public accountants.

- a. Total investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits.
- b. Total investment income, as shown in the accompanying statement of changes in net assets available for benefits, including interest and dividend income, net realized and unrealized depreciation in fair value of investments and interest income on notes receivable from participants.

### **Note 4. Fair Value Measurements**

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.

Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at June 15, 2022 and December 31, 2021.

*Mutual funds:* Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5. Investment Contract with Insurance Company

The Plan held a traditional investment contract with Great-West Life & Annuity Insurance Company ("Great-West"). The contract met the fully benefit-responsive investment contract criteria and was therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

### **Note 5. Investment Contract with Insurance Company (Continued)**

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, (6) and early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

Discontinuance of the contract would result in certain surrender charges as defined by the contract. Guaranteed crediting rates are based on a formula agreed upon with the insurance company. Such interest rates are reviewed quarterly for resetting. The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Principal and interest are guaranteed; however, there is no stated maturity date.

### **Note 6. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments at December 31, 2021, are shares of an investment contract managed by the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participant transactions are also party-in interest transactions. Certain administration expenses are paid by the Employer on behalf of the Plan. The Employer also provides certain administrative services at no cost to the Plan.

### **Note 7. Income Tax Status**

On November 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not been amended since receiving the opinion letter. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 15, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.
