Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mason Companies Retirement and Savings Plan for the Collectively Bargained Employees, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of period ended June 30, 2022 (in liquidation) and year ended December 31, 2021, and the related statement of changes in net assets available for benefits for the period ended June 30, 2022 (in liquidation) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mason Companies Retirement and Savings Plan for the Collectively Bargained Employees's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Mason Companies Retirement and Savings Plan for the Collectively Bargained Employees and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Mason Companies Retirement and Savings Plan for the Collectively Bargained Employees's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 7 to the financial statements, the Employee Benefit Plan & Compensation Committee of Mason Companies approved a plan of liquidation on April 26, 2022, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the on-going basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Mason Companies Retirement and Savings Plan for the Collectively Bargained Employees's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Mason Companies Retirement and Savings Plan for the Collectively Bargained Employees's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Mason Companies Retirement and Savings Plan for the Collectively Bargained Employees (the "Plan") provides only general information. The description is for the time period through the transfer of all assets to the successor Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Mason Companies, Inc. (the "Company") who are age 18 or older and covered by a collective bargaining agreement. Employees must have one year of service and be employed on the last day of the Plan year to be eligible for the Company contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan adopted certain provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act that was signed into law on March 27, 2020, which were immediately available, for coronavirus-related distributions and waiver of required minimum distributions that are due during 2020.

Effective July 1, 2022, the Company merged the Mason Companies Retirement and Savings Plan for the Collectively Bargained Employees (the "Union Plan") into the Mason Companies Retirement and Savings Plan (the "Non-Union Plan"). This amendment resulted in a short plan year beginning January 1, 2022, and ending June 30, 2022.

Contributions

Each year, participants may contribute up to 50% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a stable value collective trust fund.

Company contributions are based on a percentage of compensation as defined in the collective bargaining agreement. During the period ended June 30, 2022, the Company did not make any contributions to the Plan. The Company may not make a contribution to the Plan for any Plan year to the extent the contribution would exceed the participant's maximum permissible amount.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully and immediately vested in all contributions plus actual earnings (losses) thereon.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum payment or installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participants with accounts under \$1,000 upon termination will receive a lump sum payment if a direct rollover to another plan or individual retirement account is not elected. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Transfers To/From Noncollectively Bargained Plan

The Plan transfers participant balances to the Mason Companies Retirement and Savings Plan (the "other Plan") sponsored by the Company when the participant's job status changes from collectively bargained to noncollectively bargained or vice versa (also reference General Policy).

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

As discussed in Notes 1 and 7, the Plan was terminated effective June 30, 2022. In accordance with accounting principles generally accepted in the United States of America (GAAP), the Plan changed its basis of accounting from the ongoing plan basis to the liquidation basis. The change to the liquidation basis had no material impact on the accompanying financial statements.

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investment in the Mason Companies Retirement and Savings Master Trust (the "Master Trust") is presented at fair value, which has been determined based on the fair value of the underlying investments of the Master Trust. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Trustee, investment advisory, Plan administration, and audit expenses are paid directly from the Plan's assets.

Subsequent Events

The Plan has evaluated subsequent events through April 10, 2023, which is the date the financial statements were available to be issued.

Note 3: Interest in Master Trust

The Plan's investment is in the Mason Companies Retirement and Savings Plan Master Trust, which is commingled with the assets of the Mason Companies Retirement and Savings Plan. Each participating plan has an undivided interest in the Master Trust. The Plan's allocated share of the Master Trust's net assets and investment activities is based upon the total of each participant's share of the Master Trust. The percentage of the Plan's assets to the total assets of the Master Trust is 0.00% and 16.28% as of period ended June 30, 2022 and year ended December 31, 2021, respectively.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Fair Value Measurements (Continued)

Stable value collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities' liquidations will be carried out in an orderly business manner.

Note 5: Related-Party Transactions and Party-in-Interest Transactions

Matrix Trust Company is the Trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee amounted to \$4,914 for the period ended June 30, 2022.

Francis Investment Council is the investment advisor for the Plan. For the period ended June 30, 2022, fees paid by the Plan to Francis Investment Council amounted to \$8,130.

Milliman, U.S.A. is the Plan's record keeper. A portion of Milliman, U.S.A.'s fees are paid indirectly from the Plan's investments in the form of revenue sharing. The remaining fees are paid directly from the Plan. The indirect compensation received is included in net appreciation in the fair value of investments. The direct compensation received was \$4,495 for the period ended June 30, 2022.

Note 6: Tax Status

The Company adopted a volume submitter plan document with an Internal Revenue Service (IRS) opinion letter, which states the Plan and related Trust were in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan and related Trust were designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Effective July 1, 2022, the Company merged the Mason Companies Retirement and Savings Plan for the Collectively Bargained Employees (the "Union Plan") into the Mason Companies Retirement and Savings Plan (the "Non-Union Plan"). As part of the merger, all Plan assets of the Union Plan were transferred into the Non-Union Plan, and the Union Plan and Master Trust were terminated.

Note 8: Information Prepared and Certified by Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments held at June 30, 2022 and December 31, 2021, and net appreciation (depreciation) in fair value of investments, interest and dividends for the period ended June 30, 2022, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Matrix Trust Company, the Trustee of the Plan.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
