Independent Auditors' Report

Our opinion is not modified with respect to that matter.

NOTE 1: DESCRIPTION OF PLAN

The following description of the GrayHawk Home Care 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Plan Termination - Management of GrayHawk Holdings, LLC terminated the Plan effective March 31, 2022. Effective with the Plan's termination, all participants became fully vested in their account balances, and all employees and employer contributions to the Plan ceased, other than contributions made that had been accrued on behalf of participants in the Plan, any corrective contributions, repayment of loan balances to the extent permitted by the Plan, or contributions that were based on compensation earned through the termination date. All account balances were distributed in accordance with the terms of the Plan, and any remaining assets were distributed on June 29, 2022.

General - Prior to Plan termination, the Plan, established and effective January 1, 2020, was a defined contribution plan covering all eligible employees of GrayHawk Holdings, LLC, the primary employer, and GrayHawk Home Care, LLC, a participating employer, (collectively the "Company"), who were age 18 or older and had completed at least 500 hours of service during the first six months of employment or the completion of one year of service and were not collectively bargained employees, nonresident aliens who received no compensation from the Company which constitutes U.S. source income, leased employees, or employees of an employer acquired as part of an Internal Revenue Code (IRC) Section 410(b)(6)(c) transaction. Entry dates occurred on the first day of each month after attainment of the eligibility requirements. The Plan was subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Contributions - Prior to Plan termination, each year, participants could contribute up to 100% of pre-tax, annual, eligible compensation, as defined by the Plan. Participants could also elect to contribute after-tax Roth deferrals. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Pre-tax and Roth salary deferral provisions were effective as of July 1, 2020. Participants could also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Company could make discretionary employer matching and nonelective contributions. Employees must have been employed on the last day of the Plan year to be eligible to receive discretionary employer matching contributions. During the year ended June 29, 2022, the discretionary, employer-match formula was 25% of deferrals up to 8% of eligible compensation. There were no additional discretionary employer contributions for the year ended June 29, 2022. Contributions are subject to certain Code limitations.

Participant Accounts - Prior to Plan termination, each participant's account was credited with the participant's contribution and allocations of the Company's contribution and plan earnings, as well as charged with an allocation of administrative expenses that were paid by the Plan. Certain administrative expenses were paid from the investment alternatives held by the participants. Allocations were based on participant earnings, account balances, or specific

Participant Accounts - Continued - participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting - Prior to Plan termination, participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon was based on years of continuous service. A participant was 100% vested after one year of service. As noted in the Plan termination section, effective with the Plan's termination date on March 31, 2022, participants became fully vested in their accounts.

Notes Receivable from Participants - Prior to Plan termination, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance during the prior 12-month period or 50% of the participant's vested account. Loans had to be repaid within a five-year period, or if the loan was taken for the purchase of a participant's principal residence, could not exceed 15 years. The loans were secured by the balance in the participant's account and accrued interest at the prime rate plus 1%. Principal and interest were paid ratably through payroll deductions. Only one loan could be outstanding at a time.

Payment of Benefits - Prior to Plan termination, upon termination of service due to death, disability, retirement (age 65), or severance of employment, a participant could elect to receive a lump sum benefit as described in the Plan. In certain instances, a terminated participant could elect to delay withdrawal until a future date. In addition, if permitted by the Company, a participant could take a partial distribution of a portion of their vested account upon termination of employment. If a terminated participant's vested account balance was \$5,000 or less, his or her vested account would be paid in a single lump sum. For any distribution exceeding \$1,000, but not in excess of \$5,000, the participant would be given the option to elect to have such distribution paid in a single lump sum or rolled to another eligible retirement plan or an IRA of his or her choice in a direct rollover. If no option was selected, the plan administrator would make such distribution in a direct rollover to an individual retirement plan designated by the plan administrator and would provide notice to the participant when an automatic rollover occurs. A participant age 59½ or older could make in-service withdrawals up to four times during the year. Effective with the Plan's termination, a participant could receive all or any portion of his or her account balance according to the terms of the Plan. All account balances were distributed in accordance with the terms of the Plan, and any remaining assets were distributed on June 29, 2022.

As required under Section 401(a)(9) of the IRC, a participant had to begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (i) the calendar year following the year in which the participant reached age 70½ or 72 if the participant was not 70½ prior to January 1, 2020, or (ii) the calendar year in which the participant retired.

Hardship Withdrawals - Prior to Plan termination, participants could withdraw their salary deferral account balance in the form of a hardship withdrawal to satisfy an immediate and heavy financial need as defined by the Plan. The participant had to exhaust all other assets prior to obtaining a hardship withdrawal.

Forfeited Accounts - As of June 29, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$1, respectively. Prior to Plan termination, forfeiture accounts could be used at the discretion of the Company to reduce future employer contributions or pay administrative expenses. During 2022, \$702 of forfeitures were used to pay administrative expenses and \$322 of forfeitures were used to reduce employer contributions.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - In accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), the Plan has changed its basis of accounting from the ongoing basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements.

Use of Estimates - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received for the sale of an asset or paid for the transfer of a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 29, 2022 and December 31, 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Payments of Benefits - Benefits are recorded when paid.

Administrative Expenses - Prior to Plan termination, certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees associated with participant-initiated transactions were paid by the respective participants' accounts. Some administrative expenses were paid from the annual operating expenses of the Plan's designated investment alternatives, which were netted against the investment earnings of the relevant participant-directed investments.

Subsequent Events - The Plan's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. The Company has evaluated events and transactions through the date of the independent auditors' report, which is the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under Financial Accounting Standards Board Accounting Standards Accounting Standards Codification (FASB ASC) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 3: FAIR VALUE MEASUREMENTS - CONTINUED

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of June 29, 2022 and December 31, 2021.

Pooled Separate Accounts - Valued at the net asset value (NAV) of units held by the Plan at year end based on the market value of its underlying investments. All pooled separate accounts held by the Plan each invest in a single mutual fund. Although the pooled separate accounts are not available in an active market, the NAV of the units are approximated based on the quoted price of the underlying investment that is traded in an active market. The Plan has no unfunded commitments related to any of these investments, and there are no plan-initiated redemption restrictions on these investments. There are no redemption restrictions on participants' holdings in the investments, and the plan can redeem these investments daily.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has not considered normal plan operations such as participant and employer contributions to the Plan or benefits accrued or paid by the Plan for participants as party-in-interest transactions that require separate disclosure. Certain plan investments were units of pooled separate accounts managed by Principal, the custodian and recordkeeper for the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees for professional services rendered by parties in interest were partially absorbed by the plan sponsor. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

NOTE 6: PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances. Any unallocated forfeitures would be allocated to participants' accounts and distributed in such manner as the Company may determine.

NOTE 6: PLAN TERMINATION - CONTINUED

As described in Note 1, management of GrayHawk Holdings, LLC terminated the Plan effective March 31, 2022. Effective with the Plan's termination, all participants became fully vested in their account balances, and all employee and employer contributions to the Plan ceased, other than contributions made that had been accrued on behalf of participants in the Plan, any corrective contributions, repayment of loan balances to the extent permitted by the Plan, or contributions that were based on compensation earned through the termination date. All account balances were distributed in accordance with the terms of the Plan, and any remaining assets were distributed on June 29, 2022.

NOTE 7: TAX STATUS

The underlying Atlantic Pension Services volume submitter profit sharing plan with a cash or deferred arrangement has received an advisory letter from the Internal Revenue Service (IRS) dated September 21, 2017, stating that the form of the Plan is qualified under the IRC Section 401, therefore, the related trust is tax exempt. Although the Plan has been amended since receiving the advisory letter, the Company believes that the Plan is designed, and is being currently operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS or DOL. The Company has analyzed the tax positions taken by the Plan and has concluded that as of June 29, 2022 and December 31, 2021, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan's federal Form 5500 is subject to examination by the IRS and DOL, generally for three years after it is filed.

NOTE 8: RISKS AND UNCERTAINTIES

The Plan invested in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9: COMMITMENTS AND CONTINGENCIES

In the normal course of business, there are various commitments and contingencies outstanding which are not reflected in these financial statements. In the opinion of the Company, the outcome of such events, if any, would not have a material effect on the Plan's financial position or operations.

NOTE 10: PLAN AMENDMENTS

Effective July 1, 2021, the Plan was amended to modify the names of the participating employers to GrayHawk Holdings, LLC as the primary employer and GrayHawk Home Care, LLC as a participating employer.

Additionally, in compliance with the Bipartisan Budget Act of 2018, the Plan was amended effective July 1, 2021, for the following changes to enact legislative changes to provisions related to hardship withdrawals:

- Amounts available for hardships include earnings on elective deferrals.
- Participants are no longer required to obtain all nontaxable loans available under the Plan and other plans maintained by the Company.
- If a participant takes a hardship distribution as permitted under the Plan, the participant is not suspended from making salary deferrals for any period of time after the receipt of the hardship distribution.
