Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Basis of Accounting

As further discussed in Note 6 to the financial statements, the management of Versalus Health Management, LLC, the Plan's sponsor, terminated the Plan as of December 31, 2021. In accordance with accounting principles generally accepted in the United States of America, the Plan is utilizing the liquidation basis in presenting the financial statements. Our opinion is not modified with respect to that matter.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Versalus Health Management, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. In December 2020, Versalus Health Management, LLC (the “Company”) was acquired by CorroHealth, Inc. As a result, effective December 31, 2021, the Plan was terminated and on July 1, 2022, the accounts of all Plan employees were transferred out of the Plan to the CorroHealth, Inc. 401(k) Plan (an existing plan controlled by the acquiring company).

General

The Plan is a defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

All employees (as defined) who have attained the age of 21 and completed one year of service are eligible to participate in the Plan. One year of service is defined by the Plan as 1,000 hours of completed service within the time period following the employee’s commencement of employment.

Contributions

Through the year ending December 31, 2021, eligible participants may elect to make pre-tax contributions, Roth contributions, or both, to the Plan, up to 100% of their annual compensation, as defined, not to exceed the maximum amount allowable under the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offered various pooled separate accounts and one stable value fund as investment options for participants. In addition, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, and it automatically increases each January 1 by 1% up to a maximum deferral of 10%, with their contributions invested in a designated retirement target date fund until changed by the participant. Other than one rollover contribution into the Plan in the amount of \$25,030, there were no participant contributions during the period from January 1, 2022 to July 1, 2022.

Company matching and profit-sharing contributions to the Plan are discretionary. The Company did not make any matching or profit-sharing contributions since the inception of the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account, as defined.

Allocation of Investments

Participants make an election designating the proportion in which contributions are to be allocated among the specific assets, funds or other investments permitted under the Plan (participant-directed investment program). Participants may change their allocations and make transfers among funds.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants

Eligible participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may not have more than one loan outstanding at any one time. The loans are secured by the balance in the participant's accounts and bear interest at a rate which is commensurate with market prevailing rates as determined by the Plan administrator, and must be repaid within five years.

Repayment of loans used to acquire a principal residence of the participant may exceed five years. Principal and interest are paid ratably through payroll deductions and are monitored by the Plan administrator. A loan that is considered in default is reported as a deemed distribution, which may be a taxable event for the participant.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. The Plan provides that the participants' vested amount is a percentage of the portion of their account balance to employer matching and profit-sharing contributions, determined according to the number of years of service for which they are given credit. The Company made no contributions since the inception of the Plan.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant, or their beneficiary, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. See Note 6 for payments of benefits related to the termination and liquidation of the Plan.

Hardship and in-service withdrawals are available pursuant to specific guidelines as set forth in the Plan.

COVID-19

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act (the "CARES Act") was passed by Congress. The CARES Act contains several provisions that temporarily impact retirement savings plans. These provisions include a waiver of required minimum distributions for 2020, a new hardship withdrawal option related to the COVID-19 pandemic, certain increased loan limits and suspension of certain loan repayments. The provisions of the CARES Act were effective and operationalized March 27, 2020 and do not require amending the Plan document. The Plan sponsor has not formally adopted the relief provisions included in the CARES Act.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

Due to the Plan termination effective December 31, 2021, the 2022 and 2021 financial statements of the Plan have been prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. All notes receivable from participants were liquidated during the period from January 1, 2022 to July 1, 2022 in conjunction with the termination of the Plan (see Note 6). No allowance for credit losses was recorded as of December 31, 2021 . If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. There were no deemed distributions for the year ended July 1, 2022.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan, if not paid by the Plan, are paid directly by the Company and excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through April 13, 2023, the date the financial statements were available to be issued. Based upon the evaluation, the Plan administrator did not identify any subsequent events that require adjustments to or disclosure in the financial statements.

NOTE 3 – INVESTMENTS – INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN AS COMPLETE AND ACCURATE

As noted in the independent auditors' report, the Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the following information was certified as complete and accurate by John Hancock Life Insurance Company United States of America ("John Hancock"), the custodian of the Plan, and was not subjected to any auditing procedures performed by the independent auditors, except for comparing such information with the related information included in the financial statements.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The Plan had no investments measured at Level 1, 2, or 3 as of July 1, 2022 and December 31, 2021.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at July 1, 2022 and December 31, 2021.

Pooled Separate Accounts

Pooled separate accounts are valued at fair value based on the underlying assets, which represent the net asset value (“NAV”) of units held by the pooled separate accounts. Each pooled separate account invests mainly in domestic stocks.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the period from January 1, 2022 to July 1, 2022 and for the year ended December 31, 2021, there were no significant transfers in or out of Levels 2 or 3. During the period from January 1, 2022 to July 1, 2022, and the year ended December 31, 2021, the Plan’s investments in pooled separate accounts were measured using the fair value per share practical expedient.

NOTE 5 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan holds investments which are issued and managed by John Hancock. John Hancock is the custodian as defined by the Plan. Fees paid by the Plan to John Hancock for these services were \$3,910 for the period from January 1, 2022 to July 1, 2022. Other fees paid by the Plan included in administrative expenses are \$435 for investment advisory services and \$14,571 for administrative and compliance services for the period from January 1, 2022 to July 1, 2022. These transactions qualify as party-in-interest transactions and are exempt under the prohibited transaction rules.

NOTE 6 – PLAN TERMINATION

Management terminated the Plan effective as of December 31, 2021. Employees with account balances who were terminated prior to December 31, 2021 were directed to withdraw their Plan assets through a distribution or a rollover to a qualified plan. Active employees were directed by the Plan to roll over their Plan assets into the Company's parent plan. The Plan was required to liquidate the assets of the Plan by July 1, 2022. Effective July 1, 2022, all assets of the Plan were liquidated.

NOTE 7 – TAX STATUS

The Plan has not obtained a tax determination letter from the Internal Revenue Service ("IRS"); However, the Plan administrator believes that the Plan and related trust were designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS, or applicable state authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 1, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
