### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Water-Way, Inc. 401k Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### (1) Description of plan

The following description of the Water-Way, Inc. 401k Profit Sharing Plan & Trust (the "Plan"), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan was a defined contribution plan which was adopted on May 15, 2004, to provide retirement benefits for employees of Water-Way, Inc. and related members of a controlled group (collectively, the "Plan Sponsor"). The Plan covered substantially all employees who were twenty-one years of age or older and had completed three months of service ("participants"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In 2022, the Plan Sponsor was acquired and approved a merger of the Plan into the Tiffin Motor Homes, Inc. 401k Profit Sharing Plan (the "Tiffin Plan"). Contributions to the Plan ceased on February 18, 2022, and eligible employees joined the Tiffin Plan effective March 1, 2022. The Plan merged with the Tiffin Plan (the "Merged Plan") effective June 27, 2022. The net assets transferred were recognized in the accounts of the Tiffin Plan as previously carried in the accounts of the Water-Way, Inc. 401k Profit Sharing Plan & Trust.

#### (b) Contributions

Prior to February 18, 2022, participants could voluntarily make qualified retirement contributions to the Plan which were deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In order to participate, employees had to make a minimum contribution of 1% of compensation. Participant contributions were permitted up to 100% of compensation subject to certain IRC limitations.

The Plan Sponsor made a safe harbor matching contribution equal to 100% of each participant's contributions up to 3% of compensation plus 50% of each participant's contributions that exceeded 3% up to 5% of compensation. Plan Sponsor and participant contributions could not exceed the maximum amount allowable for federal income tax purposes.

The Plan also provided that the Plan Sponsor could contribute each year an additional matching contribution and a profit sharing contribution authorized by the Plan Sponsor's Board of Directors; however, additional contributions by the Plan Sponsor were not required. No additional matching or profit sharing contributions were made by the Plan Sponsor during the period from January 1, 2022 through June 27, 2022 or for the year ended December 31, 2021.

(c) Participant accounts

Each participant's account was credited or charged with the participant's contributions, allocations of Plan Sponsor contributions, investment earnings or losses, and administrative expenses. Allocations were based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account balance.

(d) Vesting

Participants were immediately vested in their elective salary deferral and safe harbor matching contributions plus actual earnings or losses thereon. Vesting in the Plan Sponsor's additional matching and profit sharing contributions was based on years of continuous service. Participants were 20% vested after two years of service and vested an additional 20% each year thereafter, until they reached 100% after their sixth year of service. Participants were also 100% vested upon reaching the Plan's normal retirement age of 65 or upon their death or disability.

(e) Participant notes receivable

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The participant notes were secured by the balances in the respective participants' accounts and bore interest at a fixed rate, which was commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest were collected ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, permanent disability, or retirement, a participant could elect to receive a lump-sum payment equal to his or her entire account balance. For termination of service due to other reasons, a participant was entitled to receive only the vested interest in his or her account as a lump-sum distribution.

(g) Forfeited accounts

Forfeitures were created when participants terminated employment prior to becoming fully vested in the Plan Sponsor's additional matching and profit sharing contribution portion of their accounts. Such forfeitures could reduce the Plan Sponsor's contributions to the Plan or could be used to pay Plan expenses.

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(i) Administrative expenses

Administrative expenses were paid by the Plan or the Plan Sponsor. Expenses paid directly by the Plan Sponsor are excluded from these financial statements. Certain fees incurred by the Plan for investment management services are netted within net appreciation (depreciation) in the fair value of investments. Fees related to the administration of the Plan, participant notes receivable, and processing of distributions were charged directly to the participants' accounts and are included in administrative expenses.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

(b) Investment valuation and income recognition

Investments were stated at fair value (except for the fully benefit-responsive investment contract, which was reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 and Note 5 for discussion of fair value and contract value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as, held during the period from January 1, 2022 through June 27, 2022 and for the year ended December 31, 2021.

(c) Participant notes receivable

Participant notes receivable were measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes were reclassified as distributions based upon the terms of the plan agreement.

(d) Payment of benefits

Benefits were recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) Certified information

Certain information related to investments disclosed in the accompanying financial statements, including the fair value and contract value of investments and participant notes receivable held at December 31, 2021, as well as net appreciation (depreciation) in fair value of investments and interest on participant notes receivable for the period from January 1, 2022 through June 27, 2022 and for the year ended December 31, 2021, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Lincoln National Life Insurance Company ("Lincoln").

(4) Investments measured at net asset value using the practical expedient

The Plan's investments at December 31, 2021 included pooled separate accounts which were measured at net asset value ("NAV") as a practical expedient to estimate fair value, and therefore, were not classified in the fair value hierarchy.

The following table summarizes investments for which fair value was measured using the NAV as a practical expedient as of December 31, 2021. There were no participant redemption restrictions for these investments.

(5) Investment contract with insurance company

The Plan had entered into an investment contract with Lincoln. This investment contract was considered fully-benefit responsive. Lincoln maintained the Plan's contributions in a pooled account which was credited with earnings on the underlying investments and charged for Plan withdrawals and investment expenses. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The investment contract provided for daily redemption by the Plan at reported unit values with no advance notice requirement.

The contract value of the investment contract at December 31, 2021, was \$10,318. The crediting interest rate was based on a formula agreed upon with the issuer, but could not be less than zero. Such interest rates were reviewed on a quarterly basis for resetting.

Certain events could have limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Despite the Plan's merger, the investment contract was liquidated at contract value.

The investment contract did not permit Lincoln to terminate the agreement prior to the scheduled maturity date.

### (6) Income tax status

The Plan Sponsor adopted a pre-approved profit sharing plan, which received a favorable opinion letter from the IRS (Internal Revenue Service) on June 30, 2020, which stated that the pre-approved plan was designed in accordance with the applicable sections of the IRC. The Plan itself had not received a determination letter from the IRS stating that the Plan was qualified under Section 401(a) of the IRC. However, the plan administrator believes that the adopted pre-approved plan, as amended, was designed and operated in compliance with the applicable requirements of the IRC, and was therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 27, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

### (7) Related party and party-in-interest transactions

Plan investments were units of pooled separate accounts and an investment contract managed by Lincoln and, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers and held participant notes receivable which also qualify as party-in-interest transactions.


