Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the financial statements of Maniilaq Association Employee Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to June 30, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of June 30, 2022 and December 31, 2021, and for the period from January 1, 2022 to June 30, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Notes to Financial Statements

1. Description of Plan

The following description of the Maniilaq Association Employee Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a 401(a) Money Purchase Pension Plan which covered all employees of Maniilaq Association, Inc. (Company or Employer) without regard to age. The Plan was originally enacted on October 1, 1983. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended, (ERISA) and the applicable requirements of the Internal Revenue Code (IRC).

On February 11, 2022, the Board of Directors of the Maniilaq Association made the decision to freeze the Plan effective April 1, 2022 and merge all assets into the Maniilaq Association, Inc. 401(k) Safe Harbor Profit Sharing Plan. Effective June 30, 2022, the Plan merged into the Maniilaq Association, Inc. 401(k) Safe Harbor Profit Sharing Plan. Net assets of the Plan totaling \$21,213,608 were transferred.

Custodian and Administration of the Plan

The custodian and recordkeeper of the Plan was Voya Retirement Insurance and Annuity Company (Voya). The administrator of the Plan was the Company. The custodian held all assets of the Plan in accordance with the service provider contract with the Company. Plan management determined the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All employees were eligible to participate in the Plan except for the following categories: union employees whose employment was governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, certain nonresident aliens, leased employees, employees who are Federal Commission Corps personnel or who were provided by the Federal Government under an interagency personnel agreement were not eligible for the plan. Employees were eligible to participate in the Plan after completing one year of service. Entry into the Plan was the first day of the Plan year quarter coinciding with or next following the date the eligibility requirements had been satisfied.

Contributions

Employees are not allowed to make deferrals to the Plan, as defined in the Plan document. Employer contributions were previously made annually at a rate of 5% of eligible compensation. The Employer contribution for the 2022 Plan year was based on 5% of eligible compensation from January 1, 2022 to March 31, 2022. Participants directed the investment of the employer contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Notes to Financial Statements

Participant Accounts

Each participant's account was credited with the employer contributions, as well as an allocation of Plan earnings. Allocation was based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

The vested percentage in a participant's account was based on years of service and was determined by the Plan's vesting schedule. Participants who achieved the retirement age of 65, die, or became disabled were immediately 100% vested in their accounts. Prior to April 1, 2022, all participants became 100% vested in their employer account value according to a three-year cliff vesting schedule. Effective April 1, 2022, all account balances became 100% vested.

Forfeitures

Forfeitures are used to reinstate previous forfeitures of active participants and then the remaining amount is used to reduce employer contributions. At June 30, 2022 and December 31, 2021, the total unallocated forfeitures were \$0 and \$6,811, respectively. Total forfeitures of \$6,755 were used during the period ended June 30, 2022 to reduce employer contributions and \$21,091 was used to restore previously forfeited amounts to participants rehired in 2021, who had previously had their account balance forfeited.

Payments of Benefits

Upon termination of employment, normal retirement, death or disability, the vested portion of participants' account balances were distributed in the form of an annuity payable monthly for the remainder of the participant's life, or joint lives, if married. Alternatively, a participant may elect to receive their distribution in a single lump sum. In the event the participant's vested account balance was less than \$1,000 and the participant made no election, a single lump sum payment would have been made. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance was rolled into an IRA for the benefit of a participant, without the participant's consent.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes in those assets therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value, with the exception of the fully benefit-responsive investment contract, which was reported at contract value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan were paid by the Company, except for certain withdrawal expenses that were charged to participant accounts. Certain investment expenses which were charged within investments were presented net of the depreciation in fair value of investments. All other expenses of the Plan for the year ended June 30, 2022 were paid by the Company and were excluded from these financial statements.

3. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya, a qualified institution, has certified that the following investment information included in the accompanying financial statements is complete and accurate:

- (a) Investments, as shown in the statements of net assets available for benefits as of June 30, 2022 and December 31, 2021; and
- (b) Total investment loss, as shown in the statement of changes in net assets available for benefits for the period from January 1, 2022 through June 30, 2022.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

4. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability’s level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2022, and December 31, 2021.

Pooled separate accounts: Pooled separate accounts were stated at fair value which was determined using various inputs, such as the NAV of the shares of the underlying mutual funds held at year end, adjusted for administrative expenses or other charges. The value was referred to as the unit value and is classified within level 2 of the fair value hierarchy.

The method described above may produce fair value calculations that may not have been indicative of net realizable value or reflective of future values. Furthermore, while the plan believed its valuation methods were appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain plan instruments could result in a different fair value measurement at the reporting date.

There were no investments measured within the fair value hierarchy as of June 30, 2022. The following table sets forth by level, within the fair value hierarchy, the Plan’s investments at fair value as of December 31, 2021:

5. Fully Benefit-Responsive Investment Contract

The Plan invested in a fully benefit-responsive investment contract with Voya. This investment contract met the fully benefit-responsive criteria; and therefore, was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Net deposits invested in the investment contract became part of Voya's general account. Contract value was guaranteed by the full faith and credit of Voya. The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may have been affected by future economic and regulatory developments.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the contract issuer, but it was not less than 1%. The crediting interest rate was reset quarterly.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the plan participants are probable of occurring. The assets transferred at contract value.

In addition, certain events allowed the contract issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events included the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the contract issuer. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

6. Related-Party and Party-in-Interest Transactions

Certain Plan investments were shares of pooled separate accounts offered or managed by Voya. Voya was also the issuer of the annuity contract as defined by the Plan, and, therefore, these transactions qualified as party-in-interest transactions as defined by ERISA. Such transactions were permitted under provisions of the Plan and were exempt from the prohibition of party-in-interest transactions under ERISA.

7. Tax Status

The Plan uses a pre-approved Plan document sponsored by Aldrich Retirement Solutions, LP. Aldrich received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved document, as then designed, satisfied the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believed that the Plan was designed and was operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax were included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination all account balances become fully vested, and all remaining assets in the affected participants' accounts shall be distributed to the participants and beneficiaries of the Plan in the order provided by ERISA. See Note 1.

9. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. Subsequent Events

Management has evaluated subsequent events through April 14, 2023, the date the financial statement were available to be issued.
