### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2021 Financial Statements

We have performed an audit of the accompanying financial statements of Apreva Hospice 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of October 13, 2022 (in liquidation), and the related statement of changes in net assets available for benefits for the period ended October 13, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of October 13, 2022, for the period January 1, 2022 through October 13, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the 2022 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2022 Financial Statements section—

- The amounts and disclosures in the 2022 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the 2022 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion on the 2022 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2022 Financial Statements section of our report.

## **Basis for Opinion on the 2022 Financial Statements**

We are required to be independent of Apreva Hospice 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the 2022 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Apreva Hospice 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued. As discussed in Note 1 to the financial statements, the Plan terminated effective June 30, 2022, and the financial statements are on a liquidation basis, raising substantial doubt the Plan will continue one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the 2022 Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Apreva Hospice 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Apreva Hospice 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2022 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



#### NOTE 1 - DESCRIPTION OF PLAN

The following description of Apreva Hospice 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **Plan Termination**

Effective June 30, 2022, the Plan Sponsor elected to terminate the Plan. As a result, the plan calls for termination of all assets to be distributed to participants as soon as administratively feasible and no later than 12 months following the Plan's termination date. The distributions were made in the form of single lump sums or rollovers into a qualified Plan. All participants became 100% vested in the employer portion of their accounts upon termination of the Plan. Eligibility for benefit payments from inactive participants were determined according to the Plan's provisions in effect the day before the participants become inactive. All Plan assets were distributed by October 13, 2022.

#### **General**

Prior to Plan termination, the Plan was a defined contribution plan covering all eligible classes of employees of Apreva Corporation dba Apreva Hospice (collectively the "Company") who had completed 30 days of service and were age 21 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator was responsible for oversight of the Plan. The Plan's management determined the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan administrator.

#### **Contributions**

As of the effective date of planned termination, participants no longer made contributions to the Plan. Prior to the date of planned termination, participants were able to contribute up to 100% of their annual pre-tax compensation, as defined in the Plan, up to the maximum amount allowed by law. Participants could also make qualified Roth contributions to the Plan and could contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants directed the investment of their contributions into various investment options offered by the Plan. Prior to the Plan termination, the Company offered various mutual funds as investment options for participants. Prior to the Plan termination, the Company made discretionary matching contributions equal to 25% of the participant's salary deferral up to 6% of Plan compensation. Prior to the date of planned termination, the Company could make discretionary profit sharing contributions, at the discretion of the Company. There were no discretionary employer profit sharing contributions made during the Plan years ended October 13, 2022 and December 31, 2021. Contributions were subject to certain limitations as determined by the Internal Revenue Code ("IRC").

#### **Participant Accounts**

As of the effective date of planned termination, contributions were no longer allowed. Prior to the date of planned termination, each participant's account was credited with the participant's contributions, including amounts rolled over from other qualified plans, Company contributions, as well as allocations of Plan earnings.

##### **Participant Accounts (Continued)**

Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocation of expenses were based on the participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

##### **Vesting**

Participants, prior to and after the date of planned termination, were vested immediately in their voluntary contributions, including amounts rolled over from other qualified plans. Vesting in the Company's matching portion of their accounts is based on years of continuous service with the Company. A participant is 20 percent vested after year 2 of credited service until reaching 100 percent vested after 6 years of continuous service or in the event of death and disability, as defined by the Plan.

##### **Notes Receivable from Participants**

Subsequent to the date of planned termination, no new notes receivable from participants were allowed. Prior to the date of planned termination, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their account balance or \$50,000. A participant could have one outstanding loan at a time. The loans were secured by the balance in the participant's account and bear interest at 1% over the prime rate at the time of issuance, which was commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest was paid ratably through regular payroll deductions.

##### **Payment of Benefits**

As of the date of planned termination, only liquidating distributions were allowed. Prior to the date of planned termination, participants could elect to receive either a partial or lump-sum amount equal to the value of the participant's vested interest in his or her account, on termination of service due to death, disability, or retirement, or could delay benefit payments until age 70½ when required minimum distributions would begin. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a partial or lump-sum distribution. If a participant's vested interest does not exceed \$5,000, a lump-sum distribution would be made regardless of whether the participant consents to receive payment. Participants were permitted to take hardship distributions from selected accounts, as defined by the Plan, upon demonstrations of financial hardship.

##### **Forfeited Accounts**

Forfeited, non-vested accounts can be used to reduce future employer contributions or to pay Plan administrative expenses. At October 31, 2022 and December 31, 2021, there were no forfeited non-vested accounts. During 2022, there were \$1,616 in reductions in employer contributions from forfeited non-vested accounts and \$741 in fees paid from forfeited non-vested accounts.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### **Basis of Accounting**

As discussed in Note 1 to the financial statements, the Plan Sponsor elected to terminate the Plan effective June 30, 2022, therefore, liquidation was deemed imminent during 2022. In accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting used to determine the amounts at which investments and benefit distribution information is stated from the accrual (ongoing) basis used in the presentation of the 2021 financial statements to the liquidation basis of accounting presentation of the 2022 financial statements.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan Management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees were recorded as administrative expenses and were expensed when they were incurred. Delinquent notes receivable from participants were recorded as a distribution based upon the terms of the Plan document. There was no allowance for uncollectible loans for the year ended October 13, 2022.

##### **Payment of Benefits**

Benefits payments to participants were recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan were paid by the Company and were excluded from these financial statements. Certain expenses were paid using the Plan's assets and were included in net appreciation or depreciation of fair value of investments. Certain expenses relating to specific transactions, such as loan set up, and loan maintenance, were paid directly by the participant and were included in administrative expenses.

##### **Subsequent Events**

The Plan has evaluated events and transactions for potential recognition or disclosure through March 15, 2023, which is the date the financial statements were available to be issued.

#### NOTE 3 - INFORMATION CERTIFIED BY NATIONWIDE LIFE INSURANCE COMPANY (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements, including investments and notes receivable from participants held at October 13, 2022 and December 31, 2021, and net appreciation in fair value of investments, and interest and dividends for the period ended October 13, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Nationwide Life Insurance Company ("Nationwide").

#### NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820-Fair Value Measurement are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 13, 2022 and December 31, 2021.

NOTE 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Fund management and custodial services, recordkeeping, transactions processing, loan maintenance services, and shares of mutual fund accounts were provided by Nationwide Life Insurance Company, subsidiaries and affiliates, therefore, these transactions qualify as party-in-interest transactions. Plan recordkeeping and transaction processing services were provided by Trinity Pension Group, LLC, therefore, fees associated with these services qualify as party-in-interest transactions.

NOTE 6 - PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. As described in Note 1, the Plan Sponsor elected to terminate the Plan effective June 30, 2022, and all Plan assets were distributed prior to October 13, 2022.

#### NOTE 7 - TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by Trinity Pension Group, LLC. The prototype plan had received a determination letter dated June 30, 2020 from the Internal Revenue Service that the prototype plan and related trust were designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan had been amended since receiving the determination letter, the Plan administrator believes the Plan was designed and was currently being operated in compliance with the applicable provisions of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator had analyzed the tax positions taken by the Plan, and had concluded that as of October 13, 2022 and December 31, 2021, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

#### NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
