Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Geissele Automatics 401(k) Profit Sharing Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 2, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 through June 2, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 2, 2022 and December 31, 2021 and for the period January 1, 2022 through June 2, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Merger

As further described in Note 1, the Plan was merged with and into the AON Pooled Employer Plan effective June 1, 2022. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

(1) Description of Plan

The following description of the Geissele Automatics 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution profit-sharing plan covering substantially all employees of Geissele Automatics, Inc., Gwynedd Manufacturing, Inc., and ALG Defense, Inc. (collectively, the Company) who had attained age eighteen or older and completed three months of service (as defined in the Plan document) with the Company, except employees whose employment was covered by a collective bargaining agreement, nonresident aliens, and leased employees. The Plan was subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan trustees were responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Plan Merger

In May 2022, the Company's board of directors adopted an amendment to the Plan and a resolution that, effective June 1, 2022, the Plan merged with and into the AON Pooled Employer Plan (the Aon PEP). All participants and their surviving beneficiaries in the Plan immediately prior to the effective date (the Transferred Participants) will become participants of the Aon PEP as of the effective date and the Transferred Participants will no longer be eligible to participate in the Plan. Additionally, all active Transferred Participants will be granted an additional year of vesting service to the total vesting service accrued as of January 1, 2022. As a result of the merger to Aon PEP, during the period ended June 2, 2022, \$4,102,080 of plan assets were transferred to another trust for the benefit of the Transferred Participants.

Contributions

Prior to the Participants may contribute up to 100% of their pre-tax annual eligible compensation or after-tax annual eligible compensation, as defined in the plan document, subject to the maximum allowable under the Internal Revenue Code (IRC) guidelines. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a matching contribution of 50% of a participant's elective deferral contribution for elective deferrals up to 6% of a participant's compensation, as defined by the Plan. Matching contributions are determined each payroll period.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service according to the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are permitted to have one loan outstanding at any given time. Loan terms range from 1 to 5 years, or longer if the proceeds are used for the purchase of the participant's primary residence. Participant notes receivable are secured by the balance in the participants' accounts and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. The interest rate will remain fixed for the duration of the loan. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the vested balance of the participant's account, unless another form of payment is selected by the participant. For termination of service due to other reasons, a participant may (a) elect to defer payment until normal retirement age or April 1 of the calendar year following the attainment of age 72, if the balance is greater than \$1,000, (b) receive the value of the vested account as a lump-sum distribution, or (c) rollover the vested balance to another authorized plan. Absent instructions, accounts with a balance under \$1,000 will be paid as a lump-sum distribution. Employees may elect withdrawals during employment subject to the terms described in the plan document.

Forfeited Accounts

As of December 31, 2021, there were forfeited nonvested account balances in the amount of \$3,402. Forfeited nonvested accounts may be used to offset future employer contributions or plan administrative expenses. During 2022, no forfeitures were used to reduce employer contributions or plan administrative expenses. Remaining forfeiture balances at the time of the plan merger of \$12,039 were transferred to the Aon PEP.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses related to the administration of the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of distributions are charged directly to the affected participants' accounts and are included in administrative expenses. Investment related expenses are included in net depreciation in the fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through April 17, 2023, the date the financial statements were available to be issued.

(3) Financial Information Certified by the Trustee

Certain information related to investments disclosed in the accompanying financial statements, including investments held at June 2, 2022 and December 31, 2021, and net depreciation in fair value of investments, and interest and dividends for the period January 1, 2022 through June 2, 2022, was obtained by management and agreed to or derived from the information certified as complete and accurate by Nationwide Trust Company, FSB (Nationwide), a qualified institution.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

There were no significant transfers among investment levels during the period January 1, 2022 to June 2, 2022 and the year ended December 31, 2021.

(5) Tax Status

The Plan used a prototype plan document sponsored by Nationwide Financial Services, Inc. (NFSI). The Internal Revenue Services (IRS) had determined and informed NFSI by a letter dated March 31, 2014, that the Plan was designed in accordance with the applicable section of the IRC. Although the Plan had been amended since receiving the opinion letter, the plan administrator believed that the Plan was designed and was operated in compliance with the applicable requirements of the IRC and therefore believed that the Plan was qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments were shares of registered investment companies managed by an affiliate of Nationwide. Nationwide Retirement Plans, an affiliate of Nationwide, was the record keeper of the Plan. Nationwide was the trustee of the Plan and, therefore, these transactions qualified as party-in-interest transactions, which were exempt from the prohibited transaction rules. Fees incurred by the Plan for investment management services were included in net depreciation in the fair value of investments. Administrative expenses paid by the Plan related to activity based transactions and recordkeeping services amounted to \$778 for the period January 1, 2022 to June 2, 2022. The plan sponsor paid directly certain other fees related to the Plan's operations.

(7) Prohibited Transactions

As required by ERISA Section 2510.3-102, the Plan sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable. During 2019, employee contribution withholdings in the amount of \$308 were not remitted to the Plan timely. Additionally, during April 2022, employee contribution and loan withholdings in the amount of \$23,856 were not remitted to the Plan timely. As of June 2, 2022, with the exception of a loan withholding of \$267, the withholdings resulting from the delinquent contributions have been remitted to the Plan. For all such delinquent contributions, the related lost earnings have not been calculated and remitted. These transactions are considered prohibited transactions as defined by ERISA.
