Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Specialty Polymers, Inc. Qualified Employee Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Note 1 - Description of the Plan

The following description of the Specialty Polymers, Inc. Qualified Employee Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all regular full-time employees of Specialty Polymers, Inc. and its subsidiary Roo Products, Inc. (collectively, the Company) who have six months of service. The Plan provides participants with a salary deferral option pursuant to Section 401(k) of the Internal Revenue Code (IRC). The Plan engages Standard Insurance Company (the Custodian) to hold and invest Plan assets and execute Plan transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Each year, participants may contribute up to 100% of pretax and after tax (Roth) annual compensation, subject to limits of the tax law as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company matches a discretionary portion of participants' annual deferrals. For the six months ended July 1, 2022, the Company elected to match 100% of the participant's contribution up to 5% of gross pay. The Plan also allows the Company to make discretionary non-elective contributions but did not elect to make this contribution in the six months ended July 1, 2022. To be eligible for the Company's discretionary contributions, a participant must have completed 1,000 hours and one year of service. Contributions are subject to certain limitations.

Investment Elections

Participants direct the investment of their contributions into various investment options offered by Standard Insurance Company. Participants have the opportunity to change their investment combinations on a daily basis.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are made in a manner which recognizes each participant's account balance, investment selection and timing of contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary match plus actual earnings thereon is based on years of continuous service and occurs gradually. A participant is 100% vested after six years of credited service. A participant becomes fully vested in the entire balance of his or her account upon attainment of normal retirement age, permanent disability, death, or termination of the Plan. Any amount not vested upon a participant's separation from service is forfeited and may be used to reduce the Company's contribution or pay Plan expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years. Principal and interest is paid ratably through payroll deductions. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with rates charged by commercial lenders for loans made under similar circumstances. The interest rates ranged from 3.25% to 4.75% for the six months ended July 1, 2022 and the year ended December 31, 2021.

Payment of Benefits

On termination of service due to any reason, participants with vested account balances of less than \$5,000 receive an automatic distribution to an Individual Retirement Account (IRA). Participants with vested account balances of \$5,000 or more may elect to receive a single lump-sum amount or choose to rollover their balance into another qualified retirement plan or IRA.

Participants may also elect to take in-service or hardship withdrawals subject to the terms of the Plan document and Internal Revenue Service (IRS) regulations. Benefits are recorded when paid.

Forfeitures

At July 1, 2022 and December 31, 2021 there were no forfeited nonvested accounts. During the six months ended July 1, 2022, forfeitures of \$1,747 were used to pay Plan expenses.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value, except for guaranteed investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the six months ended July 1, 2022.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of July 1, 2022 and December 31, 2021. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Plan permits the payment of remaining Plan expenses to be made from the Plan's assets. Investment related expenses are included in net appreciation or depreciation of fair value of investments. Other fees are charged to participants on a pro rata basis, equally to participant accounts, or specifically to a participant account for transactions specifically related to that participant.

Subsequent Events

The Plan has evaluated subsequent events through April 13, 2023, which is the date the financial statements were available to be issued.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 3 - Information Certified by Custodian

The Plan's investments are held by Standard Insurance Company, the Custodian of the Plan. Investment decisions are made at the direction of the participants. The investments are credited for earnings thereon and charged for withdrawals and expenses as charged by the Custodian. The Plan Administrator has obtained a certification from the Custodian as of July 1, 2022 and December 31, 2021, and for the six months ended July 1, 2022, that the following information provided to the Plan Administrator by the Custodian is complete and accurate:

- Investments, at fair value
- Investment, at contract value
- Notes receivable from participants
- Net depreciation in fair value of investments
- Interest and dividends

Note 4 - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets; 2) quoted prices for identical or similar assets or liabilities in inactive markets; 3) inputs other than quoted prices that are observable for the asset or liability; 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 1, 2022 and December 31, 2021:

Pooled Separate Accounts (PSA): PSAs invest in a variety of domestic stock, international stocks, mutual funds, bonds and other securities. The majority of the underlying securities have observable level 1 quoted pricing inputs. While the underlying asset values are generally based on publicly quoted prices, the net asset value (NAV) of each PSA is not valued using publicly quoted prices. The NAV provided by the Custodian is used as the practical expedient to estimate fair value. PSA's can be redeemed on a daily basis and each PSA has its own investment strategy. Participants should refer to each PSA's prospectus for a description of the PSA and its investment strategy.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The inputs used for valuing securities are not necessarily an indication of the risk associated with investing in those securities.

Note 5 - Guaranteed Investment Contracts

The Plan includes a fully benefit-responsive investment contract with Standard Insurance Company. Standard Insurance Company maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value, as reported to the Plan, represents contributions made under the contract plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) termination of the contract, (2) spin-offs, (3) divestitures, (4) layoffs, (5) corporate relocation, (6) partial or total Plan termination, (7) retirement incentive programs, and (8) the liberalization of Plan withdrawal or transfer rules. The issuer may terminate the contract with 30 days advance written notice for reasonable cause, which includes (1) the Plan's failure to abide by state or federal law, (2) failure to render performance necessary to comply with the terms of the contract, (3) failure to maintain assets of at least \$25,000, (4) Plan disqualification, or (5) failure to adopt the Plan in a reasonable period of time. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring. Upon termination by the issuer, there was no market value adjustment or other withdrawal restrictions.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract values of the investments at July 1, 2022 and December 31, 2021 were \$0 and \$5,985,364, respectively. The crediting interest rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions.

Note 6 - Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. On December 1, 2021, the plan sponsor was acquired by Sherwin Williams Company. Effective June 30, 2022, all remaining assets of the Plan were transferred into The Sherwin-Williams Company 401(k) Plan (EIN 34-0526850, Plan 001), a plan sponsored by the acquiring entity. The transfer included \$17,280,930 of investments and \$430,139 of notes receivable from participants. Transferred participant balances were invested in target date funds based on the date at which each participant would reach age 65.

Note 7 - Tax Status

The IRS has determined and informed the Plan's volume submitter sponsor by an opinion letter dated March 31, 2014, that the Volume Submitter Profit Sharing Plan with CODA sponsored by Standard Retirement Services Inc., which has been adopted by the Plan, is acceptable pursuant to section 401 of the IRC and in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements as of July 1, 2022. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts managed by Standard Insurance Company. Transactions with this entity qualify as party-in-interest transactions. For the six months ended July 1, 2022, fees paid by the Plan for investment management and recordkeeping services were \$42,381.


