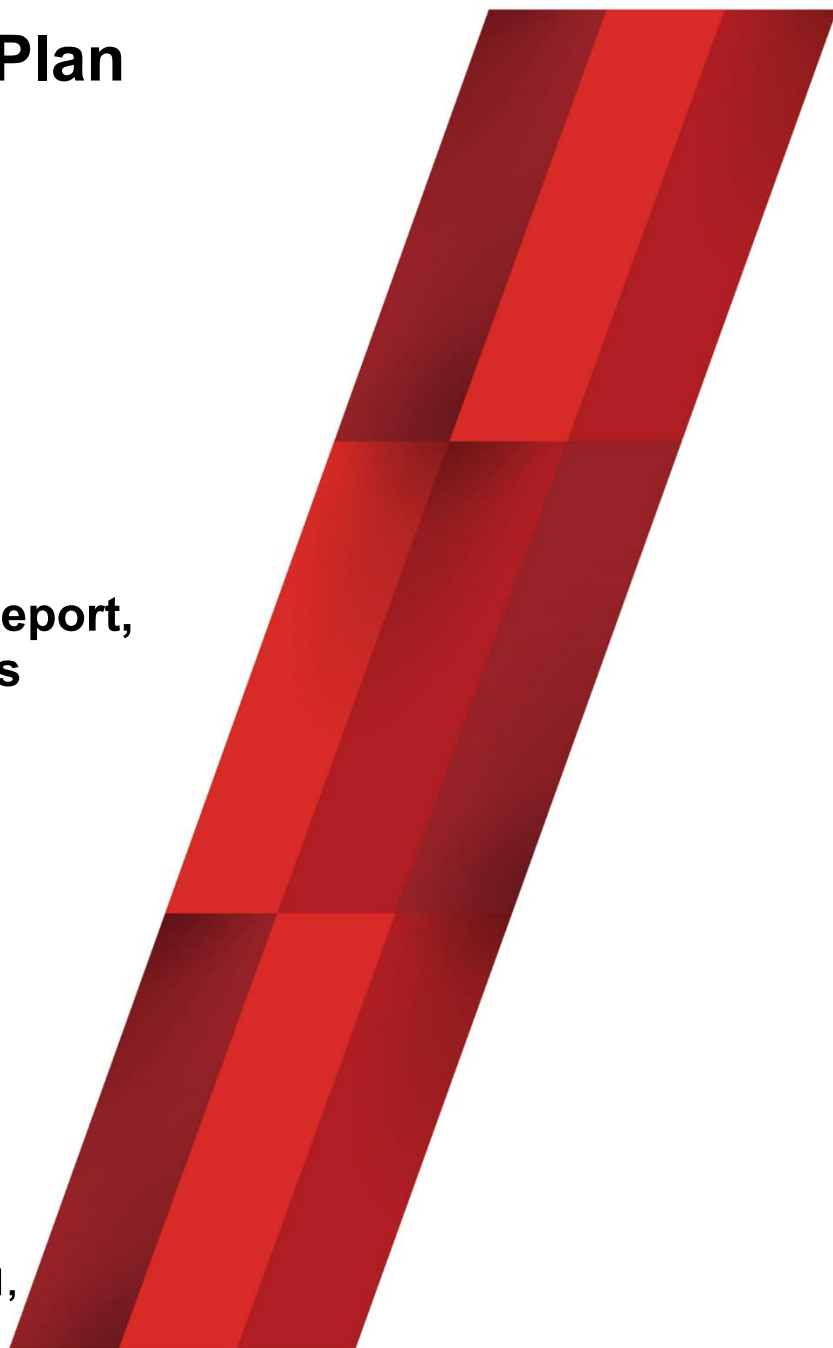

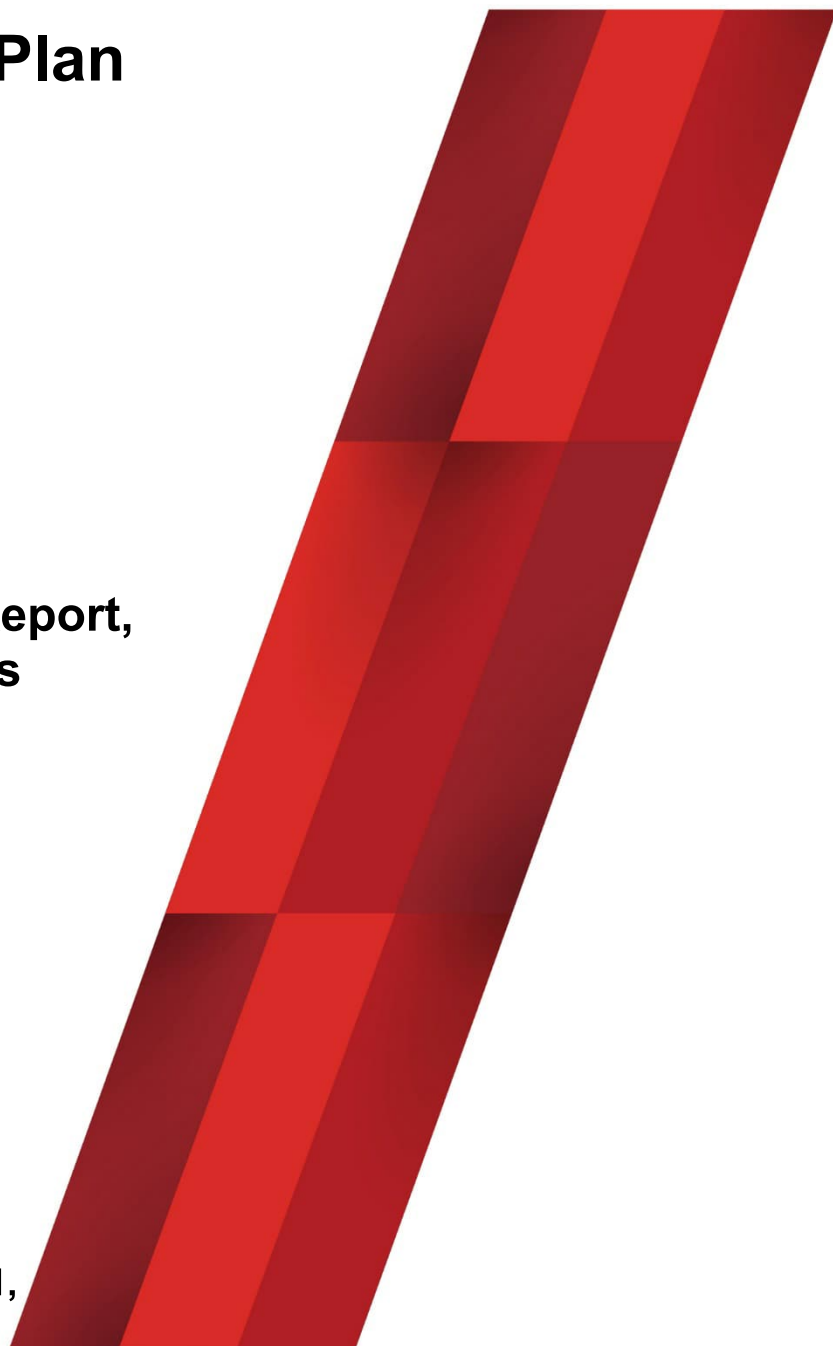

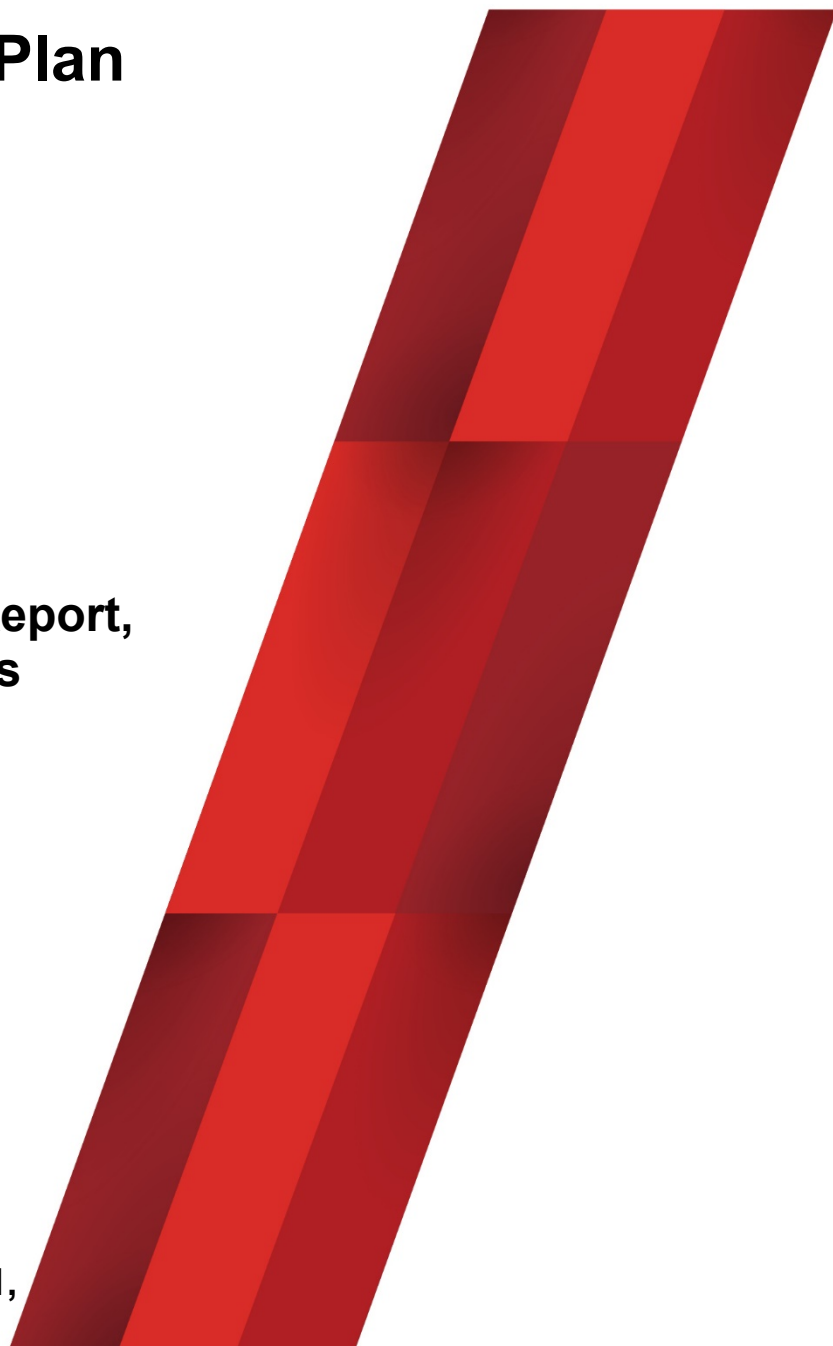

Notes to Financial Statements

1. Plan Description

The following description of the InTec, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all full-time employees of InTec, LLC (the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's management was responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Plan termination

In 2021, the Company was acquired by Analytic Services Inc. As a result, the Board of Directors of the Company, resolved to terminate the Plan and merge the Plan's assets into a qualified plan sponsored by the acquiring company. As part of the process, contributions were no longer made to the Plan after March 31, 2022 as participants were eligible to contribute to the acquirors plan.

The plan assets were fully merged on June 2, 2022.

Contributions

Prior to April 1, 2022, participants were able to contribute up to the maximum amount allowed by law as pre-tax or Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year may make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company makes a safe harbor matching contribution equal to 100% of the elective deferrals that do not exceed 6% of the participant's compensation. The Company may make additional discretionary profit-sharing contributions. Participants must be employed on the last day of the Plan year and must have completed 1,000 hours of service to be eligible for the discretionary profit-sharing contribution. For the period from January 1, 2022 through June 2, 2022, the Company did not make discretionary profit-sharing contributions. Contributions are subject to certain IRS limitations.

Participant accounts

Each participant's account was credited with the participant's contributions, including amounts rolled over from other qualified plans, the Company's safe harbor matching contributions, the Company's discretionary profit-sharing contributions, if any, and Plan earnings. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their voluntary contributions, rollover contributions, and all Company contributions, plus actual earnings thereon.

Notes receivable from participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to an amount equal to the lesser of \$50,000 or 50% of their vested account balance. Participants were allowed one outstanding note at any time. The notes were secured by the balance in each participant's account. The loan interest rate was 1.00% above the prime rate, which as commensurate with local prevailing rates as determined by the plan administrator. Loan terms ranged from one to five years or if the loan is for the purchase of a primary residence, the plan administrator could permit a longer term.

Payment of benefits

Upon termination of service due to death, disability, retirement or any other reason, a participant or beneficiary could elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or partial withdrawals. Participant accounts with balances, excluding rollovers, of \$5,000 or less were automatically distributed as soon as administratively feasible following severance of employment.

The Plan also allowed for in-service withdrawals in the following circumstances: 1) hardship withdrawals for current employees from the participant's pre-tax deferral contributions and 2) withdrawal at the age of 59½ from all vested balances.

2. Summary of Significant Accounting Policies

Basis of accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at the unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through April 13, 2023, the date the financial statements were available to be issued.

3. Unaudited Information Certified by the Custodian

The accompanying financial statements include the following unaudited information as of June 2, 2022 and December 31, 2021 and for the period ended June 2, 2022 that was obtained from data prepared and certified to be complete and accurate by the Plan's custodian.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 2, 2022 and December 31, 2021.

Pooled separate accounts ("PSA")

Valued using the net unit value, which is based on the fair value of the underlying assets of the account.

Fair value of investments that calculate net asset value

There were no investments at June 2, 2022. The following table summarizes investments measured at fair value based on net asset value (NAVs) per share as of December 31, 2021.

5. Fully Benefit-responsive Investment Contracts

The Plan invested in the Voya Fixed Account (the "Fixed Account"), a traditional investment contract. The contract meet the fully benefit-responsive investment contract criteria and, therefore, was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan was a guaranteed investment contract ("GIC"). The contract issuer was contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not be less than 1%. The crediting rate was reviewed on an annual basis for resetting. The contract could not be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

Certain events could limit the ability of the Plan to transact at contract value with the contract issuer. These events could be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

6. Tax Status

The Plan had adopted a volume submitter plan and trust sponsored by The Retirement Advantage, Inc. The volume submitter plan has received an opinion letter from the IRS dated March 31, 2014, stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The volume submitter plan opinion letter has been relied upon by the Plan. The Plan has been amended subsequent to the opinion letter date. The plan administrator believes the Plan, as amended, is being operated in compliance with the applicable requirements of the IRC to maintain a tax-exempt status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

7. Related Party and Party-In-Interest Transactions

Certain Plan investments are shares of pooled separate accounts and a guaranteed investment contract managed by Voya, the custodian and a party-in-interest to the Plan. Fees paid by the Plan for investment management services are included in net depreciation in the fair value of the investment, as they are paid through revenue sharing rather than a direct payment. In addition, the Plan paid certain expenses related to Plan operations to other service providers. These transactions are party-in-interest transactions under ERISA.
