NOTES TO FINANCIAL STATEMENTS JULY 8, 2022 AND DECEMBER 31, 2021

Note 1: Description of Plan

The following description of the Kate Somerville Skincare, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Kate Somerville Holdings, LLC (the "Company"). The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code ("IRC") and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan initially became effective on January 1, 2008. The Plan Adoption Agreement was amended and restated on December 23, 2020.

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security ("CARES Act") was signed into law. Plans are permitted to immediately adopt any of the provisions provided that the Plan document is retroactively amended on or before December 31, 2022. Further discussion of the provisions adopted can be found in **Payment of Benefits and Notes Receivable from Participants**.

Employees will become eligible to participate in the Plan once they have reached the age of 18. There is no minimum service requirement. Plan entry dates are on the first day of each month after satisfying eligibility requirements.

Contributions

Each year, participants may contribute 100% of pretax annual compensation, as defined in the Plan, up to the IRC annual maximum. Such contributions may be pre-tax elective Deferrals (as defined). In addition, participants may make after-tax Roth Contributions (as defined). Participants may also contribute amounts representing distributions from other qualified plans ("rollovers"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company is required to make safe-harbor matching contributions equal to 100% of the employee's salary deferrals that do not exceed 4% of the employee's compensation, up to the applicable Internal Revenue Service ("IRS") compensation limit. The contributions are made on a per payroll basis. For the period of January 1, 2022 through July 8, 2022, the Company made safe harbor contributions of \$183,136.

The Plan also allows for the Company to make a discretionary matching contribution. The Company may also make a discretionary profit sharing contribution to the Plan. For the period of January 1, 2022 through July 8, 2022, no discretionary matching contribution nor profit sharing contribution were made.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, (b) Plan earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions and the Company's safe-harbor matching contributions plus actual earnings thereon. The Company's discretionary matching contributions and profit sharing contributions and earnings thereon will be vested in accordance with the following schedule:

The vesting percentage for a participant who is an employee on or after the date the participant reaches normal retirement age (as defined by the Plan) will be 100% vested in employer contributions.

Effective with the Plan termination on July 8, 2022, the participants became 100% vested in all Company Contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Roth deferrals are not available to fund loans to participants. The loans are secured by the balance in the participant's account. All loans shall bear an interest rate equal to the prime rate, which shall remain fixed throughout the duration of the loan. Principal and interest are paid ratably through payroll deductions. Each participant may have only one loan outstanding at a time. For participant loans that become delinquent, the amount of the unpaid loan principal plus any accrued unpaid interest will be treated as a deemed distribution. Deemed distributions are reported as a taxable distribution and remain part of the participant's account balance until a distributable event occurs. The Plan did not adopt any of the CARES Act provisions related to notes receivable from participants.

Payment of Benefits

Upon leaving the Company for any reason (retirement, termination, disability, or death) a participant can elect to receive their vested benefits in the form of either a single lump-sum cash payment, or have a payment paid as a direct rollover to an individual retirement account ("IRA") or to another employer's tax qualified plan. However, if the participant's vested account balance is \$5,000 or less, the Company can elect to cash the balance out of the account by establishing a separate IRA outside the Plan. All vested account balances not exceeding \$1,000 may be immediately distributed in a lump sum payment.

Payment of Benefits (Continued)

Additionally, under certain circumstances of financial hardship or upon attaining the age of 59½, participants are allowed to take a hardship or in-service distribution from their accounts. Hardship distributions are subject to income taxes and may be subject to additional tax based on early withdrawal. Matching contributions and employer profit sharing contributions are not available for hardship distributions. Participants who obtain a hardship distribution, can continue to contribute to the plan, and are no longer subject to a six-month suspension. The Plan did not adopt any of the CARES Act provisions related to the payment of benefits to participants.

Forfeited Accounts

At July 8, 2022 and December 31, 2021, forfeited non-allocated accounts totaled \$0 and \$2,891, respectively. Forfeitures are retained in the Plan and may be used to reduce future employer contributions or to pay Plan expenses.

Note 2: Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on a cash basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable that are deemed by the plan administrator to be in default are treated as distributions based on the terms of the Plan document. Interest income on notes receivable from participants is recorded on an accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Plan Fees and Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Date of Management's Review

Events occurring after July 8, 2022 have been evaluated for possible adjustments to the financial statements or disclosures as of March 30 2023, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurement and Disclosures*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 8, 2022 and December 31, 2021.

Cash and cash equivalents: Short-term money market instruments are reported at fair value based on quoted market prices.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission (“SEC”). These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In regards to the classification of investment options offered by the Plan, there were no reclassifications in or out of levels 1, 2 or 3 during the period of January 1, 2022 through July 8, 2022 and December 31, 2021.

Note 4: Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of July 8, 2022 and December 31, 2021, respectively.
- Net investment income (loss) and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period of January 1, 2022 through July 8, 2022.
- Investment information included in the schedule of assets (held at end of year) for the period of January 1, 2022 through July 8, 2022.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 5: Party-In-Interest Transactions

The Plan allows for transactions with certain parties who may perform investment or recordkeeping services for the Plan. The Plan also issues loans to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest transactions for which a statutory exemption exists.

Note 6: Plan Termination

Effective July 8, 2022, the Plan was terminated in connection with the transfer of Assets to Unilever Advantage Savings Plan and participants became 100% vested in any employer contributions in accordance with ERISA provisions.

Note 7: Tax Status

The Plan uses a pre-approved plan document, which received an advisory letter from the IRS, dated June 30, 2020, stating that the pre-approved plan document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Operational Errors

During 2019 and 2020, Plan management identified certain operational errors related to the calculation of vested balances for multiple employees who had received distributions from the plan. The plan administrator has identified the procedural errors that allowed the errors to occur and has taken steps to ensure that this does not happen again in the future. The Company self-corrected the errors and adjusted any corrective contributions for lost earnings in 2022. These earnings were immaterial to the financial statements.

During 2020, Plan management identified certain operational errors related to the failure to automatically enroll eligible participants in the Plan and to withhold participant deferral contributions for certain participants who were automatically enrolled in the Plan. The Company has self-corrected the operational errors and remitted to the Plan any lost earnings in May 2022. These earnings were immaterial to the financial statements.

Note 10: Delinquent Participant Contributions

During the 2021 audit, it was determined that the Company had failed to remit employee deferrals in the time described in 29 CFR 2510.3-102. As a result of these late remittances, the Plan is considered to have engaged in a prohibited transaction. The plan administrator has identified the procedural errors that allowed the late deferrals to occur and has taken steps to ensure that this does not happen again in the future. The Company has self-corrected the late remittances in May 2022 and remitted lost earnings to the Plan. These earnings were immaterial to the financial statements.
