- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter— Plan Termination and Liquidation Basis

As further discussed in Note 1 to the financial statements, on July 23, 2021, the governing body of the Plan approved the termination of the Plan effective July 31, 2021, and a plan of liquidation, and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting prior financial statements to the liquidation basis of accounting used in presenting the 2022 and 2021 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of the Diamond Resorts 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan, established effective January 1, 1994, was a defined contribution plan. The Plan was intended to assist Diamond Resorts International, Inc. and related companies (collectively, the Employer or the Company) in its efforts to attract and retain competent employees by enabling eligible employees to share in the profits of the Employer and to supplement retirement income. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Trustee and Administration of the Plan

The Plan was administered by an investment committee appointed by the management of the Company. Fidelity Management Trust Company (Trustee) was the Plan Trustee. The Trustee held and executed investment transactions, made payments as directed by the Plan participants, provided record keeping and other functions, as defined within the service agreement.

Plan Termination

The Board of Directors of the Plan announced on July 31, 2021, that the Company had been acquired by Hilton Grand Vacations Inc. (HGV). Under the terms of the acquisition, the Plan was amended to terminate the Plan, cease all contributions, and fully vest all participants effective July 31, 2021. Following Plan termination, participant accounts were distributed to participants or, as applicable, rolled into a plan sponsored by HGV. All funds were distributed or transferred out by October 18, 2022.

Eligibility

Prior to July 31, 2021, employees who were at least 18 years of age and who had 1 month of service were eligible to participate. All employees were eligible, except for certain employees covered by a collective bargaining agreement, leased employees, nonresident aliens, and others as defined by the Plan.

Contributions

In connection with the freeze and termination of the plan, there were no participant or employer contributions subsequent to July 31, 2021.

Participant Accounts

Each participant's account was credited with allocations of plan earnings and expenses. The allocation of investment income and expenses of each fund was based on the value of each participant's account invested in each fund, in proportion to the total value of all accounts in each fund, taking into account any contributions to or distributions from the participant's account. General expenses, if any, of the Plan not attributable to any particular fund were allocated among

participants' accounts in proportion to the value of each account, taking into consideration the participant's distributions. The participants of the Plan could direct their account balance in various mutual fund investment options and a common collective fund offered by the Plan through the Trustee.

Vesting

Due to Plan termination, all participants are fully vested.

Payment of Benefits

Due to Plan termination, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeitures

At October 18, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$186, respectively. Due to Plan termination, forfeitures from nonvested participant accounts were used to pay expenses of the Plan. During the year ended October 18, 2022, \$186 was used to pay expenses of the Plan.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Employer and are excluded from these financial statements. The Plan paid for certain investment transactions and management fees which totaled \$186 for the period from January 1, 2022 through October 18, 2022. The fees for participant requested services are charged to the accounts of participants requesting the transaction.

Notes Receivable from Participants

Prior to July 31, 2021, participants could borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance in their account during the prior 12-month period. The loans were secured by the balance in the participant's account and bore interest at rates as specified in the Plan document. The Trustee determined the appropriate interest rate based on interest rates for loans of comparable quality and duration extended by banks and other financial institutions in the business of lending money for loans under similar circumstances. The notes were repayable ratably through periodic payroll deductions over a term not exceeding five years, or ten years for loans used for the purchase of a primary residence. These loans were subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC. Participants who rolled their investment balances into the HGV plan were also able to roll their outstanding loans.

2. Summary of Significant Accounting Policies

Basis of Accounting

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 205-30, *Presentation of Financial Statements: Liquidation Basis of Accounting*, requires an entity to prepare its financial statements using the liquidation basis of accounting when liquidation is imminent. The Plan implemented ASC 205-40 for the 2021 plan year as this is when liquidation was determined to be imminent. Therefore, the accompanying financial statements have been prepared on a liquidation basis of accounting as of October 18, 2022 and December 31, 2021, and for the period from January 1, 2022 through October 18, 2022. The adoption did not have a material impact on the financial statements.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make certain estimates and assumptions that affect reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ materially from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan were reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well during the year.

Notes Receivable from Participants

Notes receivables from participants were measured at the unpaid principal balance plus unpaid accrued interest. The Plan classified all participant loans with no payments received for 6 months as in default. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits. During 2022, \$12,027 were recorded as deemed distributions.

Payment of Benefits

Benefits were recorded when paid.

Subsequent Events

The financial statements and related disclosures include an evaluation of events up through and including April 18, 2023, which is the date the financial statements were available to be issued.

3. Certified Investment Information

The plan administrator has elected the method of annual reporting compliance permitted by ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements is complete and accurate.

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of October 18, 2022 (liquidation basis) and December 31, 2021 (in liquidation).
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period from January 1, 2022 through ended October 18, 2022 (liquidation basis).
- Investment information included in Note 4.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Fund: The Plan holds shares in a stable value fund, which is a form of common collective trust fund composed primarily of fully benefit-responsive investment contracts. Due to Plan termination, management has determined that it is probable the fund will sell for an amount different from the reported NAV and has classified the investment as Level 2. Participant transactions (purchases and sales) could occur daily. The Plan's termination allowed for sufficient notification to the issuer to ensure that securities liquidations were carried out in an orderly business manner.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although plan management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following tables set forth the Plan's investments by level within the fair value hierarchy.

5. Related Party Transactions and Party-in-Interest Transactions

Prior to liquidation, the Plan's investments were managed by an affiliate of the Trustee of the Plan, and therefore, these transactions qualified as party-in-interest transactions. The Plan paid for third party administrator fees, investment advisory, and plan audit fees which qualified as party-in-interest transactions. The administrative expenses totaled \$186 for the period from January 1, 2022 through October 18, 2022. Notes receivable from participants were also considered exempt party-in-interest transactions.

6. Plan Termination

The Plan has terminated effective July 31, 2021. All assets were distributed or transferred out on October 18, 2022.

7. Tax Status

The Plan adopted the Fidelity Volume Submitter Defined Contribution Plan, which received a favorable opinion letter from the IRS dated March 31, 2014, which stated that the prototype plan is in compliance with applicable sections of the Code. Although the Plan has since been amended, the Plan Administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for federal or state income taxes was included in the accompanying financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.
