Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Tegra118 401(k) Retirement Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of April 30, 2022 and December 31, 2021, the related statements of changes in net assets available for benefits for the period ended April 30, 2022 and the year ended December 31, 2021, and the related notes to the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of plan

The following description of the Tegra118 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

General - The Plan was created on January 1, 2021 and was a defined contribution plan sponsored by Tegra118 Wealth Solutions, Inc. (the “Company”), for the benefit of its fulltime employees. Employees were eligible to participate upon hire. Union employees, nonresident aliens, leased employees, residents of Puerto Rico, interns, temporary employees, seasonal, and part time employees who worked less than 30 hours a week are excluded from participation in the Plan. Participants could enter the Plan on the first payroll coinciding with or following the date of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan was administered by the Company’s Retirement Plan Committee (“Committee”), which was a committee made up of members of management of the Company. The Committee had overall responsibility for the operation and administration of the Plan. The Committee, along with the investment advisor, determined the appropriateness of the Plan’s investment offerings and monitored investment performance.

Plan merger - Effective April 1, 2022, the Plan merged into the InvestCloud, Inc. 401(k) Plan (EIN 32-0412640, Plan #001) as discussed in Note 9.

Contributions - Each year, participants could contribute up to 75% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who made contributions to the Plan, were allowed to make catch-up contributions as defined in the Plan. Participants directed the investment of all contributions into various investment options offered by the Plan. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 8% percent of eligible compensation. The automatic deferral percentage would increase by 1% per year up to a maximum of 15% of eligible compensation. The Company may contribute a discretionary matching contribution to the Plan. For the period ended April 30, 2022 and for the year ended December 31, 2021, the Company contributed 25% of the first 8% of base compensation that a participant contributed to the Plan. Contributions were subject to certain Internal Revenue Code (“IRC”) limitations.

Participant investment account options - The Plan offered various mutual funds, common collective trusts, and a self-directed brokerage account as investment options for participants. Each investment option had its own investment strategy, which could be obtained through the prospectus of the respective fund. Participants could change their investment options at any time.

Participant investment account options (continued) - The FiServ Stock Fund, which primarily consisted of FiServ, Inc. common stock, was transferred into the Plan as part of the plan transfer as described in Note 8. Participants were prohibited from purchasing additional shares or transferring into the FiServ Stock Fund.

Participant accounts - Each participant's account was credited with the participant's contribution and allocations of (a) the Company matching contributions (if any) and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account.

Vesting - Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 100% vested after 2 years of credited service.

Notes receivable from participants - Participants could borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bear interest at rates which were commensurate with local prevailing rates as determined by the plan administrator. Principal and interest were paid ratably through payroll deductions.

Payment of benefits - On termination of service due to death, disability or retirement, a participant could elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account. If the participant's vested benefit in the Plan did not exceed \$5,000, then the participant's benefit would be distributed as soon as administratively feasible without the participant's consent. If the participant made no election, then their account balance would automatically be rolled to an IRA. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump sum distribution, substantially equal installments, or partial withdrawals.

Forfeited accounts - At April 30, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$7,445, respectively. These accounts could be used to pay reasonable plan expenses or reduce future employer contributions. For the period ended April 30, 2022, employer contributions were reduced by \$12,687 from forfeited nonvested accounts. No forfeitures were used during the year ended December 31, 2021.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared on the accrual method of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants - Notes receivable from participants were measured at their unpaid principal balance plus accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded as of April 30, 2022 and December 31, 2021.

Payment of benefits - Benefits were recorded when paid.

Administrative expenses - Certain expenses of the Plan were paid by the Company and were not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation (depreciation) of fair value of investments.

(3) Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Trust Company LLC ("John Hancock"), the trustee of the Plan, has certified that the following data included in the accompanying financial statements are complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Dividends
- Interest income on notes receivable from participants

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

(4) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2022 and December 31, 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations would be carried out in an orderly business manner.

Stable value common collective trust: A stable value fund that was composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

FiServ stock fund: The FiServ Stock Fund consisted mainly of FiServ, Inc. common stock, and cash equivalents which provided liquidity for trading. These investments are valued at the closing price reported on the active market on which the individual securities are traded.

Self-directed brokerage account: In addition, participants could invest in publicly traded securities, mutual funds, and other securities through a self-directed brokerage account. The following additional investments were held in the self-directed brokerage account:

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Interest-bearing cash: Stated at cost, which approximates fair value.

As of April 30, 2022, there were no investments held by the Plan as a result of the plan merger as discussed in Notes 1 and 9.

- (b) All participating plan directed withdrawals would be funded no later than 12-months from the date that withdrawal instructions were received by the Trustee.
- (c) The fund required the plan sponsor to provide advance written notice of 5 business days for the plan sponsor directed withdrawals which would exceed \$1 million or 10% of the assets invested in the Fund.
- (d) The fund required the plan sponsor to provide advance written notice of 5 business days for the plan sponsor directed withdrawals which would exceed \$1 million.

(5) **Related party transactions and party-in-interest transactions**

Certain Plan investments were units of a stable value fund managed by John Hancock. John Hancock is the trustee for the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services were included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third party administrator of \$11,376 and \$30,420 for the period ended April 30, 2022 and year ended December 31, 2021, respectively, which were not covered by revenue sharing. The Plan Sponsor paid directly any other fees related to the Plan's operations.

(6) **Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

(7) **Tax status**

The Internal Revenue Service ("IRS") had determined that the pre-approved profit sharing plan was designed in accordance with applicable sections of the IRC and informed the recordkeeper of such in a letter dated June 30, 2020. The plan administrator has adopted the pre-approved plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

(8) Transfer in

The Company was created by carving FiServ Investment Services from FiServ, Inc. After the Company set up the Plan effective January 1, 2021, the previous employees of FiServ, Inc. transferred their account balances into the Plan. Effective January 11, 2021, participant accounts totaling \$90,100,682 were transferred from the FiServ 401(k) Savings Plan to the Plan.

(9) Plan merger

Effective April 1, 2022, the Plan merged into the InvestCloud, Inc. 401(k) Plan (EIN 32-0412640, Plan #001). As a result of the plan merger, assets of \$97,081,226 were transferred out of the Plan.

(10) Subsequent events

The Plan had evaluated subsequent events through April 12, 2023, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
