INDEPENDENT AUDITORS' REPORT

To the Trustee(s) and Plan Participants
Growers Express, LLC 401(k) Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements

We have performed an audit of the financial statements of Growers Express, LLC 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Notes 1 and 2 to the financial statements, the Plan Administrators of Growers Express, Inc. authorized the termination of the Plan effective August 31, 2022 and management determined liquidation is imminent. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the 2022 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the 2022 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2022 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Auditor's Report on the 2021 Financial Statements

The financial statements of Growers Express, LLC 401(k) Plan and Trust as of and for the year ended December 31, 2021 were audited by Hayashi Wayland LLP, whose partners and professional staff joined CliftonLarsonAllen LLP as of November 1, 2022 and has subsequently ceased operations. In their report dated July 5, 2022, they expressed an opinion that (a) the amounts and disclosures in the 2021 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America and (b) the information in the 2021 financial statements and supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C) and (c) the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, was presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS
OCTOBER 31, 2022 AND DECEMBER 31, 2021

NOTE 1. DESCRIPTION OF PLAN

The following description of the Growers Express, LLC 401(k) Plan and Trust (the Plan) is for general information purposes only. Participants should refer to the plan document for more complete information.

General – The Plan is a defined contribution plan adopted January 1, 2016 that covers substantially all employees of Growers Express, LLC (the Company) who are 18 years of age or older. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective August 31, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination – Upon the merger of the Company with B&G Foods, Inc. during 2022, the Board of Directors of the Company authorized the termination of the Plan effective August 31, 2022. In connection with the termination of the Plan, all participants with an account balance, became fully vested in all contribution sources, regardless of status or years of vested service. The Plan’s termination also ceased employee and Company contributions into the Plan and ceased new participant notes receivable from the Plan. Participants were provided the option to receive a distribution of their account balance or the Plan administrator authorized a rollover of their account balance into an IRA without the participant’s consent. All Plan assets were distributed as of October 31, 2022.

Contributions – Eligible participants may contribute, by voluntary payroll deductions, up to the maximum allowed by sections 404, 415, 402(g) and 401(k) of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make a discretionary matching contribution and a discretionary non-elective contribution in an amount determined by the Company. For the period and year ending October 31, 2022 and December 31, 2021, the Company did not make matching or non-elective contributions. The Company adopted safe-harbor provisions, which provides for matching contributions equal to 100% of the participants’ salary deferrals that do not exceed 4% of their compensation for the same period. The Plan allows participants to make Roth deferrals.

Participant Accounts – Each participant’s account is credited or debited with (1) the participant’s contributions by payroll deduction, (2) the participant’s portion of employer matching, (3) a portion of the net increase or decrease in the net value of the Plan investments, which bears the ratio of the total amount of each participant’s account in this fund to the aggregate of the balances of all participants’ accounts immediately before the quarterly adjustment, and (4) any loans made to or repaid by the participant. The allocation of Plan earnings is determined by using the valuation of trust assets on a daily basis.

Vesting – Participants are immediately vested in their voluntary contributions and employer matching contributions plus actual earnings thereon.

Payment of Benefits – Upon termination, retirement, death, or disability, a participant or participant’s beneficiary may receive a lump-sum distribution equal to the value of his or her account.

NOTE 1. DESCRIPTION OF PLAN (Continued)

Participant Investment Options – Participants are allowed to invest in a variety of investment choices as more fully described in the Plan’s literature. Participants may change their allocation on a daily basis.

Notes Receivable from Participants – Loans are available to all participants as described in the Plan’s loan policy. Participants may apply to borrow from the Plan a minimum amount of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loans fund. Most loan funds may be repaid over any reasonable period, not to exceed the fifth anniversary of the date the funds were borrowed, with the exception of loans used for the purchase of a principal residence, which can be repaid over a period of up to 30 years. The loans are secured by the balance in the participant’s account and bear interest at the Prime Rate plus one percent as published by any Federal Reserve Bank as of the date of the loan. Interest rates ranged from 4.25% to 6.50%. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts – As of October 31, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$–0– and \$7,032, respectively . For the period January 1, 2022 through October 31, 2022, forfeitures of \$2,025 were used to reduce administrative expense. The forfeiture account balance of \$5,054 was allocated to participants as part of the Plan Termination.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – Effective August 31, 2022, the Board of Directors of Growers Express, Inc. authorized the termination of the Plan and management determined liquidation is imminent. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements.

Under the liquidation basis of accounting, assets are stated at their estimate net realized cash value and liabilities are stated at their anticipated settlement amounts. The Plan held no assets as of October 31, 2022. There were no material adjustments to the financial statements as a result of the change to the liquidation basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Valuation of Investments and Income Recognition – Investments are stated at fair value as reported by the Plan Trustees. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation / (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits – Benefits are recorded when paid.

Plan Expenses – Expenses to administer the Plan, if not paid by the sponsor, may be paid by the Plan, and certain fees are allocated to the individual participant accounts.

Subsequent Events – The Plan has evaluated subsequent events through January 26, 2023, the date the financial statements were available to be issued.

NOTE 3. CERTIFIED INFORMATION

For the period ending October 31, 2022, the Plan funds are held by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively Empower, formerly Great-West), the Plan Trustees. For the year ending December 31, 2021, the Plan funds are held by Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC (collectively Great-West), the Plan Trustees. All investment information disclosed in the accompanying financial statements, including investments held and notes receivable from participants at October 31, 2022 and December 31, 2021 and interest, dividends, and net appreciation/ (depreciation) in fair value of investments for the period and year then ended were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan trustees.

The Plan trustees also certified to the completeness and accuracy of \$(1,925,235) and \$933,965 of net (depreciation) / appreciation in the fair value of investments and \$52,461 and \$391,280 of interest and dividends related to the aforementioned investments and notes receivable from participants for the period and year ended October 31, 2022 and December 31, 2021, respectively.

NOTE 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2022 and December 31, 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed investment contracts: Value at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

NOTE 4. FAIR VALUE MEASUREMENTS (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are invested in funds held by Empower and Great-West, the trustees, and therefore, these transactions qualify as party-in-interest transactions. Fees paid to the plan recordkeepers, Empower and Great-West, also qualify as party-in-interest transactions and amount to \$39,573 and \$42,393 for the period and year ended October 31, 2022 and December 31, 2021, respectively.

NOTE 6. TAX STATUS

Effective December 15, 2019, the Plan adopted a non-standardized form of a prototype plan sponsored by Great-West Trust Company, LLC. The prototype plan provider has received an opinion letter from the Internal Revenue Service as to the prototype plan’s qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Variations in the timing of the recognition of certain transactions affecting the Plan have resulted in differences between the financial statements and the Internal Revenue Service Form 5500. The following is a reconciliation of these differences:
