### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements**

We have performed an audit of the accompanying financial statements of the Symbol Mattress 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of May 3, 2022 (Liquidation Basis) and December 31, 2021 (Ongoing) and the related statement of changes in net assets available for benefits for the period January 1, 2022 to May 3, 2022 (Liquidation Basis), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of and for the period ended May 3, 2022 and December 31, 2021, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### **Opinion on the Financial Statements**

Participants were notified of the merger on January 19, 2022 and all Plan assets were transferred from the Plan on May 3, 2022. Our opinion is not modified with respect to this matter.

### Notes to Financial Statements

#### 1. Description of Plan:

The following description of the Symbol Mattress 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement or summary plan description for a more complete description of the Plan's provisions.

**Plan Merger:** The Plan was merged and all of its assets were transferred to the Corsicana Bedding, LLC 401(k) Plan effective May 3, 2022. Therefore, the Plan has changed its basis of accounting to the liquidation basis used in presenting the 2022 financial statements.

**General:** The Plan was a defined contribution plan covering all eligible employees of Eastern Sleep Products Company doing business as Symbol Mattress and subsidiaries (the "Company"). Employees became eligible to participate after completing one year of service, during which they have completed at least 1,000 hours of service. Employees were eligible for entry to the Plan on the first day of the quarter coinciding with or next following the date on which such requirements were satisfied. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** The Plan provided for participant contributions of pre-tax annual compensation, as defined in the Plan. The Company may make matching contributions as determined annually by the Company's Board of Directors. The Company may contribute additional amounts at the option of the Board of Directors. Participants of qualifying age may make additional "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions were subject to certain limitations.

**Participant Accounts:** Each participant's account was credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations were based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options:** Participants could direct John Hancock Life Insurance Company, the custodian, as to the investment of their account balances in accordance with guidelines established by the Plan. Participants could change their investment elections at any time.

**Vesting:** Participants were immediately vested in their contributions, plus actual earnings thereon. A participant was vested in the Company's contributions 20% after 2 years, 40% after 3 years, 60% after 4 years, and 100% after 5 years of credited service.

#### 1. Description of Plan, Continued:

**Notes Receivable from Participants:** Participants could borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms could not exceed five years, unless the proceeds are used to acquire a principal residence. The loans are secured by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the plan administrator. Principal and interest were paid ratably through payroll deductions. Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant did not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan document.

**Plan Administration:** Overall responsibility for administering the Plan rests with the Company. Participant accounts were administered by John Hancock Life Insurance Company.

**Payment of Benefits:** Distribution of the vested portion of a participant's account occurred upon the participant's termination of service, retirement, death, disability, or hardship withdrawal, as defined in the Plan. A participant was entitled to receive a lump-sum payment in an amount equal to the vested value of his or her account.

**Forfeitures:** Forfeited balances of terminated participants' non-vested accounts were used to reduce Company contributions or pay administrative expenses. Forfeiture additions were \$8,154 and \$7,774 for 2022 and 2021, respectively. No forfeited amounts were used to reduce employer contributions or pay administrative expenses during the period January 1, 2022 to May 3, 2022. During 2021, \$815 was used to reduce employer contributions and pay administrative expenses. Forfeitures available and transferred to the Corsicana Bedding, LLC 401(k) Plan on May 3, 2022 were \$37,861. Forfeitures available were \$29,707 at December 31, 2021.

#### 2. Summary of Significant Accounting Policies:

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual method of accounting for the year ended December 31, 2021. In 2022, the accompanying financial statements were prepared using the liquidation basis of accounting. The liquidation basis of accounting requires the plan to accrue costs and income that it expects to earn through the end of its liquidation if and when it has a reasonable basis for estimation.

**Payment of Benefits:** Benefits were recorded when paid.

#### 2. Summary of Significant Accounting Policies, Continued:

**Use of Estimates:** The preparation of financial statements in conformity with the liquidation basis of accounting and generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition:** Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment gain (loss) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Subsequent Events:** Management has evaluated subsequent events through April 5, 2023, the date the financial statements were available to be issued, and has determined that there are no subsequent events to be reported in the accompanying financial statements.

#### 3. Fair Value Measurements:

The Plan follows Financial Accounting Standards Board ("FASB") guidance on fair value measurements. The provisions of the guidance provides a framework for measuring fair value under generally accepted accounting principles ("GAAP") and defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. This guidance requires that valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. This guidance also establishes a fair value hierarchy which prioritizes the valuation inputs into three broad levels.

Based on the underlying inputs, each fair value measurement in its entirety is reported in one of three levels:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology are quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable active markets.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### 3. Fair Value Measurements, Continued:

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments measured at fair value:

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common/collective trust:** Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with subtopic 820-10, these Plan assets were measured at the net asset value per share (or its equivalent) as a practical expedient and have not been included in the fair value hierarchy. #### 4. Administrative Expenses:

Although not required by the Plan, a portion of the costs of the Plan administration is absorbed by the Company. The Plan paid administrative fees totaling \$8,498 during 2022.

#### 5. Risks and Uncertainties:

The Plan provided for various investments in a money market fund, mutual funds, and common/collective trusts. Investments were exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

#### 6. Tax Status:

The Internal Revenue Service has determined by a letter dated March 31, 2014 that the adopted prototype plan is designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan was designed and operated in accordance with the applicable requirements of the Internal Revenue Code.

Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at May 3, 2022 and December 31, 2021. The Plan is not currently under audit by any jurisdiction.

#### **7. Plan Termination:**

The Company elected to discontinue its contributions effective January 1, 2022 and to terminate the Plan subject to the provisions of ERISA. At the time of Plan termination, participants became 100% vested in their accounts. The Plan's assets were transferred to the Corsicana Bedding, LLC 401(k) Plan effective May 3, 2022.
