Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were unable to gain an understanding of the Plan's internal controls and determine whether they were operating properly due to the departure of key personnel after the acquisition of Kadmon Corporation, the Plan sponsor.

Emphasis of Matter

As discussed in Note 1, on November 9, 2021, the Plan sponsor, Kadmon Corporation, merged with Sanofi. As of March 7, 2022, the Plan became a Participating Affiliate of the Sanofi U.S. Group Savings Plan. As a result, effective September 30, 2022, all investments were transferred from the Plan into the Sanofi U.S. Group Savings Plan.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Kadmon Corporation, LLC Tax Deferred Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Kadmon Corporation, LLC Tax Deferred Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Kadmon Corporation, LLC Tax Deferred Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule of Assets (Held at End of Year) for the period ended September 30, 2022 and Schedule of Assets (Acquired and Disposed of Within Year) are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that

agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion

- the form and content of the supplemental schedules, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS
September 30, 2022 and December 31, 2021

1. Plan Description

The following description of the Kadmon Corporation, LLC (Company) Tax Deferred Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan consisting of a deferred 401(k) plan and a Roth deferral plan with employer matching contributions for eligible employees. Eligible employees may participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

The provisions of the Plan provide that, in general, any person age 21 or older, employed by the Company and having withheld federal Social Security taxes, will be eligible to participate in the Plan. However, residents of Puerto Rico and employees covered by a collective bargaining agreement are not generally eligible to participate in the Plan. Eligible employees may elect to participate in the Plan as of the first day of the month coincident with or next following the completion of three months of service with the Employer.

Contributions

Employee Contribution

Each year, participants may contribute their pretax annual compensation in a range between one (1%) percent to seventy-five (75%) percent, as defined in the Plan, with a maximum of \$20,500 and \$19,500 for the period ended September 30, 2022 and year ended December 31, 2021, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds ranging from fixed-income, equity, money market, and a blend of fixed-income and equity portfolios for participants. The maximum pretax catch-up contribution was \$6,500 for the period ended September 30, 2022 and year ended December 31, 2021, respectively.

Employer Contribution - Non-Discretionary

The Company is required to make a non-discretionary matching contribution to non-highly compensated participants, in an amount equal to 100% of deferral contributions subject to a maximum of 6% of eligible compensation contributed to the Plan. For purposes of defining non-highly compensated participants, the Plan defers to the Internal Revenue Code requirements. Participants must be employed as of the last day of the contribution period. Contributions allocated to a participant are credited to a Plan account established on behalf of the participant. Participants direct the investment of these contributions.

Employer Contribution - Discretionary

The Company may make an annual discretionary basic matching employer contribution on behalf of each participant who is employed on the last day of the Plan year. The Company made no discretionary matching contributions for the period ended September 30, 2022 and year ended December 31, 2021, respectively.

Vesting

Participants are vested immediately in their elective deferral contributions plus actual earnings, thereon. Plan participants acquire a nonforfeitable (vested) right in employer matching contributions (plus any related earnings) allocated to their Plan accounts based on years of continuous service with the Employer. A participant becomes 20% vested after completion of one full year of service 40% after two years, 60% vested after three years, 80% vested after four full years, and 100% vested after five full years of service. Participants are also 100% vested in employer matching contributions (plus any related earnings), regardless of service, upon reaching age 65, permanent disability or death, or in the event of a Plan Termination.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses, if any, that are paid by the Plan. Allocations are based on participant earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Employees are entitled to an annual payment of benefits beginning at normal retirement age 65 or no later than age 70 ½, based on the value of the participant's vested interest in their account. On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive their benefits in the form of a lump-sum payment. If employees terminate before rendering five years of service, they forfeit the right to receive the Company's contribution and earnings portion of their accumulated plan benefits based on the vesting schedule noted above. Employees will receive the value of their accumulated plan benefits as a lump-sum distribution upon retirement or termination if the value of their account is less than \$1,000.

Investment Options

Upon enrollment in the Plan, participants are offered a variety of investment options in a selection of mutual funds. The selection of mutual funds offered range from fixed-income, equity, money market and a blend of fixed-income and equity portfolios. The selection of investment options are made at the discretion of the participant.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the amount to which the participant is vested. Loans are considered investments of the account of the participant to whom the loan is granted. All loans must be for a hardship purpose. Loan terms can range up to 5 years or up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate which is commensurate with prevailing rates as determined by the plan administrator. Principal and interest is paid through bi-weekly payroll deductions.

Forfeited Accounts

At September 30, 2022 and December 31, 2021, forfeitures in non-vested accounts totaled \$133,818 and \$84,096, respectively.

Forfeitures may first be used to pay administrative expenses, if so directed by the Company, any remaining forfeitures will be used to reduce employer contributions. Forfeitures used to offset employer contributions for 2022 and 2021 were \$47,057 and \$88,418, respectively. No forfeitures were used to pay administrative fees.

Merger

On November 9, 2021, the Plan sponsor merged with Sanofi. As of March 7, 2022, the Plan became a Participating Affiliate of the Sanofi U.S. Group Savings Plan. As a result, effective September 30, 2022, all investments were transferred from the Plan into the Sanofi U.S. Group Savings Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when they are incurred. As of September 30, 2022 and December 31, 2021, no allowance for credit losses has been recorded. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan document.

In-Service Withdrawals

Employees can withdraw all or part of their vested account balance once they reach age 59 ½.

Payment of Benefits

Upon retirement, disability, death, or termination of service, a participant is eligible to receive a lump-sum amount equal to the value of the vested interest in his or her account. Other withdrawals from participants' account balances may be made under certain circumstances, as defined in the plan document. Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Investment and Security Transactions

The Plan's investments are stated at fair value. All Plan assets were transferred to the Sanofi U.S. Group Savings Plan before close of business on September 30, 2022.

Subsequent Events

The Plan has evaluated subsequent events through April 12, 2023, the date the financial statements were available to be issued.

3. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- Level 1 inputs consist of quoted prices in active markets for identical assets or liabilities.
- Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 inputs are unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.
- No assets were measured at fair value using Level 2 or 3 inputs as of September 30, 2022 and December 31, 2021, respectively.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2022, in comparison to prior years.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are actively traded. The funds are a mix of income and growth.

4. Financial Information Certified by Trustee (Unaudited)

The September 30, 2022, and December 31, 2021, Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the nine-months ended September 30, 2022, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Trustee in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$0 and \$23,309,189 at September 30, 2022, and December 31, 2021, respectively, and related losses of \$5,409,007 for the nine-month period ended September 30, 2022.

5. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. Per the definitive merger agreement, Sanofi has requested the Company terminate the Plan upon closing of the merger. To the extent that the 401(k) Plan is terminated pursuant to Parent's request, Covered Employees shall be eligible to participate in a 401(k) plan maintained by Parent or the Surviving Corporation as promptly as practicable following the Closing Date, and Parent or the Surviving Corporation shall take commercially reasonable efforts to effect a direct rollover of any eligible rollover distributions (as defined in Section 402(c)(4) of the Code), including any outstanding loans, to such 401(k) plan maintained by Parent or the Surviving Corporation with respect to each such Covered Employee.

6. Rollover Contribution

Participants may contribute amounts representing distribution from other eligible retirement plans.

7. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$1,240 for the period ended September 30, 2021. The Company is the plan administrator and is responsible for the management and administrative duties of the Plan.

8. Tax Status

Since the Plan is a prototype Plan, the related Trust obtained its latest determination letter on March 31, 2008, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, was in accordance with the applicable requirements of the Internal Revenue Code. Although, the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified and the related trust is tax-exempt.

9. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Company is closely monitoring the global outbreak of the novel coronavirus (COVID-19). We are unable to determine the ultimate severity of duration of the outbreak or its effect on among other things, the global, national or local economy. To date, COVID-19 has not had a material adverse impact to the Company's business or the Plan.

10. Reconciliation of Financial Statements to Form 5500

11. Recent Changes in Audit Standard

The Audit Standards Board (ASB) of the American Institute of Certified Public Accountants (AICPA) changed the audit standards applicable to audits of financial statements of employee benefit plans subject to ERISA for plan years ending after December 15, 2021.

The new standards set forth in Statement on Auditing Standards (SAS) No. 136, refer to limited-scope audits as "ERISA Section 103(a)(3)(C) audits," and include a new audit report format. Instead of disclaiming an opinion, in an ERISA Section 103(a)(3)(C) audit an auditor must provide an opinion on audit areas that are not certified and perform limited procedures on investments. The new standards require ERISA Section 103(a)(3)(C) audit reports to comply with more extensive content requirements and include sections that address the auditor's opinion, the basis for their opinion, the responsibilities of plan sponsors for financial statements, and the responsibilities of the auditor for the audit of financial statements.
