## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
Pilgrim Parking, Inc. 401(k) Profit Sharing Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Pilgrim Parking, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statement of Net Assets Available for Plan Benefits as of December 31, 2022 (in liquidation) and 2021 (ongoing), and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### **Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 4 to the financial statements, the Directors of Pilgrim Parking, Inc. (the Employer) approved a plan of liquidation on April 30, 2022, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going concern basis using in presenting the 2021 financial statements to the liquidation basis of accounting using in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**1. Description of Plan**

The following description of the Pilgrim Parking, Inc. 401(k) Profit Sharing Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a participant-directed defined contribution 401(k) plan covering all employees of Pilgrim Parking, Inc. (the Employer). Employees are eligible to participate in the Plan effective with the first day of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is maintained by an administrator and a trustee. The administrator maintains participant account records and instructs the trustee to execute transactions such as benefit payments to participants. The trustee reports to the Plan's management regarding investments and changes in those investments.

Effective April 30, 2022, the Directors of the Employer voted to terminate the Plan. See Note 4 for additional information. The following is a description of the Plan prior to termination.

***Contributions***

Participants may elect to contribute a percentage of their compensation not to exceed the maximum salary reduction contribution permitted by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other tax qualified plans (rollovers).

The Employer may make discretionary matching contributions based on participant deferral contributions made during each plan year provided that the participant has attained three months of service. For the year ended December 31, 2022, the Employer elected to contribute 50% of the first 5% of participants' eligible compensation deferred into the Plan, which totaled \$24,210.

The Employer may also make special discretionary profit sharing contributions to participants who are 20½ years of age or older and have completed one year of service. For the year ended December 31, 2022, the Employer did not make a special discretionary profit sharing contribution to the Plan.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and their allocation of the Employer's discretionary matching and special discretionary profit sharing contributions, the Plan's earnings and losses, and investment expenses. The allocation of earnings and losses is performed based on individual participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions, Employer discretionary matching contributions and actual earnings thereon. Participants become vested in Employer special discretionary profit sharing contributions and actual earnings thereon as follows: 20% after 2 years, 40% after 3 years, 60% after 4 years, 80% after 5 years and 100% after 6 years of employment. In the event of death or disability, participants shall immediately become 100% vested in their account. In conjunction with the Plan termination effective April 30, 2022, all participants became 100% vested in their entire account balances.

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested value of their account. Loan terms can be up to five years, or up to 10 years for the purchase of a primary residence. The notes are secured by the vested balance in the participant's account and bear interest equal to regional bank rates for similar loans or such other reasonable rate as set by the Plan Administrator. Principal and interest is repaid ratably through payroll deductions.

***Payment of Benefits***

Benefits are available for distribution upon retirement, death or disability in a single lump-sum distribution. In the event of termination for any reason other than retirement, death or disability, payment of vested benefits will be made by the Plan Administrator in accordance with the procedures described in the Plan. Participants who have attained age 59½ may elect to withdraw all or a portion of their vested account while still employed. If a participant's vested balance is less than \$1,000, the participant will receive an immediate cash-out of their vested account balance. If a participant's vested balance exceeds \$1,000 but is less than \$5,000, the amount will be rolled over to an individual retirement account designated by the Employer. Hardship withdrawals from the Plan are also permitted subject to the applicable IRS laws.

***Forfeitures***

Forfeitures are created when participants terminate employment before becoming fully vested in their accounts. As of December 31, 2022 and 2021, there were no forfeitures. Forfeitures are retained in the Plan and may be used to reduce Employer contributions payable or to pay administrative expenses of the Plan. Forfeitures in the amount of \$4,203 were used to reduce Employer contributions during the year ended December 31, 2022.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

As discussed in Note 4, Directors of the Employer approved a plan of liquidation on April 30, 2022, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going concern basis using in presenting the 2021 financial statements to the liquidation basis of accounting using in presenting the 2022 financial statements.

***Valuation of Investments and Income Recognition***

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

Purchases and sales of investments are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent participant notes receivable are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses was recorded as of December 31, 2021.

***Contributions***

Participant and Employer discretionary matching contributions are recorded weekly when the Employer remits the payroll deductions for investment into the Plan. Employer discretionary profit sharing contributions are recorded at the end of the year, if applicable.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest risk, market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside trustee's non-performance of its fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Money Market Fund:* The carrying amount of the money market fund is deemed to be valued at deposit amount plus accrued interest, as determined according to stated terms.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **4. Plan Termination**

The Plan was terminated on April 30, 2022. All participants become 100% vested in their account balances effective April 30, 2022. Participants were given the option to take a full cash distribution, rollover their account balance to an IRA or another qualified plan, or a combination of these options. As of November 1, 2022, the Plan assets were fully distributed, and no assets remained in the Plan.

**5. Income Tax Status**

The Plan is an adoption of a volume submitter plan document which received an advisory letter from the IRS dated June 30, 2020. The Plan has been amended since receiving the advisory letter in order to comply with the latest applicable tax laws and regulations. However, the Plan Administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Summary of Financial Information Certified by the Trustee**

The following is a summary of financial information and data certified by the trustee, Capital Bank and Trust Company:

**7. Related Party Transactions and Party-in-Interest Transactions**

Plan investments are held and managed by Capital Bank and Trust Company, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to Capital Bank and Trust Company for administrative services totaling \$15,454 for the year ended December 31, 2022. Participant notes receivable also qualify as party-in-interest transactions.
