Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Cambria Solutions, Inc. 401(k) Profit Sharing Plan Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As a result, in accordance with accounting principles generally accepted in the United States of America, Cambria Solutions, Inc. 401(k) Profit Sharing Plan Trust has changed its basis of accounting from the accrual basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

The accompanying statement of net assets available for benefits of the Cambria Solutions, Inc. 401(k) Profit Sharing Plan Trust (the Plan) as of December 31, 2021, were not audited, reviewed, or compiled by us and, accordingly, we do not express an opinion or any other form of assurance on them.

NOTE 1: DESCRIPTION OF PLAN

The following description of the Cambria Solutions, Inc. 401(k) Profit Sharing Plan Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed contribution plan covering all eligible employees of Cambria Solutions, Inc., Cassadyne Properties, LLC, and ML Staffing LLC (the Company) with retirement benefits in accordance with section 401(k) of the Internal Revenue Code (the IRC). The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA) provisions. The Plan was established on January 1, 2004.

Effective August, 16, 2022, the Plan sponsor, Cambria Solutions, Inc. was acquired by Ernst & Young LLP (EY U.S.). On August 24, Cambria Solutions, Inc. the plan terminated and announced the intention to transfer existing account balances into individual retirement accounts. The remaining net assets were directly transferred to Millennium Trust Co., LLC as of October 21, 2022.

Eligibility

To be eligible to participate in the Plan, employees must have reached the age of twenty-one and have completed one year of service with the Company. Part-time, temporary, or seasonal employees who works regularly more than 1,000-hour service during the relevant eligibility computation period are also eligible to the Plan. Eligible employees may participate in the plan on the first day of each month immediately following or coincident with the date the employee completes the eligibility conditions.

Contributions

Participant Contributions: Participants elect to have amounts withheld from their paychecks and contributed to the Plan by the Company. Participants who have attained age 50 before the plan year's end are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants are eligible to designate some or all of their deferral contributions as Roth contributions.

Eligible Automatic Contribution Arrangement (EACA): The plan includes automatic enrollment with a deferral rate of 3% of eligible compensations as pre-tax elective deferrals. The automatic deferral provisions apply to all current participants who have not entered into a Salary Deferral Election. A participant may apply for a permissible EACA withdrawal within 90 days of the first automatic deferral.

Contributions (continued)

Employer Contributions: The Company may make discretionary matching contributions and nonelective contributions in an amount as determined by the Company. To receive the Company's matching and nonelective contribution allocation, participants are required to complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan. Company contributions are made in the ratio that each participant's compensation bears to the compensation of all eligible participants.

All foregoing contributions are subject to limits as set by federal law.

Investment Options

Participants may direct the investment of all contributions into various investment options offered by the Plan and John Hancock Life Insurance Company (U.S.A).

Participant Accounts

Each participant's account is credited with the participant's own contributions, an allocation of the Company's contributions, and an allocation of net earnings from investments and changes in investment values. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on each participant's contributions, earnings, or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's account. Participants select the investments into which their contributions are invested.

Participant Loans

Loans to participants consist of promissory notes received from participants in exchange for the distribution of cash from the Plan. A participant is allowed to borrow a minimum of \$1,000, and the loan shall not exceed the participant's vested interest in the Plan. Loans must be repaid over no more than five years with the exception of a loan for the participant's principal residence that may have a repayment period beyond five years. A participant may only have a maximum of two loans outstanding at any time. Principal and interest are paid not less frequently than quarterly or ratably through payroll deductions. Loans to participants are stated at the principal amount outstanding, which approximates fair value.

Participants are always fully vested in their contributions and all earnings thereon. Vesting schedules in the Company's matching and nonelective contributions are below:

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may receive installments only if they are subject to lifetime required minimum distributions. Terminated participants whose balances are less than \$5,000 will be automatically distributed. For such balances exceeding \$5,000, subject to certain requirements, participants may leave their account balance in the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may request a withdrawal from their contribution accounts for financial hardship or after attaining the age of 59½. The distribution of the participant's account must commence no later than April 1 following the calendar year in which the participant attains age 72.

Forfeitures

Forfeitures of nonvested employer contributions if any shall be used to reduce employer contributions and can be applied to reduce administrative expenses charged to the Plan, for the plan year in which they occurred or thereafter. As of October 21, 2022, and December 31, 2021, there were \$0 and \$4,067, respectively in forfeiture nonvested accounts for future use.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with U.S. generally accepted accounting principles (U.S. GAAP). Certain prior period disclosures have been revised to conform to the current year's presentation. Effective August 10, 2022, the Plan committee adopted a resolution to terminate the Plan. As a result, the Plan's financial statements as of October 21, 2022, and for the period from January 1, 2022, through October 21, 2022, have been prepared on a liquidation basis, in accordance with U.S. GAAP. This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts. The estimated net realizable cash value for investments as of October 21, 2022, would be fair value. There were no material changes to the 2022 financial statements as a result of the change under the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions which affect the reported amounts of net assets available or benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisors, custodians, and the insurance company. See Note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis.

Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3: INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A) the custodian of the Plan, has certified as being complete and accurate the following information as of October 21, 2022, and for the period from January 1, 2022, to October 21, 2022.

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits
- Net depreciation in fair value of investments and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits
- Investments reflected on the schedule of assets (held at end of the year)

NOTE 4: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1) Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2) Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3) Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4: FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on October 21, 2022, and December 31, 2021.

Pooled separate accounts: These investments are public investment securities valued using the Net Asset Value (NAV) provided by the investment contract issuer. The NAV is quoted on a private market that is not active, however, the unit price is based on the underlying investments. A majority of the investments held by each fund are traded on an active market.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Net depreciation in fair value of investments includes net unrealized and net realized gains and losses on investments during the year and is presented net of investment expenses. Investment income is allocated to individual participant accounts based on the participant's investment fund share.

NOTE 5: PLAN TERMINATION

On August 10, 2022, the Plan sponsor, Cambria solution, Inc. began the termination process of the Plan. Subsequent to August 10, 2022, no contributions were allowed into the Plan. Shortly after the termination approval date, the Plan transferred remaining participants' balances to individual retirement accounts (IRA) with Millennium Trust Co., LLC as of October 21, 2022.

NOTE 6: PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by John Hancock Life Insurance Company (U.S.A). John Hancock Life Insurance Company (U.S.A) is the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Any purchase and sales of investments in the custodian are open market transactions at fair market value. Fees incurred by the Plan for investment management services are included in net depreciation in the fair value of investments.

These fees are paid to the investment fund manager and may include certain revenue-sharing fees that are paid to John Hancock Life Insurance Company (U.S.A), other investment custodians, and investment advisors. Additionally, the Plan sponsor, Cambria Solutions, Inc., is a party-in-interest to the Plan; however, there were no transactions with the Plan sponsor other than the funding of contributions to the Plan and payment of certain administrative expenses of the Plan. The Plan also allows for the issuance of notes receivable to participants in accordance with the related regulations. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 7: TAX STATUS

The Company has adopted the Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with CODA. The Internal Revenue Service ("IRS") has informed Associated Pension Consultants in a letter dated June 30, 2020, that its non-standardized pre-approved profit-sharing/money purchase plan is designed in accordance with applicable sections of the IRC, and any Plan sponsor adopting this form of the non-standardized pre-approved profit-sharing/money purchase plan will be considered to have a plan qualified under applicable sections of the IRC. Therefore, the Plan and related trust are tax-exempt, and once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified as a tax-exempt trust.

NOTE 7: TAX STATUS (CONTINUED)

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognizes tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2019.

NOTE 8: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
