Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TAEC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (an "ERISA 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets as of August 31, 2022 and December 31, 2021, and the related statement of changes in net assets for the period from January 1, 2022 to August 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of TAEC 401(k) Profit Sharing Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of August 31, 2022 and December 31, 2021, and for the period from January 1, 2022 to August 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of TAEC 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Merger

As discussed in Note 1 to the financial statements, in March 2022, Technology Associates EC Inc., the Plan's sponsor, was acquired by Phoenix Tower International Investments LLC ("PTI"), and on August 31, 2022, the investments of the Plan were liquidated and merged into the 401(k) retirement plan sponsored by PTI, effectively terminating the TAEC 401(k) Profit Sharing Plan at that time. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatements of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of TAEC 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1. DESCRIPTION OF PLAN

The following description of the TAEC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan was originally formed as an Internal Revenue Code ("IRC") Section 401(k) profit sharing plan covering substantially all full-time and part-time employees of Technology Associates International Corporation ("TAIC"), effective January 1, 2002, and was amended in 2011 to include substantially all full-time and part-time employees of Technology Associates EC Inc. ("TAEC" or the "Company"). The Plan was amended in 2012 to change the name of the Plan to TAEC 401(k) Profit Sharing Plan, change the sponsor of the Plan to TAEC, and remove TAIC as a participating employer. The Plan has been subsequently restated, including most recently in January 2022 to comply with the latest laws and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In March 2022, the Plan Sponsor was acquired by a third-party entity, Phoenix Tower International Investments LLC ("PTI"). In connection therewith, in July 2022, contributions were no longer permitted to be made to the Plan; however, employees became eligible to participate in a retirement savings plan sponsored by PTI. On August 31, 2022, the investments of the Plan were liquidated and merged into the Phoenix Tower International In 401(k) Profit Sharing Plan and Trust, the 401(k) retirement plan sponsored by PTI, thereby effectively terminating the TAEC 401(k) Profit Sharing Plan.

Eligibility

Employees are generally eligible to participate in the Plan on their date of hire but will not become participants of the Plan until they have reached their entry date, which is the first day of the month coincident with or next following their date of hire. There is no age or service requirement. The Plan excludes the following classes of employees from participation:

- union employees whose employment is governed by a collective bargaining agreement;
- certain nonresident aliens who have no earned income from sources within the US;
- leased employees;
- temporary employees whose jobs are of limited duration and have arisen due to special projects, abnormal workloads or emergencies and work less than 1,000 hours in the Plan year.

Participant Contributions

Participants may elect to contribute up to 100% of their eligible earnings on a pre-tax basis as allowed by the IRC. In addition, employees who are age 50 or older can elect to defer additional amounts (called "catch-up contributions") to the Plan up to the maximum allowed by the IRC. Participants may also contribute amounts representing rollover distributions from other qualified sources.

Employer Contributions

Employer contributions include the following components:

- a. Discretionary matching contributions
- b. Discretionary profit-sharing contributions

NOTE 1. DESCRIPTION OF PLAN (Continued)

To share in the allocation of any discretionary matching or discretionary profit-sharing contributions, which are determined each Plan year, an employee must be employed on the last day of the Plan year and have completed a year of service. A year of service is defined as having completed 1,000 hours of service during the Plan year, or for employees where records of actual hours of service are not maintained or available, credit will be determined on the basis of 45 hours per week ("1,000 hours of service equivalent").

Notwithstanding the preceding, participants who are not employed on the last day of the Plan year due to (i) death, (ii) total and permanent disability, or (iii) termination of employment on or after their normal retirement age or early retirement date, are eligible to share in allocations of any discretionary employer matching or profit-sharing contributions for that year.

For the period from January 1, 2022 to August 31, 2022, the Company made no discretionary matching or profit-sharing contributions to the Plan.

Participant Accounts

Participant accounts are credited with the participant's contributions, any employer contributions, and allocations of Plan earnings or losses, and are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Individual participant accounts are also charged for any loan and distribution fees incurred by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer contribution portion of their accounts is based on years of credited service. A participant vests at the rate of 20% for each year of credited service with the Company. Participants are credited with a year of service upon reaching 1,000 hours of service or the 1,000 hours of service equivalent during a Plan year.

Participants also become fully vested at their early retirement date, as defined, or in the event of their death or total and permanent disability.

Forfeitures

Forfeitures may be used to reduce employer contributions or pay administrative expenses. As of August 31, 2022 and December 31, 2021, forfeited, non-vested accounts totaled \$0.

Notes Receivable from Participants (Participant Loans)

Participants may borrow against their accounts a minimum of \$1,000 up to a maximum generally equal to the lesser of \$50,000 or 50% of their vested interests in their account balances. Under certain circumstances, participants may have up to two such loans outstanding at a time. Loans are required to be repaid within five years unless the loan is for the purchase of a principal residence of the participant, in which case the repayment period may extend up to 15 years. Loans are secured by up to half of the participant's vested account balance. The loans bear interest at fixed rates determined by the Plan administrator at the time of loan application at rates similar to those charged by commercial lending institutions. During the period from January 1, 2022 to August 31, 2022, the interest rate on outstanding notes receivable from participants was 3.25% to 4.75%. Principal and interest are paid regularly through payroll deductions.

Notes Receivable from Participants (Participant Loans) (Continued)

In April 2020, the Plan operationally implemented the provisions of the Coronavirus Aid, Relief, and Economic Security Act (the "CARES Act") (Note 8). Participants requesting relief under the CARES Act were permitted (i) an increased loan limit to the lesser of \$100,000 or 100% of the nonforfeitable account balance (available until September 23, 2020), and (ii) a delay in loan repayments due through December 31, 2020 for up to one year. In addition, the CARES Act waived loan origination fees through August 31, 2020 for such participants.

Payment of Benefits

Upon termination of service, retirement, death, disability, or attaining age 59½, a participant whose account balance is \$5,000 or more may generally elect to receive a lump sum amount equal to the value of his or her vested account balance, or to leave such funds on deposit in the Plan. Pursuant to the Setting Every Community Up for Retirement Enhancement Act of 2019 (the "SECURE" Act), which became law on December 20, 2019, participants may defer taking distributions as follows:

- If a participant reached the age of 70½ in 2019, the participant may defer receiving distributions until the later of April 1, 2020, or the April following the calendar year in which the participant retires;
- If a participant reaches the age of 70½ in 2020 or later, the participant may defer receiving distributions until the later of the April following the calendar year in which the participant reaches age 72 or retires.

Upon a participant's termination of employment, if the participant's vested account balance is between \$1,000 and \$5,000, and if the participant has not elected to receive a cash distribution or have his or her balance rolled over into an individual retirement account, the Plan may transfer the participant's account balance into an individual retirement account at the discretion of the Plan administrator. The Plan administrator, also at its discretion, may elect to distribute vested balances of less than \$1,000.

In addition, the Plan allows for hardship distributions from a participant's elective deferral and rollover account balances in accordance with Plan and IRC provisions. Effective January 1, 2019, the Plan no longer suspends elective deferrals after participants take hardship distributions.

As permitted by the CARES Act, the Plan implemented the following provisions for CARES Act related distributions: (i) participants may withdraw up to \$100,000 without a 10% early distribution penalty during 2020, (ii) distribution processing fees were waived through August 31, 2020, (iii) such distributions can be repaid within three years of the date of distribution, and (iv) required minimum distributions were temporarily suspended for 2020.

Corrective Distributions

Corrective distributions represent amounts refunded to certain participants for contributions made to the Plan in excess of amounts permitted pursuant to the nondiscrimination rules of the IRC.

Investment Options

In accordance with Plan provisions, participants may direct employee and employer contributions to any of the Plan's investment options.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United State of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Valuation of Investments and Recognition of Income and Loss

Investments are reported at fair value, except for the investment in the insurance company unallocated contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

The insurance company unallocated contract is a fully benefit-responsive investment contract which is reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 6 for further discussion of the insurance company unallocated contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation or depreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants (Participant Loans)

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of August 31, 2022 or December 31, 2021. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain of the Plan's administrative expenses, such as custodian/trustee, certain accounting, and legal expenses, are paid by the Company. Certain other accounting fees, as well as recordkeeping and other administrative fees, are paid by the Plan, as are certain distribution and loan fee expenses, which are paid by the transacting participants.

Income Tax Status

The Company adopted a pre-approved defined contribution plan and relies upon the pre-approved plan's opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS") which states its opinion that the plan and related trust are designed in compliance with the applicable requirements of the IRC. Although the Plan has since been amended, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of August 31, 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in process for any tax periods. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

Subsequent Events

Plan management has evaluated subsequent events through the date of the independent auditors' report, which is the date these financial statements were available to be issued.

NOTE 3. INFORMATION CERTIFIED BY THE CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at August 31, 2022 and December 31, 2021, and net appreciation or depreciation in fair value of pooled separate accounts, interest income from the insurance company unallocated contract, and interest income on notes receivable from participants for the period from January 1, 2022 to August 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard Insurance Company, the custodian of the Plan.

NOTE 4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Company provides administrative services for the Plan at no cost to the Plan and certain costs of the Plan's operating expenses are paid by the Company. In addition, Plan investments are managed by an affiliate of the record-keeper of the Plan, Standard Retirement Services, Inc. These transactions qualify as exempt party-in-interest transactions.

NOTE 5. FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs are unadjusted, quoted market prices in active markets for identical assets or liabilities at the measurement date.

Level 2 – Inputs are either directly or indirectly observable for the asset or liability through correlation with related market data at the measurement date and for the duration of the instrument’s anticipated life.

Level 3 – Inputs are both unobservable and significant to the overall fair value measurement for the asset or liability at the measurement date. These inputs reflect Plan management’s best estimate of what market participants would use in pricing the asset or liability at the measurement date. Consideration is given to the risk inherent in the valuation technique and the risk inherent in the inputs to the model.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2021. As of August 31, 2022, the Plan’s assets have been transferred to the Phoenix Tower International In 401(k) Profit Sharing Plan and Trust (Note 1).

Pooled separate accounts: Valued at the unit value of shares held by the Plan, based on the daily closing price reported by the underlying mutual fund less a management fee. The Plan’s investments are not themselves publicly traded, but are composed of assets that are priced directly by a mutual fund company trading partner.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. In addition, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6. GROUP ANNUITY CONTRACT WITH STANDARD INSURANCE COMPANY

The Plan has a group annuity contract with Standard Insurance Company (“Standard”), the Standard Stable Asset Fund A. Standard maintains the contributions in an unallocated general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals, contract fees, and other administrative expenses. The contract issuer is contractually obligated to repay the principal and any credited interest.

The Plan owns a promise to pay interest at crediting rates which are announced in advance and guaranteed for a specified period of time as outlined in the group annuity contract. The Standard Stable Asset Fund A is not considered a guaranteed investment contract, as it has no maturity date or penalty for early withdrawal and there are not any known cash flows that could be discounted, however, there is a stated minimum interest rate (floor) of 1.00%. Crediting rates for the contract are declared in advance and are reset quarterly using a process similar to that used by banks or other insurance companies for similar products. The crediting rate is based on the interest rate forecast for the investments underlying the account and considers yield forecasts from Standard’s internal asset advisory group, the margins required for its business, and requires the approval of Standard management. Past crediting rates are not indicative of future rates.

Certain events may limit the availability of the Plan to transact at contract value with Standard. Such events include termination of the contract, spinoffs, divestitures, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. Additionally, the Plan sponsor may terminate the contract at any time with 30 days advance written notice. Standard may terminate the contract with 30 days advance notice for reasonable cause including failure of the Company to abide by state and federal law. In connection with the Plan merger (Note 1), the Plan sponsor terminated the group annuity contract, which was subject to a nominal market value adjustment charge.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the accompanying financial statements.

NOTE 8. CARES ACT

In response to the effects of the coronavirus on the economy, in March 2020, Congress passed the CARES Act. The CARES Act provides temporary relief for retirement plan sponsors and participants with respect to employer contributions, distributions, and participant loans. The provisions of the CARES Act may be implemented operationally prior to formally amending the Plan document. The Plan has implemented certain relief provisions included in the CARES Act as disclosed in the preceding notes to the financial statements.
