Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of New York Dialysis Services, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 31, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 to July 31, 2022, and for the year ending December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the New York Dialysis Services, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 31, 2022 and December 31, 2021, and for the period from January 1, 2022 to July 31, 2022, and for the year ending December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Notes To Financial Statements

Note 1: Description Of Plan

The following description of the New York Dialysis Services, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of New York Dialysis Services, Inc. (the Company) who are eligible. Eligible employees become participants in the Plan following three months of continuous service. The Plan's entry dates are the first day of the month following the date in which an employee meets the eligibility requirements. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary matching contributions. For the period January 1, 2022 to July 31, 2022 and for the year ended December 31, 2021, the Company did not make matching contributions. The Company has the option of making additional discretionary profit sharing contributions. Contributions are subject to certain dollar limitations.

Participants' accounts - Each participant's account is credited or charged with the participant's contribution and allocations of the Company's discretionary contributions, if any, plan earnings (losses), payments, forfeitures, withdrawals, expenses, or other distributions made to or from such accounts during the period. Allocations are based on participant earnings or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account balance.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of continuous service; a participant is 100% vested after five years of credited service. Participant accounts become fully vested upon attainment of the normal retirement age of 65, upon death, or disability.

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans must be adequately secured and made in accordance with the terms of the Plan. Principal and interest is paid ratably through payroll deductions.

Note 1: Description Of Plan (Continued)

Payment of benefits - On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or elect to defer payment until a later date. However, management has discretion to automatically pay the entire balance if less than \$5,000 after subtracting rollover contributions.

Plan termination - On July 1, 2022, the Plan Sponsor, New York Dialysis Services, Inc., executed a resolution to merge the Plan into a successor plan which occurred on July 8, 2022. As of July 8, 2022, all account balances were distributed from the Plan in accordance with the terms of the merger.

Forfeited accounts - As of the period ended July 31, 2022 and year ended December 31, 2021, forfeited non-vested accounts were approximately \$-0- and \$9,000, respectively. These amounts were used to reduce future employer contributions or to pay plan expenses. For the period from January 1, 2022 to July 31, 2022, and for the year ended December 31, 2021, the Plan used \$4,161 and \$18,766, respectively, of the existing forfeiture balance to pay plan expenses.

Note 2: Summary Of Significant Accounting Policies

Investment valuation - Investments held by the Plan measured at contract value and at fair value using the net asset value per share (or its equivalent) as a practical expedient have not been categorized in the fair value hierarchy and a description of the hierarchy levels is not included in the disclosures.

The accompanying financial statements are presented on the accrual basis of accounting. Purchases and sales of securities are recorded on a trade-date basis with the gain or loss based upon the actual cost of the securities. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes receivable from participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Income taxes - The Plan is exempt from federal income tax under the Internal Revenue Code. Tax positions are evaluated and recognized in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities.

The Plan has adopted a volume submitter plan which has an opinion letter dated November 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Note 2: Summary Of Significant Accounting Policies (Continued)

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures. The application of these accounting principles involves the exercise of judgment and use of assumptions as to future uncertainties and, as a result, actual results could differ from these estimates. The Plan periodically evaluates estimates and assumptions used in the preparation of the financial statements and makes changes on a prospective basis when adjustments are necessary.

Presentation - Certain reclassifications, when applicable, are made to the prior year financial statement presentation to correspond to the current year's format. Reclassifications, when made, have no effect on total net assets available for benefits or changes in net assets available for benefits.

Note 3: Investments

The statements of net assets available for benefits, the investment activities included in the statements of changes in net assets available for benefits for the period and year ended July 31, 2022 and December 31, 2021, respectively, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Great West Trust Company, LLC (formerly Massachusetts Mutual Life Insurance Company), the Custodian of the Plan, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments and notes receivable from participants of \$-0- and \$4,784,238 at July 31, 2022 and December 31, 2021, respectively, and related investment income (loss) of \$(772,653) and \$580,734 for the period January 1, 2022 to July 31, 2022 and for the year ended December 31, 2021, respectively.

Note 4: Fair Value Measurements

The following is a description of the valuation methodology used for assets at fair value at December 31, 2021:

Pooled separate accounts with insurance company: Valued at the net asset value of the underlying pool of securities. The pooled separate accounts may be redeemed at any time.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan entered into an investment contract with Great West Trust Company, LLC (formerly Massachusetts Mutual Life Insurance Company). Great West Trust Company, LLC maintains the contributions in pooled separate accounts and a guaranteed investment contract, Guaranteed Interest Account. The account is credited with earnings associated with the underlying investments and charged for participant withdrawals and administrative expenses.

Note 4: Fair Value Measurements (Continued)

The Guaranteed Interest Account is included in the financial statements at contract value (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses). For example, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. However, the contract generally provides that withdrawals associated with certain events which are not in the ordinary course of fund operations, and are determined by the issuer to have a material adverse effect on the issuer's financial interest, will be paid with a market value adjustment to the contract value amount of such withdrawal as defined in the contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Units of the Guaranteed Interest Account may be redeemed at any time and the contract contains no withdrawal penalty provisions. The crediting interest rate on the Guaranteed Interest Account is based on an agreed-upon formula with the issuer, but cannot be less than 3%.

Note 5: Related Party Transactions

Certain fees for administrative services may be paid by the Company. Certain plan investments are managed by Great West Trust Company, LLC (formerly Massachusetts Mutual Life Insurance Company). Great West Trust Company, LLC is the Custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

Note 6: Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7: Commitments And Contingencies

The Plan follows the guidance for uncertainty in income taxes. As of July 31, 2022, the Plan believes that it has appropriate support for the income tax positions taken and to be taken on its returns based on an assessment of many factors including experience and interpretations of tax laws applied to the facts of each matter. The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits.

Note 8: Plan Merger

On July 8, 2022, New York Dialysis Services, Inc. 401(k) Plan transferred the assets of this plan into the Fresenius Medical Care North America 401(k) Savings Plan. As a result, investments and notes receivable from participants totaling \$3,915,609 were transferred from the Plan into the Fresenius Medical Care North America 401(k) Savings Plan.

Note 9: Subsequent Events

Subsequent events have been evaluated through May 1, 2023, which is the date the financial statements were available to be issued.


