INDEPENDENT AUDITORS' REPORT

To the Investment Committee and Management of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Stellar Solutions, Inc. Defined Benefit Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). The financial statements comprise the statement of net assets as of November 15, 2022 (liquidation basis) and December 31, 2021 (ongoing basis), and the related statement of changes in net assets for the period ended November 15, 2022 (liquidation basis) and the year ended December 31, 2021 (ongoing basis), statement of accumulated benefits as of December 31, 2021, and the related statement of changes in accumulated benefits for the year ended December 31, 2021 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the period ended November 15, 2022 (liquidation basis) and the year ended December 31, 2021 (ongoing basis), stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP"), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we: (a) exercise professional judgment and maintain professional skepticism throughout the audit, (b) identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Board of Directors of Stellar Solutions, Inc., the Plan's sponsor, voted on February 11, 2022 to terminate the Plan and liquidation occurred on November 15, 2022. As a result, the Stellar Solutions, Inc. Defined Benefit Plan & Trust used the liquidation basis of accounting in presenting the period ended November 15, 2022 financial statements. Our opinion is not modified with respect to this matter.

Notes to Financial Statements

November 15, 2022

Note 1 - Description of plan:

The following description of the Stellar Solutions, Inc. Defined Benefit Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

In February 2022, the Company and the trustees made the decision to terminate the Plan. The assets of the Plan were accordingly frozen as of that date. As of November 15, 2022, the Plan was fully terminated and all participant vested assets were rolled into individual retirement accounts (“IRAs”).

General - The Plan is a noncontributory defined benefit plan established in 2017 and amended and restated subsequently. The Plan covers all eligible employees of Stellar Solutions, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Company is the Plan administrator and retains the services of a third party to assist in the administration of the Plan. Through November 15, 2022, the Plan’s custodian was Vanguard Fiduciary Trust Company (“Vanguard”) and the third party administrator was Nicolas Pension Consultants, Inc.

Eligibility - All employees of the Company who have reached twenty-one years of age are eligible to participate in the Plan, except for certain members of collective bargaining units, leased employees, nonresident employees with no U.S. source income, individuals incorrectly determined not to be an employee, and owners of the Company born after 1957. Eligible employees may enter into the Plan upon meeting eligibility requirements.

Contributions - The Company has agreed to voluntarily contribute such additional amounts as are necessary to provide assets sufficient to meet benefits to be paid to participants as they come due. The Company’s present intention is to make annual contributions in amounts sufficient to fund the Plan’s current year service cost, the amortization of amendments, and actuarial gains and losses over the appropriate periods as well as interest on such items. For the year ended December 31, 2021 and the period ended November 15, 2022, the Company made no contributions to the Plan.

Plan benefits - The amount of a participant’s normal retirement benefit is based on a percentage of average monthly compensation, depending on the participant’s Employee Classification as reflected in the table below, multiplied by their years of credited service.

Note 1 - Description of plan (continued):

Plan benefits (continued) - A participant's monthly retirement benefit is offset by the monthly benefit provided by a portion of their account balance in the Stellar Solutions, Inc. Profit Sharing Plan; specifically, the portion of their account balance attributable to the first 10 percent of nonelective contributions each year starting from 2017, plus associated earnings. This offset is converted to a single life annuity at the later of age 65 or the fifth anniversary of participation in the Plan using the actuarial assumptions of the Plan. The Plan has provisions for termination and death benefits. Participants may elect to receive their pension benefits through various forms of joint and survivor annuities, a single life annuity, or a single lump-sum payment, if applicable. A participant may not receive Plan benefits for over 25 years.

Vesting - Participants are immediately vested in their portion of benefits under the Plan.

Forfeited accounts - Contributions are immediately vested and are therefore non-forfeitable.

Notes receivable from participants - Participants may borrow from their vested account balance a minimum of \$1,000 only under the circumstances where an immediate and heavy financial need is demonstrated. The maximum amount is 50% of their vested account balance, up to \$50,000. Loan terms range from 1-5 years, but may not exceed 5 years, except for loans used for a purchase of a primary residence, which may be repaid over a longer period but not to exceed 30 years. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with the local prevailing rates plus 1%, as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Participants may not have more than three outstanding loans at a time.

Administrative expenses - Substantially all administrative expenses of the Plan are paid by the Plan sponsor. Separate fees for recordkeeping fees as specified in the service agreement, are charged against Plan balances.

Note 2 - Significant accounting policies:

Basis of accounting - The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with GAAP. Contributions from participants are recorded when withheld from the participant. Benefit payments to participants are recorded when paid. For the period from January 1, 2022 through November 15, 2022, in accordance with GAAP, the Plan financial statements were prepared using the liquidation basis of accounting due to the termination of the Plan as described in Note 1.

Use of estimates - The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and schedule. Actual results could differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net realized and unrealized appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Actuarial present value of accumulated plan benefits - Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributed under the Plan's provisions to the service that participants have rendered. Accumulated plan benefits include benefits expected to be paid to: (a) retired or terminated participants or their beneficiaries, (b) beneficiaries of participants who have died, and (c) present participants or their beneficiaries.

Benefits under the Plan are based on the three highest consecutive years of compensation during the last ten calendar years of employment with the Company and the number of years of eligibility. The actuarial present value of accumulated plan benefits is determined by the Company's actuaries and results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuations as of December 31, 2021 and December 31, 2020, the date of the most recent actuarial information available for each of the Plan's year-ends, were: (a) life expectancy of participants, (b) an average retirement age, (c) an average investment return, (d) timing of benefit payments assumed, and (e) funding target equal to the present value of accrued benefits.

The significant actuarial assumptions used in determining accumulated plan benefits as of December 31, 2021, are as follow:

- Interest Rate – 5.00%
- Mortality – IRC 430(h)(3)(A)

Actuarial present value of accumulated plan benefits (continued) - There were no significant changes to actuarial assumptions for the year ended December 31, 2022.

These actuarial assumptions are based on the presumption that the Plan will continue. Should the Plan be terminated, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

The computations of the actuarial present value of accumulated plan benefits for the 2022 Plan period were made as of December 31, 2021, the beginning of the Plan period. Had the valuation been performed as of November 15, 2022 for the 2022 Plan period there would be no material differences.

Funding policy - The Company's funding policy is to contribute an amount sufficient to meet required Company contributions under ERISA. The funded status on the Company's contribution basis is measured by comparing the actuarial value of assets with the actuarial accrued liability. The actuarial value of assets is equal to the fair value of assets plus receivable contributions. The actuarial accrued liability is the funding target, under ERISA, on which the employer contribution limits are based. As the funded percentage for a plan approaches or exceeds 100%, Company contributions to the Plan may be reduced. Plan participants may not make contributions to the Plan, with the exception of direct rollovers or transfers, as set forth in the Plan document.

Fair value measurements - The Plan performs fair value measurements in accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*. Refer to Note 3 for the fair value measurement disclosures associated with the Plan's investments.

Net appreciation (depreciation) in fair value of investments - The earnings, expenses, realized gains or losses, and unrealized appreciation (depreciation) in registered investment companies and other investments are recorded in the accompanying financial statements as net appreciation (depreciation) in fair value of investments.

Subsequent events - The Plan has evaluated subsequent events through the date that the financial statements were made available to be issued which is the date of the independent auditors' report.

Note 3 - Fair value:

The Plan performs fair value measurement in accordance with ASC 820 which defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. The accounting guidance for fair value measurement requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard establishes a fair value hierarchy based on the level of independent, objective evidence surrounding the inputs used to measure fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The fair value hierarchy is as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 - Investments:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Vanguard, the custodian of the Plan, as complete and accurate, except for comparing such information to information included in the Plan's financial statements.

The following information included in the financial statements was provided by and certified by the Plan's custodian as complete and accurate:

- Investments as shown in the Statement of Net Assets as of November 15, 2022 and December 31, 2021.
- Net appreciation (depreciation) in fair value of investments, as shown in the Statement of Changes in Net Assets for the period ended November 15, 2022 and for the year ended December 31, 2021.

Note 5 - Party-in-interest transactions:

Vanguard is the custodian of the Plan and holds and manages investments. Transactions with Vanguard are party-in-interest transactions, as defined by ERISA. At December 31, 2021 all investments in the Plan were held with Vanguard. At November 31, 2022 there were no investment balances remaining in the Plan.

Note 6 - Plan termination:

The Company has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in the present value of their accrued benefits, and benefits will be distributed in the following order:

- The vested benefits accrued at the date of the Plan termination. The amount is further limited to the lowest benefit that would be payable under the Plan provisions.
- All other vested benefits insured by the Pension Benefit Guaranty Corporation ("PBGC"), up to specified limitations. The PBGC is a government agency established under ERISA.
- All other vested retirement benefits under the Plan not insured by the PBGC.
- All nonvested benefits.

Note 6 - Plan termination (continued):

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivors' pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed to the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees. For plan terminations occurring during the period ended November 15, 2022, the ceiling was \$6,205 per month. The ceilings apply to those pensioners who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or plan termination (whichever comes later). For younger annuitants or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted downward. Whether all participants receive their benefits should the plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Company and the level of benefits guaranteed by the PBGC.

As described in Note 1, the Plan was approved to be terminated in February 2022 and all assets were transferred out of the Plan upon termination on November 15, 2022 in accordance with the above requirements.

Note 7 - Income tax status:

The prototype plan adopted by the Company obtained its latest opinion letter on March 30, 2018, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Note 8 - Risks and uncertainties:

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets and accumulated plan benefits.
